AN ACT to amend chapter 192 of the laws of 2011, relating to authorizing certain health care professionals licensed to practice in other jurisdictions to practice in this state in connection with an event sanctioned by New York Road Runners, in relation to extending the provisions thereof

THE PEOPLE OF THE STATE OF NEW YORK, REPRESENTED IN SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

1 Section 1. Sections 1 and 2 of chapter 192 of the laws of 2011, relat-2 ing to authorizing certain health care professionals licensed to prac-3 tice in other jurisdictions to practice in this state in connection with 4 an event sanctioned by New York Road Runners, as amended by chapter 33 5 of the laws of 2012, are amended to read as follows:

6 Section 1. Notwithstanding any inconsistent provision of law, any 7 person who is licensed to practice as a physician, physician's assist-8 ant, massage therapist, physical therapist, chiropractor, dentist, opto-9 metrist, nurse, nurse practitioner, certified athletic trainer or podiatrist in another state or territory, who is in good standing in such 10 state or territory and who has been appointed by the New York Road 11 Runners to provide professional services at an event in this state sanc-12 13 tioned by the New York Road Runners, may provide such professional 14 services to athletes and team personnel registered to train at a 15 location in this state or registered to compete in an event conducted 16 under the sanction of the New York Road Runners in the state without first being licensed pursuant to the provisions of title 8 of the educa-17 tion law. Such services shall be provided only four days before through 18 one day after each of the following events: 19

20 a. the Queens half marathon scheduled to be held on

- 21 July 1, 2012;
- 22 b. the Bronx half marathon scheduled to be held on
