AN ACT to amend the general municipal law and the tax law, in relation to creating the Eastchester creek intermunicipal economic revitalization agency; and to repeal certain provisions of the general municipal law relating thereto

THE PEOPLE OF THE STATE OF NEW YORK, REPRESENTED IN SENATE AND ASSEM-BLY, DO ENACT AS FOLLOWS:

Section 1. Title 119 of article 15-B of the general municipal law is 1 REPEALED and a new title 119 is added to read as follows: 2 3 TITLE 119 4 EASTCHESTER CREEK INTERMUNICIPAL ECONOMIC REVITALIZATION AGENCY 5 6 SECTION 680-F. (A) FOR THE BENEFIT OF THE CITY OF MOUNT VERNON AND THE VILLAGE 10 OF PELHAM MANOR AND THE INHABITANTS THEREOF, A COMMUNITY DEVELOPMENT KNOWN AS THE EASTCHESTER CREEK INTERMUNICIPAL ECONOMIC 11 AGENCY, ТΟ ΒE 12 REVITALIZATION AGENCY, IS HEREBY ESTABLISHED FOR THE ACCOMPLISHMENT OF ANY OR ALL OF THE PURPOSES SPECIFIED IN ARTICLES FIFTEEN AND FIFTEEN-A 13 OF THIS CHAPTER. IT SHALL CONSTITUTE A BODY CORPORATE AND POLITIC, 14 AND 15 BE PERPETUAL IN DURATION. IT SHALL HAVE THE POWERS AND DUTIES NOW OR HEREAFTER CONFERRED BY ARTICLES FIFTEEN AND FIFTEEN-A OF THIS 16 CHAPTER 17 UPON COMMUNITY DEVELOPMENT AGENCIES AND PROVIDED THAT THE EXERCISE OF THE POWERS BY SUCH AGENCY WITH RESPECT TO THE ACOUISITION OF REAL 18 PROP-ERTY WHETHER BY PURCHASE, CONDEMNATION OR OTHERWISE, SHALL BE LIMITED TO 19 20 AREA DEFINED AS THE EASTCHESTER CREEK INTERMUNICIPAL ECONOMIC REVI-THE 21 TALIZATION AREA AND SUCH AGENCY SHALL TAKE INTO CONSIDERATION THE LOCAL 22 ZONING AND PLANNING REGULATIONS AS WELL AS THE REGIONAL AND LOCAL 23 COMPREHENSIVE LAND USE PLANS IN ANY ACTIONS THEY TAKE. ORGANIZED IN A MANNER PRESCRIBED BY AND BE SUBJECT TO THE PROVISIONS OF 1 ARTICLES FIFTEEN AND FIFTEEN-A OF THIS CHAPTER.
