AN ACT to amend the vehicle and traffic law, in relation to notice of parking violation

THE PEOPLE OF THE STATE OF NEW YORK, REPRESENTED IN SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

1 Section 1. Subdivision 2 of section 238 of the vehicle and traffic 2 law, as amended by chapter 224 of the laws of 1995, is amended to read 3 as follows:

4 2. A notice of violation shall be served personally upon the operator of a motor vehicle who is present at the time of service, and his name, 5 6 together with the plate designation and the plate type as shown by the 7 registration plates of said vehicle and the expiration date; the make or 8 model, and body type of said vehicle; a description of the charged violation, including but not limited to a reference to the applicable 9 10 traffic rule or provision of this chapter; information as to the days and hours the applicable rule or provision of this chapter is in effect, 11 unless always in effect pursuant to rule or this chapter and where 12 appropriate the word ALL when the days and/or hours in effect are every-13 14 and/or twenty-four hours a day; the meter number for a meter day 15 violation, where appropriate; and the date, time and particular place of occurrence of the charged violation, shall be inserted therein. A mere 16 17 listing of a meter number in cases of charged meter violations shall not deemed to constitute a sufficient description of a particular place 18 be of occurrence for purposes of this subdivision. The notice of violation 19 shall be served upon the owner of the motor vehicle if the operator is 20 21 not present, by affixing such notice to said vehicle in a conspicuous 22 place. Whenever such notice is so affixed, in lieu of inserting the name 23 the person charged with the violation in the space provided for the of 24 identification of said person, the words "owner of the vehicle bearing

license" may be inserted to be followed by the plate designation and 1 plate type as shown by the registration plates of said vehicle together 2 3 with the expiration date; the make or model, and body type of said vehi-4 cle; a description of the charged violation, including but not limited to a reference to the applicable traffic rule or provision of this chap-5 6 ter; information as to the days and hours the applicable rule or 7 provision of this chapter is in effect unless always in effect pursuant to rule or this chapter and where appropriate the word ALL when the days 8 and/or hours in effect are every day and/or twenty-four hours a day; the 9 10 meter number for a meter violation where appropriate; and the date, time and particular place of occurrence of the charged violation. 11 Service of 12 the notice of violation, or a duplicate thereof by affixation as [here-13 provided IN THIS SECTION shall have the same force and effect and inl 14 shall be subject to the same penalties for disregard thereof as though 15 the same was personally served with the name of the person charged with the violation inserted therein. WHERE AN OPERATOR OF A MOTOR VEHICLE 16 17 ACCEPT PERSONAL SERVICE OF THE NOTICE OF VIOLATION, NOTICE REFUSES ТО SHALL BE SERVED ON THE OWNER BY CERTIFIED MAIL TO THE LAST KNOWN REGIS-18 19 TERED ADDRESS. IF NOTICE IS SERVED BY CERTIFIED MAIL, THE NOTICE OF VIOLATION SHALL STATE THAT THE OPERATOR WAS PRESENT AND REFUSED PERSONAL 20 21 SERVICE. 22 S 2. This act shall take effect immediately.
