AN ACT authorizing the leasing of certain parkland for development of a parking facility with roof top park occupying the same parkland footprint such that there is no net parkland loss associated with this facility, and for the construction of associated roadways, a pedestrian foot bridge, a loading dock and other new park amenities, required to support new development of an exhibition hall, cultural space, a wellness center, hotel, restaurants, and a community programming not for profit uniquely located on the Hudson River in a historic former power plant, which site is currently an abandoned brownfield site known as the Glenwood Power Plant, uniquely located on the Hudson River adjacent to John F. Kennedy Marina and Trevor Park in the City of Yonkers, which site lacks any land for parking, and which project was contemplated in the approved May 2009 City of Yonkers Alexander Street Master Plan with a new road network connecting Alexander Street to the south past the Glenwood Power Plant through John F. Kennedy Marina and Trevor Park north to provide increased public access to the Hudson River and enhance said parks through the development of a new sustainable riverfront, transit-oriented project by enhancing the existing parks with new amenities

THE PEOPLE OF THE STATE OF NEW YORK, REPRESENTED IN SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

1     Section 1. Legislative findings. It is hereby found and declared that  
2 the development, financing, and long term lease of a new parking facili-  
3 ty, a pedestrian bridge and access to associated roadways on underuti-  
4 lized parkland which shall be replaced in kind with a roof top park, and

1 additional parkland amenities, and sale of acreage required for a load-  
2 ing dock and arrival court, which shall simultaneously benefit develop-  
3 ment of an exhibition hall, cultural space, a wellness center, hotel,  
4 restaurants, and a community programming not for profit uniquely located  
5 on the Hudson River in a historic former power plant, which site is  
6 currently an abandoned brownfield site known as the Glenwood Power  
7 Plant, uniquely located on the Hudson River adjacent to John F. Kennedy  
8 Marina and Trevor Park in the city of Yonkers and shall also benefit the  
9 general public by providing enhanced park recreational use amenities and  
10 activities, including entertainment, amusement, education, enlight-  
11 enment, cultural development and betterment and improvement of trade and  
12 commerce, cultural and entertainment events, tourism, meetings and  
13 assemblages, and other events of a civic, community and general public  
14 interest. It is further found and declared that the development, financ-  
15 ing, and long term lease of such parking facility and access to associ-  
16 ated roadways in exchange for creation of a new replacement in kind park  
17 occupying the same footprint as the parking facility and additional  
18 parkland enhancements not currently present in the park as well as dedi-  
19 cation of additional acreage in the city of Yonkers to offset the park-  
20 land impact are for the benefit of the people of the state of New York  
21 and abroad and for the improvement of their health, welfare, recreation-  
22 al activities and prosperity, and for the improvement of trade and  
23 commerce and are hereby declared to be public purposes. It is further  
24 found and declared that the development, financing, and long term lease  
25 of such parking facilities and associated roadways, and other improve-  
26 ments, which would benefit the development of an exhibition hall,  
27 cultural space, a wellness center, hotel, restaurants, and a community  
28 programming non for profit uniquely located on the Hudson River in a  
29 historic former power plant, which site is currently an abandoned brown-  
30 field site known as the Glenwood Power Plant, uniquely located on the  
31 Hudson River and simultaneously enhance and improve John F. Kennedy  
32 Marina and Trevor Park, are park purposes permitted on lands dedicated  
33 as parklands in the city of Yonkers. It is further found and declared  
34 that development, financing, and lease of the parking facility and  
35 pedestrian bridge and access to associated roadways to serve the needs  
36 of the patrons of the new development and the general public to be able  
37 to better access the Hudson River waterfront, will serve the public  
38 convenience and welfare and constitute a public purpose and enhance the  
39 use of the adjacent Glenwood Metro-North train station. It is further  
40 found and declared that the sale of a one and a half acre portion of  
41 John F. Kennedy Marina for a loading dock and arrival court immediately  
42 adjacent to the power plant building, will facilitate the redevelopment  
43 of the abandoned brownfield Glenwood Power Plant site.

44 S 2. a. Notwithstanding any other provision of law, general, special  
45 or local to the contrary, the city of Yonkers, acting through the mayor  
46 or his or her designee, is hereby authorized and empowered to enter into  
47 one or more contracts, leases or rental agreements with Glenwood POH LLC  
48 and/or a subsidiary thereof, or another entity or entities, for a term  
49 not to exceed ninety-nine years, and to grant easements, licenses,  
50 permits, concessions and other authorizations, with respect to certain  
51 land of the city of Yonkers, including parkland in the city of Yonkers,  
52 more particularly described in subdivision b of this section, for the  
53 purpose of developing, constructing, and leasing the parking facility,  
54 pedestrian bridge, and having access through and to associated roadways,  
55 and sale of the parkland associated with the loading dock and arrival  
56 court to serve the proposed redevelopment of the Glenwood Power Plant,

on such terms and conditions including the duration of the term of the lease, and the consideration therefor, and to enter into or grant such further agreements, easements, licenses, concessions and other authorizations as the city of Yonkers and such person or persons or entity or entities may agree in order to carry out the purposes of this act.

16 5. S 04°02'40" W a distance of 38.06' to a point. Thence;  
17 6. S 32°58'32" W a distance of 63.42' to a point. Thence;  
18 7. S 12°13'48" W a distance of 248.54' to a point. Thence;  
19 8. On a curve turning to the left with an arc length of 14.24', with a  
20 radius of 32.00', with a chord bearing of S 66°45'37" E, with a chord  
21 length of 14.13' to a point. Thence;  
22 9. On a reverse curve turning to the right with an arc length of  
23 143.20', with a radius of 157.00', with a chord bearing of S 53°22'59"  
24 E, with a chord length of 138.29' to a point at the Northerly bounds of  
25 the now or formerly American Sugar. Thence;  
26 Along the bounds of the now or formerly American Sugar N 87°02'24" W a  
27 distance of 57.60' to the Mean High Water Level. Thence;  
28 Along Mean High Water Level 594± to a point. Thence:  
29 S 78°40'50" E a distance of 145.69' to a point. Thence:  
30 N 12°40'23" E a distance of 187.20' to a point which is the point of  
31 beginning,  
32 Having an area of 40691.34 square feet, 0.934 acres.  
33 S 4. The discontinuance of parkland authorized by this act shall not  
34 occur until the city of Yonkers has complied with the State Environ-  
35 mental Quality Review act, as set forth in article 8 of the environ-  
36 mental conservation law.  
37 S 5. Should the leased lands described in section two of this act ever  
38 cease to be used for the purposes described in section two of this act,  
39 the lease shall terminate and those lands and improvements thereto shall  
40 revert to the city of Yonkers for exclusive park and recreational  
41 purposes.  
42 S 6. This act shall take effect immediately.
