AN ACT to amend the tax law and the real property tax law, in relation to denying tax-exempt status to any organization that discriminates against any person, group, organization or other entity based on sexual orientation or gender identity or expression

THE PEOPLE OF THE STATE OF NEW YORK, REPRESENTED IN SENATE AND ASSEM-BLY, DO ENACT AS FOLLOWS:

- 1 Section 1. The tax law is amended by adding a new section 39 to read 2 as follows:
- S 39. LOSS OF TAX-EXEMPT STATUS. NOTWITHSTANDING ANY PROVISION OF LAW
 - TO THE CONTRARY, ANY ORGANIZATION THAT DISCRIMINATES AGAINST ANY PERSON,
- 5 YOUTH GROUP, ORGANIZATION OR OTHER ENTITY BASED ON RACE, WEIGHT, NATIONAL ORIGIN, CREED, RELIGION, RELIGIOUS PRACTICES, MENTAL OR PHYS-

- EXPRESSION SHALL NOT BE ELIGIBLE FOR TAX-EXEMPT STATUS FOR 8 THE 9
- TAXES, FEES, FINES, PENALTIES, INTEREST OR OTHER ASSESSMENTS 10 IMPOSED PURSUANT TO THE PROVISIONS OF THIS CHAPTER; PROVIDED
- 11 PROVISIONS OF THIS SECTION SHALL NOT APPLY TO ANY VALIDLY INCORPORATED

- S 2. The real property tax law is amended by adding a new section 18 19 422-a to read as follows:
- 20 422-A. LOSS OF TAX-EXEMPT STATUS. NOTWITHSTANDING ANY PROVISION OF 21 LAW TO THE CONTRARY, ANY ORGANIZATION THAT DISCRIMINATES AGAINST
- 22 PERSON, GROUP, ORGANIZATION OR OTHER ENTITY BASED ON RACE, WEIGHT,

- 13 S 3. If any section of this act or any part thereof shall be adjudged 14 by any court of competent jurisdiction to be invalid, such judgement 15 shall not affect, impair or invalidate the remainder or any other 16 section or part thereof.
- 17 S 4. This act shall take effect immediately and shall apply to all tax 18 years commencing on and after January 1, 2014.
