THE PEOPLE OF THE STATE OF NEW YORK, REPRESENTED IN SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

1 Section 1. Clause (iii) of subparagraph 4 of paragraph h of subdivi-2 sion 2 of section 355 of the education law, as amended by chapter 260 of 3 the laws of 2011, is amended to read as follows:

4 (iii) The state shall appropriate annually and make available general 5 fund operating support, including fringe benefits, for the state univerб sity in an amount not less than the amount appropriated and made avail-7 able to the state university in state fiscal year two thousand eleven-two thousand twelve. Beginning in state fiscal year 8 two thousand 9 twelve-two thousand thirteen and thereafter, the state shall appropriate and make available general fund operating support, including fringe 10 benefits, for the state university AND THE 11 STATE UNIVERSITY HEALTH SCIENCE CENTERS in an amount not less than the amount appropriated and 12 made available in the prior state fiscal year; provided, however, that 13 if the governor declares a fiscal emergency, and communicates such emer-14 15 gency to the temporary president of the senate and speaker of the assemsupport for operating expenses at the state university and 16 bly, state
