30 SPIRITS AS A CONDITION OF SUCH LICENSE.

31 (C) NO PERSON SHALL BE DISQUALIFIED FROM ACTING AS A DIRECTOR, OFFICER
32 OR EMPLOYEE OF, OR PURVEYOR TO THE FWHC BY REASON OF SUCH PERSON HOLDING
33 A LICENSE PURSUANT TO THIS CHAPTER, OR BEING AFFILIATED WITH A LICENSEE
34 UNDER THIS CHAPTER AS A SHAREHOLDER, PARTNER, MEMBER, OFFICER, DIRECTOR
35 OR EMPLOYEE.

36 (D) NO PERSON SHALL BE DISQUALIFIED FROM BEING A LENDER, LESSEE OR
37 LESSOR TO THE FWHC ON TERMS AGREED WITH THE BOARD OF DIRECTORS OF THE
38 FWHC, BY REASON OF SUCH PERSON HOLDING A LICENSE PURSUANT TO THIS CHAP-
39 TER, OR BEING AFFILIATED WITH A LICENSEE UNDER THIS CHAPTER OR OTHER LAW
40 AS A SHAREHOLDER, PARTNER, MEMBER, OFFICER, DIRECTOR OR EMPLOYEE. SUCH
41 PERSONS SHALL BE ENTITLED, REGARDLESS OF THEIR LICENSING STATUS PURSUANT
42 TO THIS CHAPTER, TO OBTAIN ALL THE BENEFITS GENERALLY APPROVED BY THE
43 BOARD OF DIRECTORS OF THE FWHC.

44 (E) NOTWITHSTANDING ANY OTHER PROVISION OF LAW TO THE CONTRARY, UNDER
45 THE LICENSE GRANTED PURSUANT TO THIS SUBDIVISION, THE FWHC IS EXPRESSLY
46 AUTHORIZED TO:

47 (I) SELL NEW YORK STATE PRODUCED WINES, BEERS AND DISTILLED SPIRITS
48 FOR BOTH ON AND OFF PREMISES CONSUMPTION AS OTHERWISE PROVIDED IN THIS
49 SUBDIVISION;

50 (II) OFFER TASTINGS AT THE SITE OF SUCH PRODUCTS AND CHARGE THE GENER-
51 AL PUBLIC SUCH AMOUNTS AS IT DEEMS FIT FOR SUCH TASTINGS. FOR PURPOSES
52 OF THIS SUBDIVISION, TASTINGS MAY BE CONDUCTED IN A COMMON TASTING AREA
53 ON THE SITE; AND

54 (III) PROVIDE CONFERENCE CENTER, BANQUET AND ENTERTAINMENT FACILITIES
55 FOR THE GENERAL PUBLIC OR FOR PRIVATE PARTIES IN CONSIDERATION OF SUCH
56 FEES AS ARE ESTABLISHED BY THE BOARD OF DIRECTORS OF THE FWHC FROM TIME

1 TO TIME, AND TO SELL AND SERVE AT SUCH EVENTS WINES, BEERS AND DISTILLED
2 SPIRITS.

3 (F) NO LICENSE SHALL BE DENIED PURSUANT TO THIS SUBDIVISION OR ANY
4 OTHER PROVISION OF THIS CHAPTER BECAUSE OF THE PROXIMITY OF THE SITE TO
5 A SCHOOL, CHURCH, SYNAGOGUE, OTHER HOUSE OF WORSHIP OR OTHER FACILITY AS
6 PROVIDED FOR IN THIS CHAPTER.

7 (G) FOR PURPOSES OF SUBDIVISION FOUR OF SECTION ONE HUNDRED OF THIS
8 ARTICLE, THERE SHALL BE ALLOWED NOT MORE THAN FIVE ADDITIONAL BARS,
9 COUNTERS OR SIMILAR CONTRIVANCES AT THE SITE WHERE WINES, BEERS AND
10 DISTILLED SPIRITS ARE OFFERED FOR SALE FOR CONSUMPTION ON THE LICENSED
11 PREMISES. THE AUTHORITY FOR GOOD CAUSE SHOWN TO IT AND UPON PAYMENT TO
12 IT OF A FEE AS PROVIDED FOR IN SUCH SUBDIVISION FOUR SHALL PERMIT THE
13 ADDITIONAL CONTRIVANCES, AND PERMISSION SHALL NOT BE UNREASONABLY WITH-
14 HELD. ALL OTHER PROVISIONS OF SUCH SUBDIVISION SHALL APPLY TO SUCH
15 LICENSED PREMISES.

16 (H) IN ADDITION TO THE ACTIVITIES AUTHORIZED TO A LICENSEE UNDER
17 SUBDIVISION TWO-C OF SECTION SIXTY-ONE OF THIS CHAPTER, THE LICENSE
18 ISSUED TO A LICENSEE PURSUANT TO THIS SUBDIVISION AS DIRECTED AND
19 REQUIRED TO BE ISSUED SHALL BE AUTHORIZED TO SELL SPIRITS PRODUCED AT
20 SUCH FARM DISTILLERY ON THE SITE, WHETHER LOCATED ON PARCEL A, PARCEL B
21 OR PARCEL C. ANY RESTRICTION IN LAW AS TO THE AMOUNT PERMITTED TO BE
22 SOLD OR CONSUMED, OR ANY OTHER MATTER SUBJECT TO THE JURISDICTION OF
23 THIS CHAPTER SHALL APPLY TO SUCH SALES AS IF THE SALE OCCURRED UPON THE
24 FACILITY PRODUCING THE SAME.

25 S 2. This act shall take effect immediately.
