AN ACT to amend chapter 118 of the laws of 1969, relating to a separate union free school district in the town of Greenburgh, in the county of Westchester, in relation to clarifying the authority of the Greenburgh North Castle Union Free School District to lease certain properties and to expand its boundaries

THE PEOPLE OF THE STATE OF NEW YORK, REPRESENTED IN SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

1 Section 1. Section 2-a of chapter 118 of the laws of 1969, relating
2 to a separate union free school district in the town of Greenburgh in
3 the county of Westchester, as added by chapter 224 of the laws of 2010,
4 is amended to read as follows:
5 S 2-a. Notwithstanding any other law, rule, or regulation to the
6 contrary, in addition to the powers granted by section two of this act,
7 subject to the approval of the New York state education department, the
8 board of education shall be authorized to lease properties, AND EXPAND
9 THE BOUNDARIES OF THE SCHOOL DISTRICT FOR THE DURATION OF ANY LEASES TO
10 INCLUDE, PROPERTIES located at 108 Shonnard Place in the city of Yonk-
11 ers, county of Westchester, and TO LEASE PROPERTIES LOCATED at 1700 Old
12 Orchard Place in the village of Valhalla, county of Westchester for the
13 purpose of providing instruction to students enrolled in the school
14 district.
15 S 2. Section 2-a of chapter 118 of the laws of 1969, relating to a
16 separate union free school district in the town of Greenburgh, in the
17 county of Westchester, as added by chapter 226 of the laws of 2010, is
18 amended to read as follows:
19 S [2-a] 2-B. Notwithstanding any other law, rule, or regulation to
20 the contrary, in addition to the powers granted by section two of this
21 act, subject to the approval of the New York state education department,
22 the board of education shall be authorized to lease AND EXPAND BOUNDA-

1 RIES OF THE SCHOOL DISTRICT FOR THE DURATION OF ANY LEASES TO INCLUDE
2 properties located at 623 Blooming Grove Turnpike, in the town of New
3 Windsor, county of Orange, TO BE KNOWN AS THE KAPLAN CAREER ACADEMY, for
4 the purpose of providing instruction to students enrolled in the school
5 district.

6 S 3. Chapter 118 of the laws of 1969, relating to a separate union
7 free school district in the town of Greenburgh, in the county of West-
8 chester, is amended by adding a new section 2-c to read as follows:

9 S 2-C. NOTWITHSTANDING ANY OTHER PROVISION OF LAW, RULE OR REGULATION
10 TO THE CONTRARY, SUBJECT TO THE APPROVAL OF THE NEW YORK STATE EDUCATION
11 DEPARTMENT, THE BOARD OF EDUCATION SHALL BE AUTHORIZED TO LEASE AND
12 EXPAND THE BOUNDARIES OF THE SCHOOL DISTRICT FOR THE DURATION OF ANY
13 LEASE TO INCLUDE PROPERTIES LOCATED AT 45 EAST GAINSBORG AVENUE IN THE
14 VILLAGE OF WEST HARRISON, COUNTY OF WESTCHESTER, TO BE KNOWN AS THE
15 REACH ACADEMY, AND TO ENTER INTO ANY AGREEMENTS NECESSARY TO CARRY OUT
16 SUCH AUTHORITY, FOR THE PURPOSE OF PROVIDING INSTRUCTION TO STUDENTS
17 ENROLLED IN THE GREENBURGH NORTH CASTLE UNION FREE SCHOOL DISTRICT.

18 S 4. The actions of the board of education of the Greenburgh North
19 Castle union free school district in entering into a lease of properties
20 located at 45 East Gainsborg Avenue in the village of West Harrison,
21 county of Westchester, prior to the effective date of this act are here-
22 by ratified, validated and confirmed notwithstanding its location
23 outside of the school district boundaries.

24 S 5. This act shall take effect July 1, 2013, provided that in the
25 event it shall become a law after such date, this act shall take effect
26 immediately and shall be deemed to have been in full force and effect on
27 and after July 1, 2013.
