AN ACT to amend the public authorities law, in relation to authorizing the power authority of the state of New York and the Long Island power authority to participate in public-private transmission projects to improve the state's electric transmission grid

THE PEOPLE OF THE STATE OF NEW YORK, REPRESENTED IN SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

1 Section 1. Legislative findings and purpose. The legislature hereby
2 finds and determines that:
3 1. The state's vital electric transmission grid is aging, congested
4 and subject to outages caused by storms, obsolescence and the growing
5 demands for energy by the state's residents, and such problems and
6 conditions pose serious threats to the health, welfare, safety and
7 economic well-being of the people of the state of New York.
8 2. The condition and operation of the state's electric transmission
9 grid is a matter of state concern, and it is in the public interest to
10 provide for the means to repair, replace, reinforce, modernize and
11 expand the state's electric transmission grid to ensure the safe and
12 reliable provision of electric service to the state's residents now and
13 into the future.
14 3. A modernized electric transmission grid and energy highway will
15 also encourage investments in new energy-related infrastructure and
16 technologies, facilitate the development and integration into the power
17 grid of renewable energy resources, and stimulate and support economic
18 development in the state. Public-private transmission projects undertak-

1 en jointly by the owner of transmission facilities, systems and infras-
2 tructure, including the power authority of the state of New York and the
3 Long Island power authority, which provide for the ongoing planning,
4 construction, owning, operating, maintaining and expanding of electric
5 transmission facilities, systems and infrastructure can serve as an
6 effective means to address the aforementioned problems and concerns and
7 stimulate ongoing critical investment in the state's electric trans-
8 mission grid.

9 4. The purposes of this act can be achieved, while managing and miti-
10 gating potential liabilities, by authorizing the power authority of the
11 state of New York and the Long Island power authority to participate in
12 such public-private transmission projects through the formation of
13 subsidiary companies.

14 S 2. Section 1001 of the public authorities law is amended by adding a
15 new closing paragraph to read as follows:

16 IT IS FURTHER DECLARED THAT: (A) THERE SHOULD BE FULL COOPERATION AND
17 COORDINATION AMONG PRIVATE AND PUBLIC OWNERS AND OPERATORS OF ELECTRIC
18 TRANSMISSION FACILITIES, SYSTEMS AND INFRASTRUCTURE IN THE STATE,
19 INCLUDING THE AUTHORITY, FOR THE PURPOSE OF EXPEDITIOUSLY REPAIRING,
20 REPLACING, REINFORCING, MODERNIZING AND EXPANDING THE STATE'S ELECTRIC
21 TRANSMISSION GRID; (B) IT IS DESIRABLE THAT THE AUTHORITY, WHICH OWNS
22 AND OPERATES ELECTRIC TRANSMISSION ASSETS IN THE STATE, PARTICIPATE IN
23 PUBLIC-PRIVATE TRANSMISSION PROJECTS THAT ARE UNDERTAKEN BY A LIMITED
24 LIABILITY COMPANY OR OTHER APPROPRIATE ORGANIZATIONAL STRUCTURE, THROUGH
25 A SUBSIDIARY COMPANY FORMED BY THE AUTHORITY AS AUTHORIZED BY THIS
26 TITLE; AND (C) THE AUTHORITY SHOULD BE AUTHORIZED TO PARTICIPATE IN
27 PUBLIC-PRIVATE TRANSMISSION PROJECTS AND TRANSFER TRANSMISSION ASSETS OR
28 ANY INTEREST THEREIN IN CONNECTION WITH ITS PARTICIPATION IN SUCH A
29 LIMITED LIABILITY COMPANY OR OTHER APPROPRIATE ORGANIZATIONAL STRUCTURE
30 ON SUCH TERMS AND CONDITIONS AS THE AUTHORITY MAY NEGOTIATE.

31 S 3. Section 1005 of the public authorities law is amended by adding a
32 new subdivision 25 to read as follows:

33 25. A. FOR PURPOSES OF THIS SUBDIVISION, THE FOLLOWING TERMS SHALL
34 HAVE THE MEANINGS INDICATED:

35 (I) "SUBSIDIARY COMPANY" MEANS A SUBSIDIARY COMPANY FORMED,
36 WHOLLY-OWNED AND CONTROLLED BY THE AUTHORITY IN ACCORDANCE WITH AND
37 SUBJECT TO THE BUSINESS CORPORATION LAW, THE NOT-FOR-PROFIT CORPORATION
38 LAW, THE LIMITED LIABILITY COMPANY LAW OR THE TRANSPORTATION CORPO-
39 RATIONS LAW.

40 (II) "TRANSCO MASTER AGREEMENT" MEANS A WRITTEN AGREEMENT PROVIDING
41 FOR THE FORMATION AND OPERATION OF A LIMITED LIABILITY COMPANY OR OTHER
42 ORGANIZATIONAL STRUCTURE TO SERVE AS A TRANSCO COMPANY AND WHICH
43 PROVIDES FOR, AMONG OTHER THINGS, THE RIGHTS AND OBLIGATIONS OF MEMBERS
44 OF SUCH TRANSCO COMPANY.

45 (III) "TRANSCO ANCILLARY AGREEMENT" MEANS A WRITTEN AGREEMENT, OTHER
46 THAN A TRANSCO PROJECT AGREEMENT, BETWEEN THE AUTHORITY OR SUBSIDIARY
47 COMPANY AND THE TRANSCO COMPANY AND/OR MEMBERS OF A TRANSCO COMPANY,
48 MADE IN ACCORDANCE WITH THE TRANSCO MASTER AGREEMENT, FOR THE PURPOSE OF
49 IMPLEMENTING THE TRANSCO MASTER AGREEMENT.

50 (IV) "TRANSCO COMPANY" MEANS AN ENTITY FORMED IN ACCORDANCE WITH A
51 TRANSCO MASTER AGREEMENT PRIMARILY FOR THE PURPOSE OF ENGAGING IN THE
52 BUSINESS OF PLANNING, CONSTRUCTING, OWNING, OPERATING, MAINTAINING, AND
53 EXPANDING ELECTRIC TRANSMISSION FACILITIES, SYSTEMS AND INFRASTRUCTURE
54 SERVING THE PEOPLE OF THE STATE OF NEW YORK.

55 (V) "TRANSCO PROJECT" MEANS A PROJECT UNDERTAKEN BY THE TRANSCO COMPA-
56 NY IN ACCORDANCE WITH A TRANSCO MASTER AGREEMENT.

(VI) "TRANSCO PROJECT AGREEMENT" MEANS A WRITTEN AGREEMENT BETWEEN THE AUTHORITY OR SUBSIDIARY COMPANY AND THE TRANSCO COMPANY AND/OR MEMBERS OF A TRANSCO COMPANY, MADE IN ACCORDANCE WITH THE TRANSCO MASTER AGREEMENT, THAT RELATES TO A SPECIFIC TRANSCO PROJECT.

(VII) "TRANSMISSION ASSETS" MEANS: (1) ALL PHYSICAL ASSETS (INCLUDING BUT NOT LIMITED TO ELECTRICAL TRANSMISSION LINES, POLES, TOWERS AND SIMILAR STRUCTURES, CONDUITS, SUBSTATIONS, CONVERTER STATIONS, TRANSFORMERS, CONDUCTORS, INSULATORS, SWITCHING DEVICES, CONTROLS, BREAKERS, BUSES, STATIONS, RECTIFIERS, REGULATORS, EMERGENCY AND PROTECTIVE EQUIPMENT AND DEVICES, UTILITY INTERCONNECTIONS AND OTHER EQUIPMENT USED OR NECESSARY FOR THE CONTROL, DISPATCH, RECEIPT AND DELIVERY OF ENERGY BY SUCH FACILITIES) USED FOR THE PURPOSE OF TRANSMITTING OR DELIVERING DIRECT OR ALTERNATING CURRENT ELECTRIC ENERGY AT VOLTAGES PRIMARILY OF ONE HUNDRED KILOVOLTS OR HIGHER TO LOADS OR INTERCONNECTION POINTS; AND (2) ALL ASSOCIATED (A) TANGIBLE AND INTANGIBLE PROPERTY USED TO OPERATE, CONTROL, PROTECT AND MAINTAIN SUCH ASSETS, (B) REAL PROPERTY RIGHTS FOR LANDS AND RIGHTS-OF-WAY, SITES, AND PLACES IN WHICH SUCH ASSETS ARE SITUATED OR INSTALLED, AND (C) LEGAL AND REGULATORY RIGHTS, AUTHORIZATIONS, PERMITS, AND CONSENTS OF ANY NATURE TO OWN, OCCUPY, CONSTRUCT, USE, OPERATE AND MAINTAIN, AND RECEIVE OR DISPOSE OF REVENUES FROM SUCH ASSETS OR LANDS ON WHICH SUCH ASSETS ARE SITUATED, EXISTING, OWNED, LEASED, DESIGNED, USED AND OPERATED.

B. NOTWITHSTANDING THE PROVISIONS OF ANY OTHER LAW, THE AUTHORITY MAY (I) PARTICIPATE IN PUBLIC/PRIVATE PARTNERSHIPS TO PROVIDE FOR THE MEANS TO REPAIR, REPLACE, REINFORCE, MODERNIZE AND EXPAND THE STATE'S ELECTRIC TRANSMISSION GRID TO ENSURE THE SAFE AND RELIABLE PROVISION OF ELECTRIC SERVICE TO THE STATE'S RESIDENTS NOW AND INTO THE FUTURE, (II) FORM A SUBSIDIARY COMPANY FOR THE PURPOSE OF PARTICIPATING IN A TRANSCO COMPANY, (III) PARTICIPATE IN THE TRANSCO COMPANY BY CAUSING THE SUBSIDIARY COMPANY TO BECOME A PARTY TO A TRANSCO MASTER AGREEMENT AND EXERCISE THE RIGHTS AND PERFORM THE OBLIGATIONS OF A TRANSCO COMPANY MEMBER AS MAY BE PROVIDED FOR IN A TRANSCO MASTER AGREEMENT, AND (IV) EXERCISE THE OTHER POWERS AND DUTIES PROVIDED FOR BY THIS SUBDIVISION.

C. NOTWITHSTANDING THE PROVISIONS OF ANY OTHER LAW, IN ADDITION TO ANY OTHER POWERS AND DUTIES GRANTED TO IT UNDER THIS TITLE, THE AUTHORITY SHALL BE AUTHORIZED TO:

(I) EXERCISE ALL OF THE RIGHTS AND PRIVILEGES ASSOCIATED WITH ANY OWNERSHIP INTEREST IN OR ORGANIZER OF THE SUBSIDIARY COMPANY;

(II) ISSUE ITS BONDS, NOTES AND OTHER EVIDENCE OF INDEBTEDNESS TO FINANCE THE OPERATIONS OF THE SUBSIDIARY COMPANY, INCLUDING THE SUBSIDIARY COMPANY'S PARTICIPATION IN AND OBLIGATIONS UNDERTAKEN IN CONNECTION WITH A TRANSCO COMPANY;

(III) LEND, OR OTHERWISE TRANSFER MONIES TO THE SUBSIDIARY COMPANY, INCLUDING THE PROCEEDS OF THE AUTHORITY'S BONDS, NOTES, OTHER EVIDENCE OF INDEBTEDNESS AND OTHER AUTHORITY FUNDS;

(IV) RECEIVE MONIES FROM THE SUBSIDIARY COMPANY, INCLUDING MONIES THAT RESULT FROM THE OPERATION OF THE TRANSCO COMPANY;

(V) AS DEEMED FEASIBLE AND ADVISABLE BY THE TRUSTEES, TRANSFER TO THE SUBSIDIARY COMPANY TRANSMISSION ASSETS OR INTERESTS THEREIN THAT HAVE BEEN OR ARE EXPECTED TO BE USED IN PROJECTS UNDERTAKEN BY THE TRANSCO COMPANY FOR SUCH CONSIDERATION AND ON SUCH OTHER TERMS AND CONDITIONS AS THE AUTHORITY SHALL NEGOTIATE;

(VI) RECEIVE FROM THE SUBSIDIARY COMPANY OR THE TRANSCO COMPANY ANY PERSONAL OR REAL PROPERTY;

(VII) ENTER INTO GUARANTEE AGREEMENTS IN CONNECTION WITH THE SUBSIDIARY COMPANY'S PARTICIPATION IN THE TRANSCO COMPANY;

(VIII) ENTER INTO CONTRACTS AND OTHER FORMS OF AGREEMENT WITH THE TRANSCO COMPANY, THE SUBSIDIARY COMPANY AND OTHER MEMBERS OF THE TRANSCO COMPANY;

(IX) PLEDGE OR ASSIGN ALL OR ANY PORTION OF ANY INTEREST IN A TRANSCO COMPANY;

(X) TRANSFER AND RECEIVE ALL OR ANY PORTION OF ANY INTEREST IN A TRANSCO COMPANY;

(XI) SELL, PURCHASE, OR OTHERWISE TRANSFER ALL OR ANY PORTION OF ANY INTEREST IN A TRANSCO COMPANY ON SUCH TERMS AND CONDITIONS AS THE AUTHORITY DEEMS APPROPRIATE;

(XII) ASSIGN ONE OR MORE EMPLOYEES TO PROVIDE SERVICES TO A TRANSCO COMPANY FOR A SPECIFIED PERIOD OF TIME, PROVIDED THAT ANY SUCH EMPLOYEE SHALL CONTINUE TO BE AN EMPLOYEE OF THE AUTHORITY; AND

(XIII) DISSOLVE OR TERMINATE THE SUBSIDIARY COMPANY IN ACCORDANCE WITH APPLICABLE LAW.

D. NOTWITHSTANDING THE PROVISIONS OF ANY OTHER LAW, NO TRUSTEE, OFFICER OR EMPLOYEE OF THE STATE, OR OF ANY STATE AGENCY, PUBLIC AUTHORITY OR PUBLIC BENEFIT CORPORATION, SHALL BE DEEMED TO HAVE FORFEITED OR SHALL FORFEIT SUCH PERSON'S OFFICE OR EMPLOYMENT OR ANY BENEFITS ASSOCIATED THEREWITH BY REASON OF SUCH PERSON'S ACCEPTANCE OF MEMBERSHIP ON, OR SUCH PERSON BEING AN OFFICER, EMPLOYEE OR AGENT OF A SUBSIDIARY COMPANY, OR BY REASON OF SUCH PERSON'S PROVISION OF SERVICES TO A SUBSIDIARY COMPANY.

E. THE PROVISIONS OF SECTION TWENTY-EIGHT HUNDRED SEVENTY-NINE-A OF THIS CHAPTER SHALL BE APPLICABLE TO ANY TRANSCO MASTER AGREEMENT TO WHICH THE AUTHORITY OR SUBSIDIARY COMPANY IS A PARTY, BUT SHALL BE INAPPLICABLE TO ANY TRANSCO ANCILLARY AGREEMENT OR TRANSCO PROJECT AGREEMENT THAT OTHERWISE SATISFIES THE REQUIREMENTS OF PARAGRAPH (A) OR (B) OF SUBDIVISION ONE OF SUCH SECTION PROVIDED THAT (I) A FINAL OR SUBSTANTIALLY NEGOTIATED FORM OF SUCH TRANSCO ANCILLARY AGREEMENT OR TRANSCO PROJECT AGREEMENT, AS THE CASE MAY BE, IS ANNEXED TO A TRANSCO MASTER AGREEMENT THAT HAS BECOME VALID AND ENFORCEABLE IN ACCORDANCE WITH THE PROVISIONS OF SECTION TWENTY-EIGHT HUNDRED SEVENTY-NINE-A OF THIS CHAPTER, AND (II) IN THE CASE OF A TRANSCO PROJECT AGREEMENT, THE FINAL EXECUTED FORM OF SUCH TRANSCO PROJECT AGREEMENT IS LIMITED TO A TRANSCO PROJECT THAT WAS IDENTIFIED IN SUCH TRANSCO MASTER AGREEMENT.

F. THE PROVISIONS OF TITLE FIVE-A OF ARTICLE NINE OF THIS CHAPTER SHALL BE INAPPLICABLE TO ANY DISPOSAL OF PROPERTY BY THE AUTHORITY OR SUBSIDIARY COMPANY THAT (I) IS OTHERWISE AUTHORIZED BY THIS TITLE, OR (II) IS MADE IN ACCORDANCE WITH A TRANSCO MASTER AGREEMENT THAT HAS BECOME VALID AND ENFORCEABLE IN ACCORDANCE WITH THE PROVISIONS OF SECTION TWENTY-EIGHT HUNDRED SEVENTY-NINE-A OF THIS CHAPTER.

G. NO ACTS OR ACTIVITIES TAKEN OR PROPOSED TO BE TAKEN BY THE AUTHORITY OR A SUBSIDIARY COMPANY PURSUANT TO THE PROVISIONS OF THIS SUBDIVISION, INCLUDING THE EXECUTION OF A TRANSCO MASTER AGREEMENT, AND THE ISSUANCE OF BONDS, NOTES, OR OTHER OBLIGATIONS, SHALL BE DEEMED TO BE "ACTIONS" FOR THE PURPOSES OR WITHIN THE MEANING OF ARTICLE EIGHT OF THE ENVIRONMENTAL CONSERVATION LAW.

H. NOTWITHSTANDING THE PROVISIONS OF ANY OTHER LAW TO THE CONTRARY, THE AUTHORITY AND THE SUBSIDIARY COMPANY ONLY MAY PARTICIPATE IN A TRANSCO COMPANY THAT REPAIRS, REPLACES, REINFORCES, MODERNIZES AND EXPANDS TRANSMISSION ASSETS, AND, ANY TRANSCO COMPANY IS PROHIBITED FROM FINANCING OR CONSTRUCTING NEW ELECTRIC GENERATING FACILITIES.

S 4. Section 1020-a of the public authorities law, as added by chapter 517 of the laws of 1986, is amended by adding a new closing paragraph to read as follows:

1 THE LEGISLATURE FURTHER FINDS AND DECLARES THAT: (I) THERE SHOULD BE
2 FULL COOPERATION AND COORDINATION AMONG PRIVATE AND PUBLIC OWNERS AND
3 OPERATORS OF ELECTRIC TRANSMISSION FACILITIES, SYSTEMS AND INFRASTRUC-
4 TURE IN THE STATE, INCLUDING THE AUTHORITY, FOR THE PURPOSE OF EXPE-
5 DITIOUSLY REPAIRING, REPLACING, REINFORCING, MODERNIZING AND EXPANDING
6 THE STATE'S ELECTRIC TRANSMISSION GRID; (II) IT IS DESIRABLE THAT THE
7 AUTHORITY, WHICH OWNS AND OPERATES ELECTRIC TRANSMISSION ASSETS IN THE
8 STATE, PARTICIPATES IN PUBLIC-PRIVATE TRANSMISSION PROJECTS THAT ARE
9 UNDERTAKEN BY A LIMITED LIABILITY COMPANY OR OTHER APPROPRIATE ORGANIZA-
10 TIONAL STRUCTURE, THROUGH A SUBSIDIARY COMPANY FORMED BY THE AUTHORITY
11 AS AUTHORIZED BY THIS TITLE; AND (III) THE AUTHORITY SHOULD BE AUTHOR-
12 IZED TO PARTICIPATE IN PUBLIC-PRIVATE TRANSMISSION PROJECTS AND TRANSFER
13 TRANSMISSION ASSETS OR ANY INTEREST THEREIN IN CONNECTION WITH ITS
14 PARTICIPATION IN SUCH A LIMITED LIABILITY COMPANY OR OTHER APPROPRIATE
15 ORGANIZATIONAL STRUCTURE ON SUCH TERMS AND CONDITIONS AS THE AUTHORITY
16 MAY NEGOTIATE.

17 S 5. Subdivision 2 of section 1020-c of the public authorities law, as
18 added by chapter 517 of the laws of 1986, is amended to read as follows:

19 2. The area of operations of the authority shall be the service area,
20 PROVIDED THAT THE AUTHORITY OR SUBSIDIARY COMPANY MAY OWN AN INTEREST IN
21 TRANSMISSION ASSETS THAT ARE LOCATED IN WHOLE OR IN PART OUTSIDE THE
22 SERVICE AREA.

23 S 6. Section 1020-f of the public authorities law is amended by adding
24 a new subdivision (g-1) to read as follows:

25 (G-1) (I) FOR PURPOSES OF THIS SUBDIVISION, THE FOLLOWING TERMS HAVE
26 THE MEANINGS INDICATED:

27 1. "SUBSIDIARY COMPANY" MEANS A SUBSIDIARY COMPANY FORMED,
28 WHOLLY-OWNED AND CONTROLLED BY THE AUTHORITY IN ACCORDANCE WITH AND
29 SUBJECT TO THE BUSINESS CORPORATION LAW, THE NOT-FOR-PROFIT CORPORATION
30 LAW, THE LIMITED LIABILITY COMPANY LAW OR THE TRANSPORTATION CORPO-
31 RATIONS LAW.

32 2. "TRANSCO MASTER AGREEMENT" MEANS A WRITTEN AGREEMENT PROVIDING FOR
33 THE FORMATION AND OPERATION OF A LIMITED LIABILITY COMPANY OR OTHER
34 ORGANIZATIONAL STRUCTURE TO SERVE AS A TRANSCO COMPANY AND WHICH
35 PROVIDES FOR, AMONG OTHER THINGS, THE RIGHTS AND OBLIGATIONS OF MEMBERS
36 OF SUCH TRANSCO COMPANY.

37 3. "TRANSCO ANCILLARY AGREEMENT" MEANS A WRITTEN AGREEMENT, OTHER THAN
38 A TRANSCO PROJECT AGREEMENT, BETWEEN THE AUTHORITY OR SUBSIDIARY COMPANY
39 AND THE TRANSCO COMPANY AND/OR MEMBERS OF A TRANSCO COMPANY, MADE IN
40 ACCORDANCE WITH THE TRANSCO MASTER AGREEMENT, FOR THE PURPOSE OF IMPE-
41 MENTING THE TRANSCO MASTER AGREEMENT.

42 4. "TRANSCO COMPANY" MEANS AN ENTITY FORMED IN ACCORDANCE WITH A TRAN-
43 SCO MASTER AGREEMENT PRIMARILY FOR THE PURPOSE OF ENGAGING IN THE BUSI-
44 NESS OF PLANNING, CONSTRUCTING, OWNING, OPERATING, MAINTAINING, AND
45 EXPANDING ELECTRIC TRANSMISSION FACILITIES, SYSTEMS AND INFRASTRUCTURE
46 SERVING THE PEOPLE OF THE STATE OF NEW YORK.

47 5. "TRANSCO PROJECT" MEANS A PROJECT UNDERTAKEN BY THE TRANSCO COMPANY
48 IN ACCORDANCE WITH A TRANSCO MASTER AGREEMENT.

49 6. "TRANSCO PROJECT AGREEMENT" MEANS A WRITTEN AGREEMENT BETWEEN THE
50 AUTHORITY OR SUBSIDIARY COMPANY AND THE TRANSCO COMPANY AND/OR MEMBERS
51 OF A TRANSCO COMPANY, MADE IN ACCORDANCE WITH THE TRANSCO MASTER AGREE-
52 MENT, THAT RELATES TO A SPECIFIC TRANSCO PROJECT.

53 7. "TRANSMISSION ASSETS" MEANS: (A) ALL PHYSICAL ASSETS (INCLUDING BUT
54 NOT LIMITED TO ELECTRICAL TRANSMISSION LINES, POLES, TOWERS AND SIMILAR
55 STRUCTURES, CONDUITS, SUBSTATIONS, CONVERTER STATIONS, TRANSFORMERS,
56 CONDUCTORS, INSULATORS, SWITCHING DEVICES, CONTROLS, BREAKERS, BUSES,

1 STATIONS, RECTIFIERS, REGULATORS, EMERGENCY AND PROTECTIVE EQUIPMENT AND
2 DEVICES, UTILITY INTERCONNECTIONS AND OTHER EQUIPMENT USED OR NECESSARY
3 FOR THE CONTROL, DISPATCH, RECEIPT AND DELIVERY OF ENERGY BY SUCH FACIL-
4 ITIES) USED FOR THE PURPOSE OF TRANSMITTING OR DELIVERING DIRECT OR

6 KILOVOLTS OR HIGHER TO LOADS OR INTERCONNECTION POINTS; AND (B) ALL
7 ASSOCIATED (I) TANGIBLE AND INTANGIBLE PROPERTY USED TO OPERATE,
8 CONTROL, PROTECT AND MAINTAIN SUCH ASSETS, (II) REAL PROPERTY RIGHTS FOR
9 LANDS AND RIGHTS-OF-WAY, SITES, AND PLACES IN WHICH SUCH ASSETS ARE
10 SITUATED OR INSTALLED, AND (III) LEGAL AND REGULATORY RIGHTS, AUTHORI-
11 ZATIONS, PERMITS, AND CONSENTS OF ANY NATURE TO OWN, OCCUPY, CONSTRUCT,
12 USE, OPERATE AND MAINTAIN, AND RECEIVE OR DISPOSE OF REVENUES FROM SUCH
13 ASSETS OR LANDS ON WHICH SUCH ASSETS ARE SITUATED, EXISTING, OWNED,
14 LEASED, DESIGNED, USED AND OPERATED.

15 (II) NOTWITHSTANDING THE PROVISIONS OF ANY OTHER LAW, INCLUDING THE
16 PROVISIONS OF SECTION ONE THOUSAND TWENTY-I OF THIS TITLE, THE AUTHORITY
17 MAY 1. FORM A SUBSIDIARY COMPANY FOR THE PURPOSE OF PARTICIPATING IN A
18 TRANSCO COMPANY, 2. PARTICIPATE IN THE TRANSCO COMPANY BY CAUSING THE
19 SUBSIDIARY COMPANY TO BECOME A PARTY TO A TRANSCO MASTER AGREEMENT AND
20 EXERCISE THE RIGHTS AND PERFORM THE OBLIGATIONS OF A TRANSCO COMPANY
21 MEMBER AS MAY BE PROVIDED FOR IN A TRANSCO MASTER AGREEMENT, AND 3.
22 EXERCISE THE OTHER POWERS AND DUTIES PROVIDED FOR BY THIS SUBDIVISION.

23 (III) NOTWITHSTANDING THE PROVISIONS OF ANY OTHER LAW, IN ADDITION TO
24 ANY OTHER POWERS AND DUTIES GRANTED TO IT UNDER THIS TITLE, THE AUTHORI-
25 TY SHALL BE AUTHORIZED TO:

26 1. PARTICIPATE IN PUBLIC/PRIVATE PARTNERSHIPS TO PROVIDE FOR THE
27 MEANS TO REPAIR, REPLACE, REINFORCE, MODERNIZE AND EXPAND THE STATE'S
28 ELECTRIC TRANSMISSION GRID TO ENSURE THE SAFE AND RELIABLE PROVISION OF
29 ELECTRIC SERVICE TO THE SERVICE AREA AND THE STATE'S RESIDENTS NOW AND
30 INTO THE FUTURE;

31 2. EXERCISE ALL OF THE RIGHTS AND PRIVILEGES ASSOCIATED WITH ANY
32 OWNERSHIP INTEREST IN OR ORGANIZER OF THE SUBSIDIARY COMPANY;

33 3. ISSUE ITS BONDS, NOTES AND OTHER EVIDENCE OF INDEBTEDNESS TO
34 FINANCE THE OPERATIONS OF THE SUBSIDIARY COMPANY, INCLUDING THE SUBSID-
35 IARY COMPANY'S PARTICIPATION IN AND OBLIGATIONS UNDERTAKEN IN CONNECTION
36 WITH A TRANSCO COMPANY;

37 4. LEND, OR OTHERWISE TRANSFER MONIES TO THE SUBSIDIARY COMPANY,
38 INCLUDING THE PROCEEDS OF THE AUTHORITY'S BONDS, NOTES, OTHER EVIDENCE
39 OF INDEBTEDNESS AND OTHER AUTHORITY FUNDS;

40 5. RECEIVE MONIES FROM THE SUBSIDIARY COMPANY, INCLUDING MONIES THAT
41 RESULT FROM THE OPERATION OF THE TRANSCO COMPANY;

42 6. AS DEEMED FEASIBLE AND ADVISABLE BY THE TRUSTEES, TRANSFER TO THE
43 SUBSIDIARY COMPANY TRANSMISSION ASSETS THAT HAVE BEEN OR ARE EXPECTED TO
44 BE USED IN PROJECTS UNDERTAKEN BY THE TRANSCO COMPANY FOR SUCH CONSIDER-
45 ATION AND ON SUCH OTHER TERMS AND CONDITIONS AS THE AUTHORITY SHALL
46 NEGOTIATE;

47 7. RECEIVE FROM THE SUBSIDIARY COMPANY OR THE TRANSCO COMPANY ANY
48 PERSONAL OR REAL PROPERTY;

49 8. ENTER INTO GUARANTEE AGREEMENTS IN CONNECTION WITH THE SUBSIDIARY
50 COMPANY'S PARTICIPATION IN THE TRANSCO COMPANY;

51 9. ENTER INTO CONTRACTS AND OTHER FORMS OF AGREEMENT WITH THE TRANSCO
52 COMPANY, THE SUBSIDIARY COMPANY AND OTHER MEMBERS OF THE TRANSCO COMPA-
53 NY;

54 10. PLEDGE OR ASSIGN ALL OR ANY PORTION OF ANY INTEREST IN A TRANSCO
55 COMPANY;

1 11. TRANSFER AND RECEIVE ALL OR ANY PORTION OF ANY INTEREST IN A TRAN-
2 SCO COMPANY;

3 12. SELL, PURCHASE, OR OTHERWISE TRANSFER ALL OR ANY PORTION OF ANY
4 INTEREST IN A TRANSCO COMPANY ON SUCH TERMS AND CONDITIONS AS THE
5 AUTHORITY DEEMS APPROPRIATE;

6 13. ASSIGN ONE OR MORE EMPLOYEES TO PROVIDE SERVICES TO A TRANSCO
7 COMPANY FOR A SPECIFIED PERIOD OF TIME, PROVIDED THAT ANY SUCH EMPLOYEE
8 SHALL CONTINUE TO BE AN EMPLOYEE OF THE AUTHORITY; AND

9 14. DISSOLVE OR TERMINATE THE SUBSIDIARY COMPANY IN ACCORDANCE WITH
10 APPLICABLE LAW.

11 (IV) NOTWITHSTANDING THE PROVISIONS OF ANY OTHER LAW, NO TRUSTEE,
12 OFFICER OR EMPLOYEE OF THE STATE, OR OF ANY STATE AGENCY, PUBLIC AUTHOR-
13 ITY OR PUBLIC BENEFIT CORPORATION, SHALL BE DEEMED TO HAVE FORFEITED OR
14 SHALL FORFEIT SUCH PERSON'S OFFICE OR EMPLOYMENT OR ANY BENEFITS ASSOCI-
15 ATED THEREWITH BY REASON OF SUCH PERSON'S ACCEPTANCE OF MEMBERSHIP ON,
16 OR SUCH PERSON BEING AN OFFICER, EMPLOYEE OR AGENT OF, A SUBSIDIARY
17 COMPANY, OR BY REASON OF SUCH PERSON'S PROVISION OF SERVICES TO A
18 SUBSIDIARY COMPANY.

19 (V) THE PROVISIONS OF SECTION ONE THOUSAND TWENTY-CC OF THIS TITLE
20 SHALL BE INAPPLICABLE TO ANY TRANSCO MASTER AGREEMENT, TRANSCO ANCILLARY
21 AGREEMENT AND TRANSCO PROJECT AGREEMENT.

22 (VI) THE PROVISIONS OF SECTION TWENTY-EIGHT HUNDRED SEVENTY-NINE-A OF
23 THIS CHAPTER SHALL BE APPLICABLE TO ANY TRANSCO MASTER AGREEMENT TO
24 WHICH THE AUTHORITY OR SUBSIDIARY COMPANY IS A PARTY, BUT SHALL BE INAP-
25 PPLICABLE TO ANY TRANSCO ANCILLARY AGREEMENT OR TRANSCO PROJECT AGREEMENT
26 THAT OTHERWISE SATISFIES THE REQUIREMENTS OF PARAGRAPH (A) OR (B) OF
27 SUBDIVISION ONE OF SUCH SECTION PROVIDED THAT 1. A FINAL OR SUBSTANTIAL-
28 LY NEGOTIATED FORM OF SUCH TRANSCO ANCILLARY AGREEMENT OR TRANSCO
29 PROJECT AGREEMENT, AS THE CASE MAY BE, IS ANNEXED TO A TRANSCO MASTER
30 AGREEMENT THAT HAS BECOME VALID AND ENFORCEABLE IN ACCORDANCE WITH THE
31 PROVISIONS OF SECTION TWENTY-EIGHT HUNDRED SEVENTY-NINE-A OF THIS CHAP-
32 TER, AND 2. IN THE CASE OF A TRANSCO PROJECT AGREEMENT, THE FINAL
33 EXECUTED FORM OF SUCH TRANSCO PROJECT AGREEMENT IS LIMITED TO A TRANSCO
34 PROJECT THAT WAS IDENTIFIED IN SUCH TRANSCO MASTER AGREEMENT.

35 (VII) THE PROVISIONS OF TITLE FIVE-A OF ARTICLE NINE OF THIS CHAPTER
36 SHALL BE INAPPLICABLE TO ANY DISPOSAL OF PROPERTY BY THE AUTHORITY OR
37 SUBSIDIARY COMPANY THAT 1. IS OTHERWISE AUTHORIZED BY THIS TITLE, OR 2.
38 IS MADE IN ACCORDANCE WITH A TRANSCO MASTER AGREEMENT THAT HAS BECOME
39 VALID AND ENFORCEABLE IN ACCORDANCE WITH THE PROVISIONS OF SECTION TWEN-
40 TY-EIGHT HUNDRED SEVENTY-NINE-A OF THIS CHAPTER.

41 (VIII) THE PROVISIONS OF PARAGRAPH (D) OF SUBDIVISION ONE OF SECTION
42 ONE THOUSAND TWENTY-S OF THIS TITLE AND SECTION THREE-B OF THE PUBLIC
43 SERVICE LAW SHALL BE INAPPLICABLE TO THE RATES, SERVICES AND PRACTICES
44 RELATED TO THE TRANSCO MASTER AGREEMENT AND ANY ACTIONS UNDERTAKEN BY
45 THE AUTHORITY OR SUBSIDIARY CORPORATION IN ACCORDANCE WITH THE TRANSCO
46 MASTER AGREEMENT.

47 (IX) NO ACTS OR ACTIVITIES TAKEN OR PROPOSED TO BE TAKEN BY THE
48 AUTHORITY OR A SUBSIDIARY COMPANY PURSUANT TO THE PROVISIONS OF THIS
49 SUBDIVISION, INCLUDING THE EXECUTION OF A TRANSCO MASTER AGREEMENT, AND
50 THE ISSUANCE OF BONDS, NOTES, OR OTHER OBLIGATIONS, SHALL BE DEEMED TO
51 BE "ACTIONS" FOR THE PURPOSES OR WITHIN THE MEANING OF ARTICLE EIGHT OF
52 THE ENVIRONMENTAL CONSERVATION LAW.

53 (X) NOTWITHSTANDING THE PROVISIONS OF ANY OTHER LAW TO THE CONTRARY,
54 THE AUTHORITY AND THE SUBSIDIARY COMPANY ONLY MAY PARTICIPATE IN A TRAN-
55 SCO COMPANY THAT REPAIRS, REPLACES, REINFORCES, MODERNIZES AND EXPANDS

1 TRANSMISSION ASSETS, AND, ANY TRANSCO COMPANY IS PROHIBITED FROM FINANC-
2 ING OR CONSTRUCTING NEW ELECTRIC GENERATING FACILITIES.
3 S 7. Severability clause. If any clause, sentence, paragraph, subdivi-
4 sion, section or part of this act shall be adjudged by any court of
5 competent jurisdiction to be invalid, such judgment shall not affect,
6 impair, or invalidate the remainder thereof, but shall be confined in
7 its operation to the clause, sentence, paragraph, subdivision, section
8 or part thereof directly involved in the controversy in which such judg-
9 ment shall have been rendered. It is hereby declared to be the intent of
10 the legislature that this act would have been enacted even if such
11 invalid provisions had not been included therewith.
12 S 8. This act shall take effect immediately.
