AN ACT to amend the education law, in relation to establishing a career and technical education diploma

THE PEOPLE OF THE STATE OF NEW YORK, REPRESENTED IN SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

- 1 Section 1. The education law is amended by adding a new section 817 to 2 read as follows:
- 3 S 817. CAREER AND TECHNICAL EDUCATION PATHWAY TO A HIGH SCHOOL DIPLO-4 MA. 1. A. A CAREER AND TECHNICAL EDUCATION (CTE) PATHWAY TO A HIGH 5 SCHOOL DIPLOMA IS HEREBY ESTABLISHED. A CTE PATHWAY TO A DIPLOMA SHALL:
 - (I) RESULT IN A REGENTS OR LOCAL DIPLOMA;
- 7 (II) DIFFER FROM THE TRADITIONAL REQUIREMENTS TO A REGENTS OR LOCAL 8 DIPLOMA WITH RESPECT TO REQUIRED ASSESSMENTS;
- 9 (III) BE MADE AVAILABLE TO ALL STUDENTS, INCLUDING, BUT NOT LIMITED TO STUDENTS WITH DISABILITIES AND ENGLISH LANGUAGE LEARNERS.
- B. A CTE PATHWAY TO A DIPLOMA SHALL BE BASED ON CURRICULUM DESIGNED TO PROVIDE STUDENTS WITH TECHNICAL SKILLS AND SHALL DEMONSTRATE THAT THE STUDENT IS READY FOR A CAREER AS DETERMINED BY REGULATIONS OF THE COMMISSIONER. A CTE PATHWAY TO A DIPLOMA SHALL INCLUDE, BUT NOT BE

- (I) COMPLETION OF A CTE SEQUENCE;
- 17 (II) COMPLETION OF A THREE-PART TECHNICAL ASSESSMENT;
- 18 (III) COMPLETION OF WORK-BASED LEARNING EXPERIENCES AS PROVIDED BY THE 19 APPROVED PROGRAM; AND,
 - (IV) COMPLETION OF A WORK-SKILLS EMPLOYABILITY PROFILE.

C. FOR PURPOSES OF THIS SECTION, A CAREER AND TECHNICAL EDUCATION SHALL INCLUDE, BUT NOT BE LIMITED TO, A COURSE OF STUDY IN THE FOLLOWING CAREER FIELDS: AGRICULTURE EDUCATION, BUSINESS AND MARKETING EDUCATION, FAMILY AND CONSUMER SCIENCES EDUCATION, HEALTH OCCUPATIONS EDUCATION, TECHNICAL EDUCATION, TECHNOLOGY EDUCATION, AND TRADE AND INDUSTRIAL EDUCATION.

- 2. THE BOARD OF REGENTS SHALL PROMULGATE SUCH REGULATIONS OF THE COMMISSIONER AS MAY BE NECESSARY TO ESTABLISH THE CURRICULUM, ASSESSMENTS AND ANY OTHER CRITERIA THAT STUDENTS MUST ACHIEVE TO EARN A REGENTS OR LOCAL DIPLOMA VIA A CTE PATHWAY.
- 3. STUDENTS WHO ENTERED HIGH SCHOOL IN THE TWO THOUSAND THIRTEEN--TWO THOUSAND FOURTEEN SCHOOL YEAR AND THEREAFTER SHALL BE ELIGIBLE TO EARN A DIPLOMA VIA A CTE PATHWAY.
- 14 S 2. This act shall take effect immediately; provided that effective 15 immediately, the addition, amendment and/or repeal of any rule or regu-16 lation necessary for the timely implementation of this act on its effec-17 tive date are authorized and directed to be made and completed on or 18 before such effective date.
