AN ACT to amend the public officers law, in relation to the qualifications for holding the office of assistant district attorney in the county of Essex

THE PEOPLE OF THE STATE OF NEW YORK, REPRESENTED IN SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

- 1 Section 1. Section 3 of the public officers law is amended by adding a 2 new subdivision 62 to read as follows:
- 62. IN THE COUNTY OF ESSEX, THE PROVISIONS OF THIS SECTION REQUIRING A PERSON TO BE A RESIDENT OF THE POLITICAL SUBDIVISION OR MUNICIPAL CORPO-5 RATION OF THE STATE FOR WHICH HE OR SHE SHALL BE CHOSEN OR WITHIN WHICH HIS OR HER OFFICIAL FUNCTIONS ARE REQUIRED TO BE EXERCISED, PREVENT A PERSON FROM HOLDING THE OFFICE OF ASSISTANT DISTRICT ATTORNEY 7 OF THE COUNTY OF ESSEX, PROVIDED THAT SUCH PERSON RESIDES IN ESSEX COUN-TY OR AN ADJOINING COUNTY WITHIN THE STATE OF NEW YORK; PROVIDED, HOWEV-9 ER, THAT ANY PERSON PERFORMING SUCH FUNCTIONS OR HOLDINGS THE OFFICE OF 10 ASSISTANT DISTRICT ATTORNEY IN OTHER COUNTY SHALL BE A RESIDENT OF SUCH 11 COUNTY UNLESS OTHERWISE PROVIDED BY LAW. THE PROVISIONS OF THIS SUBDIVI-12 SION SHALL NOT APPLY TO ANY PERSON HOLDING THE OFFICE OF FIRST ASSISTANT 13 DISTRICT ATTORNEY OR CHIEF ASSISTANT DISTRICT ATTORNEY, THE HOLDER OF 14
- 15 WHICH WOULD ASSUME THE DUTIES OF THE DISTRICT ATTORNEY UPON THE DISTRICT
- 16 ATTORNEY'S ABSENCE FROM THE COUNTY OR UPON THE DISTRICT ATTORNEY'S
- 17 INABILITY TO PERFORM HIS OR HER DUTIES.
- 18 S 2. This act shall take effect immediately.
