The closing paragraph of section 190.26 of the penal law, as amended by chapter 2 of the laws of 1998, is amended to read as follows: 11 12 Criminal impersonation in the first degree is a class [E] D felony. 13 The closing paragraph of section 190.78 of the penal law, as S 4. added by chapter 619 of the laws of 2002, is amended to read as follows: 14 Identity theft in the third degree is a class [A misdemeanor] E 15 16 FELONY. 17 S 5. The closing paragraph of section 190.79 of the penal law, as 18 added by chapter 619 of the laws of 2002, is amended to read as follows: 19 Identity theft in the second degree is a class [E] D felony. 20 S 6.
