AN ACT to amend the highway law, in relation to designating certain portions of the state highway system in the counties of Monroe and Tioga

THE PEOPLE OF THE STATE OF NEW YORK, REPRESENTED IN SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

1 Section 1. The highway law is amended by adding a new section 344-c to 2 read as follows:

- S 344-C. PORTION OF STATE HIGHWAYS SYSTEM IN THE COUNTIES OF MONROE AND TIOGA TO BE MEMORIALIZED. CERTAIN PORTIONS OF THE STATE HIGHWAY SYSTEM IN THE COUNTIES OF MONROE AND TIOGA ARE MEMORIALIZED AS FOLLOWS WITH SIGNAGE:
- 1. AT STATE ROUTE THREE HUNDRED EIGHTY-THREE AT 21 CALEDONIA AVENUE IN THE VILLAGE OF SCOTTSVILLE. COUNTY OF MONROE AND TIOGA THERE SHALL BE A MEMORIAL SIGN THAT READS "AT THIS SITE ON JANUARY 10, 1912 DEPUTY SIMON J. BERMINGHAM GAVE HIS LIFE IN SERVICE TO THE COMMUNITY";
- 2. AT STATE ROUTE SIXTY-FIVE, KNOWN AS CLOVER STREET, NEAR THE INTER-SECTION WITH HIGHLAND AVENUE, IN THE TOWN OF BRIGHTON, COUNTY OF MONROE THERE SHALL BE A MEMORIAL SIGN THAT READS "AT THIS SITE ON FEBRUARY 26, 1932 SPECIAL DEPUTY JOSEPH G. MUNZ GAVE HIS LIFE IN SERVICE TO THE COMMUNITY";
- 3. AT STATE ROUTE THREE HUNDRED EIGHTY-THREE NEAR THE SCOTTSVILLE VILLAGE LINE IN THE COUNTY OF MONROE THERE SHALL BE A MEMORIAL SIGN THAT READS "AT THIS SITE ON APRIL 3, 1946 DEPUTY WILLIAM MARSHALL GAVE HIS LIFE IN SERVICE TO THE COMMUNITY";
- 4. AT STATE ROUTE THREE HUNDRED EIGHTY-THREE AT THE BLACK CREEK HOTEL IN THE COUNTY OF MONROE THERE SHALL BE A MEMORIAL SIGN THAT READS "AT THIS SITE ON MARCH 25, 1947 DEPUTY JAMES I. CONHEADY GAVE HIS LIFE IN SERVICE TO THE COMMUNITY";
- 5. AT THE INTERSECTION OF STATE ROUTE THREE HUNDRED EIGHTY-THREE AND STATE ROUTE TWO HUNDRED FIFTY-TWO IN THE TOWN OF CHILI IN THE COUNTY OF MONROE THERE SHALL BE A MEMORIAL SIGN THAT READS "AT THIS SITE ON MAY

- 6. WESTBOUND ON STATE ROUTE SEVENTEEN IN THE TOWN OF OWEGO IN THE COUNTY OF TIOGA THERE SHALL BE A MEMORIAL SIGN THAT READS "AT THIS SITE ON SEPTEMBER 13, 1965 UNDERSHERIFF GEORGE A. CONWAY GAVE HIS LIFE IN SERVICE TO THE COMMUNITY";
 - 7. ON STATE ROUTE THREE HUNDRED EIGHTY-THREE NEAR NORTH ROAD NEAR THE VILLAGE OF SCOTTSVILLE TOWN LINE IN THE COUNTY OF MONROE THERE SHALL BE A MEMORIAL SIGN THAT READS "AT THIS SITE ON FEBRUARY 6, 1970 DEPUTY FRANK DOMBROWSKI GAVE HIS LIFE IN SERVICE TO THE COMMUNITY"; AND
- 8. ON STATE ROUTE SIXTY-FIVE SOUTHBOUND, SOUTH OF STATE ROUTE TWO HUNDRED FIFTY-TWO APPROXIMATELY TWO HUNDRED FEET NORTH OF THE ENTRANCE TO THE TOBEY VILLAGE OFFICE PARK IN THE COUNTY OF MONROE THERE SHALL BE A MEMORIAL SIGN THAT READS "AT THIS SITE ON JUNE 23, 1972 SERGEANT ROBERT M. SKELTON JR. GAVE HIS LIFE IN SERVICE TO THE COMMUNITY".
- 2. The commissioner of transportation shall provide for the instal-16 17 lation and maintenance of adequate signing of the state highway system as memorialized pursuant to section one of this act; provided that, to 18 19 avoid any confusion and to limit any possible disruption of commerce, the memorialization called for pursuant to section one of this act shall 20 21 be one of ceremonial nature and the official name of such place or highshall not be changed as a result of this act. Such memorialization 22 23 sign shall be the same size and color as a department of transportation 24 designation sign.
- 25 S 3. This act shall take effect immediately.
