- AN ACT to authorize John Leslie Bergmann to apply for and receive service credit, for service in the employment of a participating employer in the New York state and local employees' retirement system, in the New York city teachers' retirement system

THE PEOPLE OF THE STATE OF NEW YORK, REPRESENTED IN SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

Section 1. Notwithstanding any other provision of law to the contrary, 1 John Leslie Bergmann, who retired on July 1, 2002 from employment by the 2 3 city school district of the city of New York and receives benefits from 4 the New York city teachers' retirement system, and who commenced employ-5 ment by the Westchester county community college, a participating employer in the New York state and local employees' retirement system, 6 7 on September 6, 1988, and who, for reasons not ascribable to his own negligence, did not become a member of the New York state and local 8 9 employees' retirement system, shall be entitled to receive retirement service credit for his service as an employee of the Westchester county 10 11 community college, from the date of his commencement of such employment 12 until the date of his retirement from employment by the city school district of the city of New York, in the New York city teachers' retire-13 ment system if, on or before the thirty-first of December next succeed-14 15 ing the date on which it shall have become a law, he shall file an 16 application therefor with the state comptroller.

S 2. Notwithstanding any other provision of law to the contrary, ther-17 eupon, the New York state and local employees' retirement system shall 18 19 transfer to the New York city teachers' retirement system an amount, to be determined by the state comptroller, equal to that which the 20 Westchester county community college would have been obligated to pay to the 21 22 New York state and local employees' retirement system on account of its employment of John Leslie Bergmann, together with interest thereon, had 23 24 he become a member of such retirement system at the time of the commencement of his employment by Westchester county community college. 25

S 4. This act shall take effect immediately.

FISCAL NOTE .: Pursuant to Legislative Law, Section 50:

This bill will adjust the retirement benefit of John Leslie Bergmann, a retiree from the New York City Teachers Retirement System (NYCTRS), by increasing his final average salary by approximately \$16,000 based on earned while working for the Westchester County Community salary The additional benefit based on the increase in final average College. salary will then be paid retroactively to his date of retirement from the NYCTRS.

this bill is enacted, insofar as it affects the New York State and Ιf Local Employees' Retirement System, we anticipate that there will be a transfer of approximately \$9,800 to the NYCTRS. This cost will be shared the State of New York and all of the participating employers in the by New York State and Local Employees' Retirement System. In addition, we estimate that Mr. Bergmann will have to pay approximately \$12,000 in member contributions to the NYCTRS. The sum of these amounts will be used to partially offset the cost to the NYCTRS.
