AN ACT to amend the mental hygiene law, in relation to directing local government units providing services to individuals with mental illness or developmental disabilities to create a single point of access system

THE PEOPLE OF THE STATE OF NEW YORK, REPRESENTED IN SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

- 1 Section 1. Subdivision (a) of section 41.13 of the mental hygiene law 2 is amended by adding a new paragraph 17 to read as follows:
- CREATE, DIRECT AND EXERCISE SUPERVISORY AUTHORITY OVER A SINGLE OF SYSTEM FACILITATE ENTRY TO COORDINATION POINT ACCESS TO CARE SERVICES, SERVICES, RESIDENTIAL PLACEMENT, REHABILITATIVE AND OTHER 6 SERVICES FOR HIGH NEED ADULTS AND CHILDREN. THE SINGLE POINT OF **ACCESS** 7 OPERATED EITHER INDIVIDUALLY BY THE LOCAL GOVERNMENTAL  $_{
  m BE}$ 8 UNIT OR COLLECTIVELY IN COOPERATION WITH ONE OR MORE OTHER LOCAL GOVERN-9 MENTAL UNITS. SEPARATE SINGLE POINT OF ACCESS SYSTEMS MAY BE ESTABLISHED IN ORDER TO ADDRESS THE NEEDS OF A TARGETED POPULATION BASED ON CRITERIA 10 11 INCLUDING, BUT NOT LIMITED TO, AGE, DISABILITY, VETERAN STATUS SPECIFIC SERVICE NEED SUCH AS HOUSING OR CARE COORDINATION. SINGLE POINT 12 13 OF ACCESS SYSTEMS SHALL HAVE THE POWER TO:
- 14 (I) RECEIVE REFERRALS OF ALL PERSONS WITH A MENTAL DISABILITY AS 15 DEFINED IN SECTION 1.03 OF THIS CHAPTER WHO ARE IDENTIFIED AS A HIGH 16 NEED PERSON BY THE COMMISSIONER;
- 17 (II) RECEIVE REFERRALS REGARDLESS OF AGE, ABILITY TO PAY, OR HEALTH 18 INSURANCE STATUS;
- 19 (III) REQUIRE THE COOPERATION OF PROVIDERS OF CARE COORDINATION, HOUS-20 ING, HEALTH CARE, AND MANAGED CARE OPERATING WITHIN THE JURISDICTION OF 21 THE LOCAL GOVERNMENTAL UNIT TO DETERMINE THE APPROPRIATE LEVEL OF CARE 22 AND SERVICE DELIVERY FOR DESIGNATED HIGH NEED PERSONS.
- 23 S 2. This act shall take effect immediately.
