AN ACT to amend the public housing law, in relation to providing a unified funding point advantage for developers creating housing units that provide certain affordable housing

THE PEOPLE OF THE STATE OF NEW YORK, REPRESENTED IN SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

Section 1. The public housing law is amended by adding a new section 2 22-a to read as follows:

- S 22-A. UNIFIED FUNDING POINT ADVANTAGE. ANY DEVELOPER WHICH CREATES AN ELIGIBLE LOW-INCOME BUILDING PURSUANT TO SUBDIVISION FIVE OF SECTION TWENTY-ONE OF THIS ARTICLE WHICH IS INTENDED FOR AND DEDICATED TO MUNICIPAL WORKERS WHO CURRENTLY RESIDE IN SHELTERS OR HOMELESS PERSONS PROGRAMS, SHALL BE GRANTED A UNIFIED FUNDING POINT ADVANTAGE.
- 8 S 2. This act shall take effect immediately; provided, however, that 9 effective immediately, the addition, amendment and/or repeal of any rule 10 or regulation necessary for the implementation of this act on its effective date are authorized and directed to be made and completed on or 12 before such effective date.
