AN ACT authorizing the county of Nassau to alienate certain parcels of land used as parkland

THE PEOPLE OF THE STATE OF NEW YORK, REPRESENTED IN SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

1 Section 1. The county of Nassau is hereby authorized, acting by and
2 through its legislature, and upon such terms and conditions as determined by such legislature, to discontinue permanently as parkland the
3 lands described in section three of this act and to convey such parcel
4 to the Roslyn Water District.

5
6 S 2. The authorization contained in section one of this act shall be
7 effective only upon the condition that the county of Nassau dedicate an
8 amount equal to or greater than the fair market value of the parkland
9 being permanently discontinued for funding of capital improvements, to
10 existing park and recreational facilities.

11 S 3. The lands to be discontinued as parklands and alienated and
12 conveyed are described as follows:

13 All that certain piece or parcel of land situated at North Hills, Town
14 of North Hempstead, County of Nassau and State of New York, being known
15 as a portion of Lot 903 "Christopher Morley Park", Block E as it appears
16 on a certain map entitled "Department of Public Works Nassau County NY
17 Map Showing Real Property To Be Acquired For Park Purposes East of Sear-
18 ington Road And North Of Long Island Expressway North Hills Town Of
19 North Hempstead" filed with the Clerk of the County of Nassau on September 29, 1961 as Case No. 7496, said parcel being more particularly
20 described as follows:

22 Beginning at a point on the southerly side of Diana's Trail. Said
23 point being the following two courses from the intersection of the
24 southerly side of Diana's Trail with the westerly side of The Tulips:

25 1. South 89 degrees, 18 minutes, 51 seconds west, 237.50 feet.

26 2. South 87 degrees, 37 minutes, 30 seconds west, 437.00 feet to a
27 point or place of beginning.

1 Thence through lands the County of Nassau the following seven (7)
2 courses:
3 1. South 02 degrees, 22 minutes, 30 seconds east, 320.00 feet.
4 2. North 87 degrees, 37 minutes, 30 seconds east, 70.00 feet.
5 3. South 02 degrees, 22 minutes, 30 seconds east, 120.00 feet.
6 4. South 87 degrees, 37 minutes, 30 seconds west, 120.00 feet.
7 5. North 02 degrees, 22 minutes, 30 seconds west, 120.00 feet.
8 6. North 87 degrees, 37 minutes, 30 seconds east, 20.00 feet.
9 7. North 02 degrees, 22 minutes, 30 seconds west, 320.00 feet to the
10 southerly side of Diana's Trail.
11 Thence easterly along the southerly side of Diana's Trail North 87
12 degrees, 37 minutes, 30 seconds east, 30.00 feet to the point or place
13 of beginning.
14 Continuing within said bounds 24,000. S.F. or 0.44 Acres.
15 Nassau County Tax Map Section 7, Block E, Part of Lot 903.
16 S 4. The discontinuance and conveyance of parkland authorized by the
17 provisions of this act shall not occur until the county of Nassau has
18 complied with any federal requirements pertaining to the alienation or
19 conversion of parklands, including satisfying the secretary of the inte-
20 rior that the alienation or conversion complies with all conditions
21 which the secretary of the interior deems necessary to assure the
22 substitution of other lands shall be equivalent in fair market and
23 recreational usefulness to the lands being alienated or converted.
24 S 5. Should the lands described in this act cease to be used by the
25 Roslyn Water District for water treatment facilities those lands shall
26 revert to the county of Nassau to be used for park purposes.
27 S 6. This act shall take effect immediately.
