THE PEOPLE OF THE STATE OF NEW YORK, REPRESENTED IN SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

S 23.01 ASSISTED OUTPATIENT TREATMENT FOR SUBSTANCE ABUSE.

2 IS HEREBY ESTABLISHED THE ASSISTED OUTPATIENT TREATMENT FOR THERE 3 THIS PROGRAM SHALL SERVE INDIVIDUALS WITH SUBSTANCE ABUSE PROGRAM. 4 SUBSTANCE USE DISORDERS WHO, DUE TO OPIOID ABUSE, REQUIRE SERVICES TO 5 PREVENT THEM FROM CAUSING HARM TO THEMSELVES AND OTHERS. THE COMMISSION-6 ER, IN CONSULTATION WITH THE COMMISSIONER OF THE DEPARTMENT OF HEALTH 7 THE COMMISSIONER OF THE OFFICE OF MENTAL HEALTH, AND IN CONJUNCTION AND 8 WITH THE ASSISTED OUTPATIENT TREATMENT FOR SUBSTANCE ABUSE ADVISORY COUNCIL, SHALL PROMULGATE ALL RULES AND REGULATIONS NECESSARY TO IMPLE-9 10 MENT THE PROVISIONS OF THIS ARTICLE.

11 S 23.03 DEFINITIONS.

12 FOR THE PURPOSES OF THIS ARTICLE, THE FOLLOWING DEFINITIONS SHALL 13 APPLY:

14 (A) "ASSISTED OUTPATIENT TREATMENT FOR SUBSTANCE ABUSE" SHALL MEAN 15 CATEGORIES OF SERVICES THAT HAVE BEEN ORDERED BY THE COURT PURSUANT TO THIS ARTICLE. SUCH TREATMENT SHALL INCLUDE CASE MANAGEMENT SERVICES TO 16 17 PROVIDE CARE COORDINATION, AND MAY ALSO INCLUDE ANY OF THE FOLLOWING CATEGORIES OF SERVICES: SUBSTANCE USE DISORDER SERVICES, DETOXIFICATION 18 19 AS DEEMED APPROPRIATE PURSUANT TO A WRITTEN TREATMENT PLAN; MEDICATION SUPPORTED RECOVERY; INDIVIDUAL OR GROUP THERAPY; DAY OR PARTIAL DAY 20 21 PROGRAMMING ACTIVITIES; TESTS FOR THE PRESENCE OF ALCOHOL OR ILLEGAL 22 SUPERVISION OF LIVING ARRANGEMENTS; TREATMENT FOR CO-OCCURRING DRUGS; 23 DISORDERS; AND ANY OTHER SERVICES PRESCRIBED TO TREAT THE PERSON'S 24 SUBSTANCE USE DISORDER AND TO ASSIST THE PERSON IN LIVING AND FUNCTION-25 ING IN THE COMMUNITY, OR TO ATTEMPT TO PREVENT A RELAPSE OR DETERI-26 ORATION THAT MAY REASONABLY BE PREDICTED TO RESULT IN THE NEED FOR 27 HOSPITALIZATION OR SERIOUS HARM TO THE PERSON OR OTHERS.

(B) "ASSISTED OUTPATIENT TREATMENT FOR SUBSTANCE ABUSE PROGRAM" SHALL
MEAN A SYSTEM TO ARRANGE FOR, AND COORDINATE THE PROVISION OF, ASSISTED
OUTPATIENT TREATMENT FOR SUBSTANCE ABUSE; TO MONITOR TREATMENT COMPLIANCE BY ASSISTED OUTPATIENTS; TO TAKE APPROPRIATE STEPS TO ADDRESS THE
NEEDS OF SUCH INDIVIDUALS; AND TO ENSURE COMPLIANCE WITH COURT ORDERS.

33 (C) "ASSISTED OUTPATIENT" SHALL MEAN THE PERSON UNDER A COURT ORDER TO 34 RECEIVE ASSISTED OUTPATIENT TREATMENT FOR SUBSTANCE ABUSE DUE TO A 35 SUBSTANCE USE DISORDER.

36 (D) "OPIOID" SHALL MEAN AN OPIATE, OPIUM, OPIUM POPPY OR POPPY STRAW;
 37 AND ANY SALT, COMPOUND, DERIVATIVE, OR PREPARATION OF THEREOF THAT IS
 38 CHEMICALLY EQUIVALENT OR IDENTICAL TO SUCH SUBSTANCES.

39 (E) "SUBJECT OF THE PETITION" OR "SUBJECT" SHALL MEAN THE PERSON WHO 40 IS ALLEGED IN A PETITION, FILED PURSUANT TO THE PROVISIONS OF THIS ARTI-41 CLE, TO MEET THE CRITERIA FOR ASSISTED OUTPATIENT TREATMENT FOR 42 SUBSTANCE ABUSE.

43 (F) "SUBSTANCE USE DISORDER" SHALL MEAN THE MISUSE OF, DEPENDENCE ON, 44 OR ADDICTION TO A LEGAL OR ILLEGAL OPIOID LEADING TO EFFECTS THAT ARE 45 DETRIMENTAL TO THE INDIVIDUAL'S PHYSICAL AND MENTAL HEALTH, OR THE 46 WELFARE OF OTHERS.

47 S 23.05 CRITERIA FOR ASSISTED OUTPATIENT TREATMENT FOR SUBSTANCE ABUSE.

48 (A) A PERSON MAY BE ORDERED TO RECEIVE ASSISTED OUTPATIENT TREATMENT49 FOR SUBSTANCE ABUSE IF THE COURT FINDS THAT SUCH PERSON:

50 (1) IS EIGHTEEN YEARS OF AGE OR OLDER; AND

51 (2) IS SUFFERING FROM A SUBSTANCE USE DISORDER; AND

52 (3) IS UNLIKELY TO SURVIVE SAFELY IN THE COMMUNITY WITHOUT SUPER-53 VISION, BASED ON A CLINICAL DETERMINATION; AND

54 (4) HAS A HISTORY OF LACK OF COMPLIANCE WITH TREATMENT FOR A SUBSTANCE 55 USE DISORDER, AS EVIDENCED BY:

(I) PRIOR TO THE FILING OF THE PETITION, AT LEAST TWICE WITHIN THE 1 2 THIRTY-SIX MONTHS, HIS OR HER SUBSTANCE USE DISORDER HAS BEEN A LAST 3 SIGNIFICANT FACTOR IN NECESSITATING HOSPITALIZATION IN A HOSPITAL, AS 4 DEFINED IN ARTICLE TWENTY-EIGHT OF THE PUBLIC HEALTH LAW, OR RECEIPT OF 5 SUBSTANCE ABUSE TREATMENT SERVICES IN A CORRECTIONAL FACILITY OR A LOCAL 6 CORRECTIONAL FACILITY, NOT INCLUDING ANY CURRENT PERIOD, OR PERIOD 7 ENDING WITHIN THE LAST SIX MONTHS, DURING WHICH THE PERSON WAS OR IS 8 HOSPITALIZED OR INCARCERATED; OR

9 (II) PRIOR TO THE FILING OF THE PETITION, RESULTED IN ONE OR MORE ACTS 10 SERIOUS VIOLENT BEHAVIOR TOWARD SELF OR OTHERS OR THREATS OF, OR OF ATTEMPTS AT, SERIOUS PHYSICAL HARM TO SELF OR OTHERS WITHIN THE LAST 11 12 FORTY-EIGHT MONTHS, NOT INCLUDING ANY CURRENT PERIOD, OR PERIOD ENDING WITHIN THE LAST SIX MONTHS, IN WHICH THE PERSON WAS OR IS HOSPITALIZED 13 14 INCARCERATED; PROVIDED, HOWEVER, THAT USE OF AN OPIOID ALONE SHALL OR 15 NOT BE DEEMED AS SATISFYING THIS REQUIREMENT; AND

16 (5) IS, AS A RESULT OF HIS OR HER SUBSTANCE ABUSE, UNLIKELY TO VOLUN-TARILY PARTICIPATE IN SUBSTANCE USE DISORDER SERVICES THAT WOULD ENABLE 17 18 HIM OR HER TO LIVE SAFELY IN THE COMMUNITY; AND

19 (6) IN VIEW OF HIS OR HER TREATMENT HISTORY AND CURRENT BEHAVIOR, IS 20 IN NEED OF ASSISTED OUTPATIENT TREATMENT FOR SUBSTANCE ABUSE IN ORDER TO 21 PREVENT A RELAPSE OR DETERIORATION THAT WOULD BE LIKELY TO RESULT IN 22 SERIOUS HARM TO THE PERSON OR OTHERS; AND

23 (7) IS LIKELY TO BENEFIT FROM ASSISTED OUTPATIENT TREATMENT FOR 24 SUBSTANCE ABUSE.

25 S 23.07 PETITION TO THE COURT.

26 (A) A PETITION FOR AN ORDER AUTHORIZING ASSISTED OUTPATIENT TREATMENT 27 FOR SUBSTANCE ABUSE MAY BE FILED IN THE SUPREME OR COUNTY COURT IN THE 28 COUNTY IN WHICH THE SUBJECT OF THE PETITION IS PRESENT OR REASONABLY 29 BELIEVED TO BE PRESENT. A PETITION TO OBTAIN AN ORDER AUTHORIZING ASSISTED OUTPATIENT TREATMENT FOR SUBSTANCE ABUSE MAY BE INITIATED ONLY 30 31 BY THE FOLLOWING PERSONS:

32 (1) ANY PERSON EIGHTEEN YEARS OF AGE OR OLDER WITH WHOM THE SUBJECT OF 33 THE PETITION RESIDES; OR

34 (2) THE PARENT, SPOUSE, SIBLING, OR CHILD OF THE SUBJECT OF THE PETI-35 TION WHO IS EIGHTEEN YEARS OF AGE OR OLDER; OR

(3) ANY OTHER PERSON DEEMED APPROPRIATE BY THE COMMISSIONER IN REGU-36 37 LATION. 38

(B) THE PETITION SHALL STATE:

39 (1) EACH OF THE CRITERIA FOR ASSISTED OUTPATIENT TREATMENT FOR 40 SUBSTANCE ABUSE AS SET FORTH IN SECTION 23.05 OF THIS ARTICLE;

(2) FACTS WHICH SUPPORT THE PETITIONER'S BELIEF THAT THE SUBJECT OF 41 THE PETITION MEETS EACH CRITERION, PROVIDED THAT THE HEARING ON THE 42 43 PETITION NEED NOT BE LIMITED TO THE STATED FACTS; AND

44 (3) THAT THE SUBJECT OF THE PETITION IS PRESENT, OR IS REASONABLY 45 BELIEVED TO BE PRESENT, WITHIN THE COUNTY WHERE SUCH PETITION IS FILED.

(C) THE PETITION SHALL BE ACCOMPANIED BY AN AFFIRMATION OR AFFIDAVIT 46 47 OF A PHYSICIAN, WHO SHALL NOT BE THE PETITIONER, STATING EITHER THAT:

48 (1) SUCH PHYSICIAN HAS PERSONALLY EXAMINED THE SUBJECT OF THE PETITION 49 NO MORE THAN TEN DAYS PRIOR TO THE SUBMISSION OF THE PETITION, RECOM-50 MENDS ASSISTED OUTPATIENT TREATMENT FOR SUBSTANCE ABUSE FOR THE SUBJECT 51 THE PETITION, AND IS WILLING AND ABLE TO TESTIFY AT THE HEARING ON OF 52 THE PETITION; OR

(2) NO MORE THAN TEN DAYS PRIOR TO THE FILING OF THE PETITION, SUCH 53 54 PHYSICIAN OR HIS OR HER DESIGNEE HAS MADE APPROPRIATE ATTEMPTS, BUT HAS 55 NOT BEEN SUCCESSFUL IN ELICITING THE COOPERATION OF THE SUBJECT OF THE 56 PETITION TO SUBMIT TO AN EXAMINATION; SUCH PHYSICIAN HAS REASON TO 5 (D) IN COUNTIES WITH A POPULATION OF LESS THAN SEVENTY-FIVE THOUSAND, 6 THE AFFIRMATION OR AFFIDAVIT REQUIRED BY SUBDIVISION (C) OF THIS SECTION 7 MAY BE MADE BY A PHYSICIAN WHO IS AN EMPLOYEE OF THE OFFICE. THE OFFICE 8 IS AUTHORIZED TO MAKE AVAILABLE, AT NO COST TO THE COUNTY, A QUALIFIED 9 PHYSICIAN FOR THE PURPOSE OF MAKING SUCH AFFIRMATION OR AFFIDAVIT 10 CONSISTENT WITH THE PROVISIONS OF SUCH SUBDIVISION.

11 S 23.09 SERVICE.

12 THE PETITIONER SHALL CAUSE WRITTEN NOTICE OF THE PETITION TO BE GIVEN 13 TO THE SUBJECT OF THE PETITION, AND A COPY THEREOF TO BE GIVEN 14 PERSONALLY OR BY MAIL TO SUCH OTHER PERSONS AS THE COMMISSIONER DEEMS 15 APPROPRIATE IN REGULATION.

16 S 23.11 RIGHT TO COUNSEL.

17 THE SUBJECT OF THE PETITION SHALL HAVE THE RIGHT TO BE REPRESENTED BY 18 COUNSEL AT ALL STAGES OF A PROCEEDING COMMENCED UNDER THIS SECTION. 19 S 23.13 HEARING.

(A) UPON RECEIPT OF THE PETITION, THE COURT SHALL FIX THE DATE FOR A 20 21 HEARING. SUCH DATE SHALL BE NO LATER THAN THREE DAYS FROM THE DATE SUCH 22 PETITION IS RECEIVED BY THE COURT, EXCLUDING SATURDAYS, SUNDAYS AND HOLIDAYS. ADJOURNMENTS SHALL BE PERMITTED ONLY FOR GOOD CAUSE SHOWN. IN 23 24 GRANTING ADJOURNMENTS, THE COURT SHALL CONSIDER THE NEED FOR FURTHER 25 EXAMINATION BY A PHYSICIAN OR THE POTENTIAL NEED TO PROVIDE ASSISTED 26 OUTPATIENT TREATMENT FOR SUBSTANCE ABUSE EXPEDITIOUSLY. THE COURT SHALL 27 CAUSE THE SUBJECT OF THE PETITION, ANY OTHER PERSON RECEIVING NOTICE PURSUANT TO SECTION 23.09 OF THIS ARTICLE, THE PETITIONER, THE PHYSICIAN 28 WHOSE AFFIRMATION OR AFFIDAVIT ACCOMPANIED THE PETITION, AND SUCH OTHER 29 PERSONS AS THE COURT MAY DETERMINE TO BE ADVISED OF SUCH DATE. UPON SUCH 30 DATE, OR UPON SUCH OTHER DATE TO WHICH THE PROCEEDING MAY BE ADJOURNED, 31 32 THE COURT SHALL HEAR TESTIMONY AND, IF IT BE DEEMED ADVISABLE AND THE 33 SUBJECT OF THE PETITION IS AVAILABLE, EXAMINE THE SUBJECT OF THE PETI-TION IN OR OUT OF COURT. IF THE SUBJECT OF THE PETITION DOES NOT APPEAR 34 AT THE HEARING, AND APPROPRIATE ATTEMPTS TO ELICIT THE ATTENDANCE OF THE 35 SUBJECT HAVE FAILED, THE COURT MAY CONDUCT THE HEARING IN THE SUBJECT'S 36 37 ABSENCE. IN SUCH CASE, THE COURT SHALL SET FORTH THE FACTUAL BASIS FOR 38 CONDUCTING THE HEARING WITHOUT THE PRESENCE OF THE SUBJECT OF THE PETI-39 TION.

40 (B) THE COURT SHALL NOT ORDER ASSISTED OUTPATIENT TREATMENT FOR SUBSTANCE ABUSE UNLESS AN EXAMINING PHYSICIAN, WHO RECOMMENDS ASSISTED 41 OUTPATIENT TREATMENT FOR SUBSTANCE ABUSE AND HAS PERSONALLY EXAMINED THE 42 43 SUBJECT OF THE PETITION NO MORE THAN SIX MONTHS BEFORE THE FILING OF THE PETITION, TESTIFIES IN PERSON AT THE HEARING. SUCH PHYSICIAN SHALL STATE 44 45 THE FACTS AND CLINICAL DETERMINATIONS THAT SUPPORT THE ALLEGATION THAT SUBJECT OF THE PETITION MEETS EACH OF THE CRITERIA FOR ASSISTED 46 THE OUTPATIENT TREATMENT FOR SUBSTANCE ABUSE. THE COMMISSIONER SHALL IN 47 48 REGULATION ADDRESS INSTANCES IN WHICH THE SUBJECT OF THE PETITION 49 REFUSES EXAMINATION BY A PHYSICIAN.

50 (C) A PHYSICIAN WHO TESTIFIES PURSUANT TO SUBDIVISION (B) OF THIS SECTION SHALL STATE: (I) THE FACTS THAT SUPPORT THE ALLEGATION THAT THE 51 SUBJECT MEETS EACH OF THE CRITERIA FOR ASSISTED OUTPATIENT TREATMENT FOR 52 SUBSTANCE ABUSE, (II) THAT THE TREATMENT IS THE LEAST RESTRICTIVE ALTER-53 54 NATIVE, (III) THE RECOMMENDED ASSISTED OUTPATIENT TREATMENT FOR 55 SUBSTANCE ABUSE, AND (IV) THE RATIONALE FOR THE RECOMMENDED ASSISTED 56 OUTPATIENT TREATMENT FOR SUBSTANCE ABUSE. IF THE RECOMMENDED ASSISTED 1 OUTPATIENT TREATMENT FOR SUBSTANCE ABUSE INCLUDES MEDICATION SUPPORTED 2 RECOVERY, SUCH PHYSICIAN'S TESTIMONY SHALL PROVIDE SUCH DETAILS AS THE 3 COMMISSIONER SHALL REQUIRE IN REGULATION.

4 (D) THE SUBJECT OF THE PETITION SHALL BE AFFORDED AN OPPORTUNITY TO 5 PRESENT EVIDENCE, TO CALL WITNESSES ON HIS OR HER BEHALF, AND TO CROSS-6 EXAMINE ADVERSE WITNESSES.

7 S 23.15 WRITTEN TREATMENT PLAN.

8 COURT SHALL NOT ORDER ASSISTED OUTPATIENT TREATMENT FOR (A) THE SUBSTANCE ABUSE UNLESS A PHYSICIAN DEVELOPS AND PROVIDES TO THE COURT A 9 10 PROPOSED WRITTEN TREATMENT PLAN, IN ACCORDANCE WITH REGULATIONS PROMUL-GATED BY THE COMMISSIONER. THE WRITTEN TREATMENT PLAN SHALL INCLUDE CASE 11 MANAGEMENT SERVICES TO PROVIDE CARE COORDINATION. THE WRITTEN TREATMENT 12 PLAN ALSO SHALL INCLUDE ALL CATEGORIES OF SERVICES THAT SUCH PHYSICIAN 13 14 RECOMMENDS THAT THE SUBJECT OF THE PETITION RECEIVE. ALL SUBSTANCE ABUSE 15 PROGRAMS SHALL BE NOTIFIED REGARDING THEIR INCLUSION IN THE WRITTEN 16 TREATMENT PLAN.

17 THE PHYSICIAN APPOINTED TO DEVELOP THE WRITTEN TREATMENT PLAN (B) SHALL PROVIDE THE FOLLOWING PERSONS WITH AN OPPORTUNITY TO ACTIVELY 18 19 PARTICIPATE IN THE DEVELOPMENT OF SUCH PLAN: THE SUBJECT OF THE PETI-TION; THE TREATING PHYSICIAN, IF ANY; AND UPON THE REQUEST OF THE 20 SUBJECT OF THE PETITION, AN INDIVIDUAL SIGNIFICANT TO THE SUBJECT 21 22 INCLUDING ANY RELATIVE, CLOSE FRIEND OR INDIVIDUAL OTHERWISE CONCERNED THE WELFARE OF THE SUBJECT. IF THE SUBJECT OF THE PETITION HAS 23 WITH EXECUTED A HEALTH CARE PROXY, THE APPOINTED PHYSICIAN SHALL CONSIDER ANY 24 25 DIRECTIONS INCLUDED IN SUCH PROXY IN DEVELOPING THE WRITTEN TREATMENT 26 PLAN.

27 (C) THE COURT SHALL NOT ORDER ASSISTED OUTPATIENT TREATMENT FOR 28 SUBSTANCE ABUSE UNLESS A PHYSICIAN WHO DEVELOPED SUCH PLAN TESTIFIES TO EXPLAIN THE PROPOSED WRITTEN TREATMENT PLAN. SUCH PHYSICIAN SHALL STATE 29 THE CATEGORIES OF ASSISTED OUTPATIENT TREATMENT FOR SUBSTANCE ABUSE 30 RECOMMENDED, THE RATIONALE FOR EACH SUCH CATEGORY, FACTS WHICH ESTABLISH 31 32 SUCH TREATMENT IS THE LEAST RESTRICTIVE ALTERNATIVE, AND ANY OTHER THAT INFORMATION REQUIRED BY THE COMMISSIONER IN REGULATION. IF THE SUBJECT 33 34 OF THE PETITION HAS EXECUTED A HEALTH CARE PROXY, SUCH PHYSICIAN SHALL 35 STATE THE CONSIDERATION GIVEN TO ANY DIRECTIONS INCLUDED IN SUCH PROXY IN DEVELOPING THE WRITTEN TREATMENT PLAN. 36

37 S 23.17 DISPOSITION.

(A) IF AFTER HEARING ALL RELEVANT EVIDENCE, THE COURT DOES NOT FIND BY
 CLEAR AND CONVINCING EVIDENCE THAT THE SUBJECT OF THE PETITION MEETS THE
 CRITERIA FOR ASSISTED OUTPATIENT TREATMENT FOR SUBSTANCE ABUSE, THE
 COURT SHALL DISMISS THE PETITION.

(B) IF AFTER HEARING ALL RELEVANT EVIDENCE, THE COURT FINDS BY CLEAR 42 43 CONVINCING EVIDENCE THAT THE SUBJECT OF THE PETITION MEETS THE AND CRITERIA FOR ASSISTED OUTPATIENT TREATMENT FOR SUBSTANCE ABUSE, 44 AND 45 THERE IS NO APPROPRIATE AND FEASIBLE LESS RESTRICTIVE ALTERNATIVE, THE COURT MAY ORDER THE SUBJECT TO RECEIVE ASSISTED OUTPATIENT TREATMENT FOR 46 47 SUBSTANCE ABUSE FOR AN INITIAL PERIOD NOT TO EXCEED SIX MONTHS.
