- AN ACT to amend the public health law, in relation to providing certain benefits to veterans; and to amend the correction law, in relation to requiring certain reports relating to veterans

THE PEOPLE OF THE STATE OF NEW YORK, REPRESENTED IN SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

1 Section 1. Subdivision 1 of section 3803 of the public health law, as 2 amended by chapter 743 of the laws of 2006, is amended to read as 3 follows:

4 1. There is hereby created within the department the veterans health 5 care information program (referred to in this section as the "program"), which shall provide information on health issues associated with mili-6 7 tary duty, including but not limited to Agent Orange, Gulf War 8 Syndromes, toxic materials or harmful physical agents such as, depleted uranium, and hepatitis C, AND SPECIFIC MENTAL AND PHYSICAL HEALTH ISSUES 9 INCLUDING POST-TRAUMATIC STRESS DISORDER, TRAUMATIC BRAIN INJURY AND 10 OTHER BRAIN-RELATED INJURIES, for veterans, their surviving spouses and 11 12 health care providers.

13 S 2. Subdivision 1 of section 29 of the correction law, as amended by 14 section 12 of subpart A of part C of chapter 62 of the laws of 2011, is 15 amended and a new subdivision 5 is added to read as follows:

16 1. The department shall continue to collect, maintain, and analyze 17 statistical and other information and data with respect to persons 18 subject to the jurisdiction of the department, including but not limited 19 to: (a) the number of such persons: placed in the custody of the depart-20 ment, assigned to a specific department program, accorded community

supervision and declared delinquent, recommitted to a state correctional 1 2 institution upon revocation of community supervision, or discharged upon maximum expiration of sentence; (b) the criminal history of such 3 persons; (c) the social, educational, and vocational circumstances of 4 5 any such persons; [and,] (d) the institutional and community supervision programs and the behavior of such persons; AND, (E) THE MILITARY BACKб 7 GROUND AND CIRCUMSTANCES, IF SUCH PERSON SERVED IN THE UNITED STATES ARMED FORCES. Provided, however, in the event any statistical informa-8 tion on the ethnic background of the inmate population of a correctional 9 10 facility or facilities is collected by the department, such statistical information shall contain, but not be limited to, the following ethnic 11 12 (i) Caucasian; (ii) Asian; (iii) American Indian; (iv) categories: Afro-American/Black; and (v) Spanish speaking/Hispanic which category 13 14 shall include, but not be limited to, the following subcategories 15 consisting of: (1) Puerto Ricans; (2) Cubans; (3) Dominicans; and (4) 16 other Hispanic nationalities.

17 THE COMMISSIONER SHALL REPORT TO THE LEGISLATURE ON THE NUMBER OF 5. INMATES WHO ARE CURRENTLY SERVING SENTENCES IN STATE CORRECTIONAL FACIL-18 19 ITIES AND ANY LOCAL CORRECTIONAL FACILITIES WHO HAVE SERVED THE IN UNITED STATES ARMED FORCES. SUCH REPORT SHALL INCLUDE, BUT NOT BE LIMIT-20 21 ED TO THE FOLLOWING: A BREAKDOWN OF THE NUMBER OF INMATES BY BRANCH OF 22 SERVICE, TIME PERIOD OF MILITARY SERVICE AND THE TYPE OF DISCHARGE THE INMATE RECEIVED UPON SEPARATION FROM THE MILITARY. SUCH REPORT SHALL BE 23 24 DONE ANNUALLY.

25 S 3. This act shall take effect on the one hundred eightieth day after 26 it shall have become a law; provided, that any rules and regulations 27 necessary for the timely implementation of this act on its effective 28 date shall be promulgated on or before such date.
