AN ACT to amend the highway law, in relation to designating portions of the state highway system as the "Livonia Veterans Memorial Highway" and the "Springwater Veterans Memorial Highway"

THE PEOPLE OF THE STATE OF NEW YORK, REPRESENTED IN SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

Section 1. The highway law is amended by adding two new sections 344-d and 344-e to read as follows:

3 344-D. PORTION OF THE STATE HIGHWAY SYSTEM TO BE DESIGNATED AS THE S "LIVONIA VETERANS MEMORIAL HIGHWAY". ALL THAT PORTION OF THE STATE HIGH-4 5 WAY SYSTEM CONSTITUTING STATE ROUTE FIFTEEN A IN THE TOWN OF LIVONIA, 6 LIVINGSTON, BEGINNING AT LIMA AND LIVONIA TOWN LINE, COUNTY OF THE7 CONTINUING IN A GENERALLY SOUTHERLY DIRECTION, AND TERMINATING AΤ THE CANADICE TOWN LINE, SHALL BE DESIGNATED AND KNOWN AS THE 8 LIVONIA AND 9 "LIVONIA VETERANS MEMORIAL HIGHWAY".

10 S 344-E. PORTION OF THE STATE HIGHWAY SYSTEM TO BE DESIGNATED AS THE "SPRINGWATER VETERANS MEMORIAL HIGHWAY". ALL THAT PORTION OF THE STATE 11 HIGHWAY SYSTEM CONSTITUTING STATE ROUTE FIFTEEN A IN THE TOWN OF SPRING-12 13 WATER, COUNTY OF LIVINGSTON, BEGINNING AT THE CANADICE AND SPRINGWATER TOWN LINE, CONTINUING IN A GENERALLY SOUTHERLY DIRECTION, AND TERMINAT-14 ING AT THE INTERSECTION OF STATE ROUTE FIFTEEN A AND STATE ROUTE FIFTEEN 15 16 SHALL BE DESIGNATED AND KNOWN AS THE"SPRINGWATER VETERANS MEMORIAL 17 HIGHWAY".

18 S 2. The commissioner of transportation shall provide for the instal-19 lation and maintenance of adequate signing of the state highway system 20 designated pursuant to section one of this act. However, to avoid as confusion and to limit any possible disruption of commerce, the desig-21 22 nations called for pursuant to section one of this act shall be of cere-23 monial nature and the official name of state route 15 A shall not be 24 changed as a result of this act.

25 S 3. This act shall take effect immediately.
