AN ACT to amend the vehicle and traffic law, in relation to tinting on motor vehicle windows and making an appropriation therefor

THE PEOPLE OF THE STATE OF NEW YORK, REPRESENTED IN SENATE AND ASSEM-BLY, DO ENACT AS FOLLOWS:

Section 1. Paragraph (b) of subdivision 12-a of section 1 375 of the 2 vehicle and traffic law, as amended by chapter 155 of the laws of 1991, is amended to read as follows:

(b) No person shall operate any motor vehicle upon any public highway, road or street:

6 (1) the front windshield of which is composed of, covered by or treat-7 ed with any material which has a light transmittance of less than seventy percent unless such materials are limited to the uppermost six inches 8 9 of the windshield; or

10 (2) the sidewings or side windows of which on either side forward of or adjacent to the operator's seat are composed of, covered by or treat-11 12 ed with any material which has a light transmittance of less than seventy percent; or 13

14 (3) [if it is classified as a station wagon, sedan, hardtop, coupe, 15 hatchback or convertible and any] THE rear side [window] WINDOWS OF WHICH ARE COMPOSED OF, COVERED BY, OR TREATED WITH ANY MATERIAL WHICH 16 17 has a light transmittance of less than seventy percent; or

(4) the rear window of which is composed of, covered by or treated 18 with any material which has a light transmittance of less than seventy 19 percent. A rear window may have a light transmittance of 20 less than 21 seventy percent if the vehicle is equipped with side mirrors on both 22 sides of the vehicle so adjusted that the driver thereof shall have a clear and full view of the road and condition of traffic behind such 23 24 vehicle.

S 2. The sum of fifty thousand dollars (\$50,000), or so much thereof 1 2 as may be necessary, is hereby appropriated out of moneys in the state treasury in the general fund to the credit of the state purposes 3 account, not otherwise appropriated, and made immediately available to 4 5 the division of criminal justice services for distribution to local law 6 enforcement agencies for the purpose of purchasing tint meters to carry 7 the provisions of this act relating to the seventy percent light out 8 transmittance standard. Such moneys shall be payable on the audit and 9 the comptroller on vouchers certified or approved in the warrant of manner prescribed by law. 10

11 S 3. This act shall take effect on the first of January next succeed-12 ing the date on which it shall have become a law; provided, however, the 13 provisions of this act shall not apply to persons operating that model 14 year vehicle or earlier model year vehicle if the windows on said vehi-15 cle were in conformity with the provisions of paragraph (b) of subdivi-16 sion 12-a of section 375 of the vehicle and traffic law as such para-17 graph existed on the day preceding the effective date of this act.
