AN ACT to amend the executive law, in relation to directing contracting state agencies to develop a growth plan in order to increase participation of MWBEs with respect to state contracts and subcontracts

THE PEOPLE OF THE STATE OF NEW YORK, REPRESENTED IN SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

1 Section 1. Subdivision 3 of section 311 of the executive law is 2 amended by adding a new paragraph (d-1) to read as follows:

3 (D-1) TO REQUIRE ALL CONTRACTING STATE AGENCIES ΤO DEVELOP A THREE 4 ΤO DETERMINE A OF PROMOTING AND INCREASING YEAR GROWTH PLAN MEANS 5 PARTICIPATION BY MINORITY-OWNED AND WOMEN-OWNED BUSINESS ENTERPRISES 6 ТО STATE CONTRACTS AND SUBCONTRACTS. EVERY THREE YEARS, WITH RESPECT 7 BEGINNING MAY FIFTEENTH, TWO THOUSAND SIXTEEN, EACH CONTRACTING STATE 8 AGENCY SHALL SUBMIT A THREE YEAR GROWTH PLAN AS PART OF ITS ANNUAL 9 REPORT TO THE GOVERNOR AND LEGISLATURE PURSUANT TO SECTION ONE HUNDRED 10 SIXTY-FOUR OF THIS CHAPTER.

11 S 2. Subdivision 5 of section 315 of the executive law, as added by 12 chapter 175 of the laws of 2010, is amended to read as follows:

13 5. Each agency shall include in its annual report to the governor and 14 legislature pursuant to section one hundred sixty-four of [the executive law] THIS CHAPTER its annual goals for contracts with minority-owned and 15 16 women-owned business enterprises, the number of actual contracts issued 17 to minority-owned and women-owned business enterprises; and a summary of 18 all waivers of the requirements of subdivisions six and seven of section three hundred thirteen of this article allowed by the reporting 19 agency during the preceding year, including a description of the basis of the 20 waiver request and the rationale for granting such waiver. 21 Each agency 22 include in such annual report whether or not it has been shall also 23 required to prepare a remedial plan, and, if so, the plan and the extent 24 to which the agency has complied with each element of the plan. 1 THREE YEARS, BEGINNING MAY FIFTEENTH, TWO THOUSAND SIXTEEN, EACH AGENCY 2 SHALL INCLUDE IN SUCH ANNUAL REPORT ITS THREE YEAR GROWTH PLAN PURSUANT 3 TO SECTION THREE HUNDRED ELEVEN OF THIS ARTICLE.

4 S 3. This act shall take effect on the ninetieth day after it shall 5 have become a law; provided, however, the amendments to sections 311 and 6 315 of the executive law made by sections one and two of this act 7 respectively, shall not affect the expiration of such sections and shall 8 be deemed to expire therewith.
