- AN ACT to amend the mental hygiene law, in relation to establishing the sober living task force; and providing for the repeal of such provisions upon expiration thereof

THE PEOPLE OF THE STATE OF NEW YORK, REPRESENTED IN SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

1 Section 1. The mental hygiene law is amended by adding a new section 2 19.04 to read as follows:

3 S 19.04 SOBER LIVING TASK FORCE.

1. DEFINITIONS. AS USED IN THIS SECTION:

5 (A) "SOBER LIVING RESIDENCE" SHALL MEAN ANY RESIDENCE LOCATED IN NEW 6 YORK STATE WHERE THE OWNER OR OPERATOR OF SUCH RESIDENCE HOLDS THE RESI-7 DENCE OUT TO THE PUBLIC AS AN ALCOHOL AND DRUG FREE LIVING ENVIRONMENT 8 FOR PERSONS RECOVERING FROM A CHEMICAL DEPENDENCY, WHERE NO FORMAL 9 TREATMENT SERVICES ARE PROVIDED ON-SITE.

10 "SOBER LIVING NETWORK" SHALL MEAN A GROUP OF INDEPENDENTLY OPER-(B) ATED AND SELF-REGULATED SOBER LIVING RESIDENCES LOCATED IN NEW YORK 11 12 STATE WHICH COMPLY WITH THE GUIDELINES ISSUED PURSUANT TO THIS SECTION. THE SOBER LIVING TASK FORCE IS HEREBY CREATED, WHICH PURSUANT TO 13 2. THE PROVISIONS OF THIS SECTION, SHALL ESTABLISH BEST PRACTICE GUIDELINES 14 FOR SOBER LIVING RESIDENCES THAT ILLUSTRATE THE MOST APPROPRIATE AND 15 EFFECTIVE ENVIRONMENT FOR PERSONS RECOVERING FROM A CHEMICAL DEPENDENCY. 16 TASK FORCE SHALL UTILIZE INFORMATION COLLECTED FROM ORGANIZA-17 THE3.

18 TIONS AND PROGRAMS BOTH IN NEW YORK STATE AND THROUGHOUT THE COUNTRY TO: 19 (A) ISSUE RECOMMENDATIONS AND GUIDELINES ESTABLISHING BEST PRACTICES 20 FOR SOBER LIVING RESIDENCES TO PROVIDE AN ALCOHOL AND DRUG FREE SOBER 21 LIVING ENVIRONMENT;

1 (B) DEVELOP A PLAN TO ESTABLISH A STATEWIDE SOBER LIVING NETWORK AS 2 DEFINED IN PARAGRAPH (B) OF SUBDIVISION ONE OF THIS SECTION; AND

3 (C) IDENTIFY BARRIERS FOR INDIVIDUALS TO ACCESS RECOVERY SERVICES, 4 RESIDENTIAL TREATMENT FOR CHEMICAL DEPENDENCY AND APPROPRIATE HOUSING 5 WHERE INDIVIDUALS ARE PROVIDED AN ALCOHOL AND DRUG FREE LIVING ENVIRON-6 MENT.

7 4. (A) THE MEMBERS OF THE TASK FORCE SHALL INCLUDE THE COMMISSIONER OF 8 THE OFFICE OF ALCOHOLISM AND SUBSTANCE ABUSE SERVICES OR HIS OR HER DESIGNEE; THE COMMISSIONER OF THE OFFICE OF MENTAL HEALTH OR HIS OR HER 9 10 DESIGNEE; THE COMMISSIONER OF THE OFFICE OF TEMPORARY AND DISABILITY ASSISTANCE OR HIS OR HER DESIGNEE; THE COMMISSIONER OF THE OFFICE OF 11 HOMES AND COMMUNITY RENEWAL OR HIS OR HER DESIGNEE; ONE REPRESENTATIVE 12 THE NEW YORK STATE LOCAL MENTAL HYGIENE DIRECTORS; AT LEAST TWO 13 OF 14 REPRESENTATIVES OF REPUTABLE OWNERS OR OPERATORS OF A RESIDENCE WHICH CURRENTLY PROVIDES ALCOHOL AND DRUG FREE HOUSING FOR PERSONS IN RECOVERY 15 WHERE NO FORMAL TREATMENT SERVICES ARE PROVIDED ON-SITE; AT LEAST TWO 16 REPRESENTATIVES OF CHEMICAL DEPENDENCE RESIDENTIAL TREATMENT PROVIDERS 17 LICENSED BY THE OFFICE; AT LEAST ONE REPRESENTATIVE WHO IS NOT A PROVID-18 19 ER OF CHEMICAL DEPENDENCE OR MENTAL HEALTH SERVICES AND WHO REPRESENT 20 NON-GOVERNMENTAL ORGANIZATIONS, SUCH AS NOT-FOR-PROFIT ENTITIES OR OTHER 21 ORGANIZATIONS CONCERNED WITH THE PROVISION OF HOUSING AND RECOVERY SERVICES; AND ANY OTHER RELEVANT AGENCY OR PARTICIPANT THAT IS DEEMED 22 APPROPRIATE. THE COMMISSIONER SHALL BE DESIGNATED AS THE CHAIRPERSON OF 23 SUCH TASK FORCE AND SHALL SELECT A VICE-CHAIRPERSON AND A SECRETARY. 24 25 PRIOR TO THE FIRST MEETING OF THE TASK FORCE, IN CONSULTATION WITH THE STATE AGENCY MEMBERS OF SUCH TASK FORCE, THE CHAIRPERSON SHALL SELECT UP 26 27 TO EIGHT ADDITIONAL MEMBERS WHOM SHALL BE REPRESENTATIVES OF LOCAL GOVERNMENT AGENCIES IN NEW YORK STATE WHERE THE NEED FOR ALCOHOL AND 28 29 DRUG FREE HOUSING IS MOST PREVALENT.

(B) THE MEMBERS OF THE COUNCIL SHALL RECEIVE NO COMPENSATION FOR THEIR
 SERVICES BUT SHALL BE REIMBURSED FOR EXPENSES ACTUALLY AND NECESSARILY
 INCURRED IN THE PERFORMANCE OF THEIR DUTIES.

(C) NO CIVIL ACTION SHALL BE BROUGHT IN ANY COURT AGAINST ANY MEMBER 33 THE SOBER LIVING TASK FORCE FOR ANY ACT OR OMISSION NECESSARY TO THE 34 OF 35 DISCHARGE OF HIS OR HER DUTIES AS A MEMBER OF THE TASK FORCE, EXCEPT AS PROVIDED HEREIN. SUCH MEMBER MAY BE LIABLE FOR DAMAGES IN ANY SUCH 36 ACTION IF HE OR SHE FAILED TO ACT IN GOOD FAITH AND EXERCISE REASONABLE 37 38 CARE. ANY INFORMATION OBTAINED BY A MEMBER OF THE TASK FORCE WHILE CARRYING OUT HIS OR HER LIMITED DUTIES AS PRESCRIBED IN SUBDIVISION 39 40 THREE OF THIS SECTION SHALL ONLY BE UTILIZED IN THEIR CAPACITY AS A MEMBER OF THE TASK FORCE. 41

NO LATER THAN DECEMBER THIRTY-FIRST IN THE YEAR FOLLOWING 42 THE 43 EFFECTIVE DATE OF THIS SECTION THE TASK FORCE SHALL PROVIDE A REPORT TO THE TEMPORARY PRESIDENT OF THE SENATE, THE MINORITY LEADER OF 44 THE45 SENATE, THE SPEAKER OF THE ASSEMBLY, THE MINORITY LEADER OF THE ASSEM-BLY, AND THE CHAIRMAN OF THE APPROPRIATE LEGISLATIVE COMMITTEES. SUCH 46 REPORT SHALL INCLUDE BUT NOT BE LIMITED TO THE BEST PRACTICES ESTAB-47 LISHED FOR SOBER LIVING RESIDENCES; A DESCRIPTION OF THE PLAN 48 THAT 49 ESTABLISHES A STATEWIDE SOBER LIVING NETWORK; RECOMMENDATIONS BY THE TASK FORCE TO REDUCE ACCESS BARRIERS FOR INDIVIDUALS SEEKING RESIDENTIAL 50 TREATMENT FOR CHEMICAL DEPENDENCY; AND RECOMMENDATIONS FOR ANY OTHER 51 PROGRAM OR POLICY INITIATIVE THE TASK FORCE DEEMS APPROPRIATE.
