AN ACT to amend the election law, in relation to judicial proceedings

THE PEOPLE OF THE STATE OF NEW YORK, REPRESENTED IN SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

1 Section 1. Subdivision 2 of section 16-102 of the election law, as
2 amended by chapter 79 of the laws of 1992, is amended to read as
3 follows:
4 2. (A) A proceeding with respect to a petition shall be instituted
5 within fourteen days after the last day to file the petition, or within
6 three business days after the officer or board with whom or which such
7 petition was filed, makes a determination of invalidity with respect to
8 such petition, whichever is later; except that a proceeding with respect
9 to a petition for a village election or an independent nomination for a
10 special election shall be instituted within seven days after the last
11 day to file the petition for such village election or independent nomi-
12 nation or within three business days after the officer or board with
13 whom or which such petition was filed, makes a determination of invalid-
14 ity with respect to such petition, whichever is later. A proceeding with
15 respect to a primary, convention, meeting of a party committee, or
16 caucus shall be instituted within ten days after the holding of such
17 primary or convention or the filing of the certificate of nominations
18 made at such caucus or meeting of a party committee.
19 (B) IN ANY PROCEEDING COMMENCED PURSUANT TO PARAGRAPH (A) OF THIS
20 SUBDIVISION RELATED TO A DESIGNATING OR NOMINATING PETITION OR CERTIF-
21 ICATE, ANY PARTY THERETO MAY PLEAD, AS OF RIGHT WITHIN THE TIME TO
22 ANSWER, A COUNTER CLAIM, CROSS-PETITION, AFFIRMATIVE DEFENSE, OBJECTION
23 IN POINT OF LAW OR OTHER AVERMENT, FOR THE PURPOSE OF ASSERTING THE
24 VALIDITY OF SUCH DESIGNATING OR NOMINATING PETITION OR CERTIFICATE
25 INCLUDING THE VALIDITY OF ANY SIGNATURE THEREON.
26 S 2. This act shall take effect on the ninetieth day after it shall
27 have become a law. Effective immediately, the addition, amendment
28 and/or repeal of any rules or regulations necessary for the implementa-
29 tion of this act on its effective date are authorized to be made on or
30 before such date.
