AN ACT to amend the penal law, in relation to burglary in the second degree

THE PEOPLE OF THE STATE OF NEW YORK, REPRESENTED IN SENATE AND ASSEM-BLY, DO ENACT AS FOLLOWS:

Section 1. Subdivision 2 of section 140.25 of the 1 penal law, as amended by chapter 361 of the laws of 1981, is amended and a new subdi-2 3 vision 3 is added to read as follows: 4

2. The building is a dwelling[.]; OR

5 3. THE BUILDING IS A DWELLING WHICH, AT THE TIME OF THE COMMISSION OF 6 THE CRIME, IS OCCUPIED BY A PERSON WHO IS NOT A PARTICIPANT IN THE 7 CRIME.

8 S 2. Paragraph (b) of subdivision 1 of section 70.02 of the penal law, 9 as amended by chapter 1 of the laws of 2013, is amended to read as 10 follows:
