THE PEOPLE OF THE STATE OF NEW YORK, REPRESENTED IN SENATE AND ASSEM-BLY, DO ENACT AS FOLLOWS:

THE COURT, IN ISSUING ANY FINAL ORDER IN ANY ACTION BROUGHT PURSU-5 ANT TO SUBDIVISIONS 1 AND 2 OF SECTION 71-4503 OF THIS TITLE MAY IN ITS 6 DISCRETION AWARD COSTS, DISBURSEMENTS AND REASONABLE EXPERT WITNESS AND 7 ATTORNEY FEES TO ANY PREVAILING OR SUBSTANTIALLY PREVAILING PARTY; PROVIDED, HOWEVER, THAT SUCH AN AWARD TO A PREVAILING RESPONDENT OR DEFENDANT SHALL NOT EXCEED TEN THOUSAND DOLLARS AND A PREVAILING 8 9 RESPONDENT OR DEFENDANT IN ORDER TO RECOVER SUCH COSTS, DISBURSEMENTS, 10 REASONABLE EXPERT WITNESS AND ATTORNEY FEES MUST MAKE A MOTION REQUEST-11 ING SUCH COSTS, DISBURSEMENTS AND FEES AND SHOW THAT THE ACTION OR CLAIM 12 BROUGHT WAS FRIVOLOUS. 48 NOTHING IN THIS TITLE SHALL RESTRICT ANY RIGHT WHICH ANY PERSON OR 49 CLASS OF PERSONS MAY HAVE UNDER ANY STATUTE OR COMMON LAW TO SEEK 50 ENFORCEMENT OF ANY STATUTE, RULE, REGULATION, PERMIT, CERTIFICATE OR 51 ORDER, OR TO SEEK ANY OTHER RELIEF.

[1.] Whenever it appears that any person is violating or threatening 1 2 to violate any provision of article 23 of this chapter or is committing 3 any offense described in section 71-1305 of this title, the department, 4 acting by the Attorney General, may bring suit against such person in any court of competent jurisdiction to restrain such person from contin-uing such violation or from carrying out the threat of violation. In any 5 6 7 such suit, the court shall have jurisdiction to grant to the department 8 without bond or other undertaking, such prohibitory or mandatory injunc-9 tions as the facts may warrant, including temporary restraining orders 10 and preliminary injunctions.

11 the department, acting by the Attorney General, shall fail to [2. Ιf bring suit to enjoin a violation or threatened violation of any provision of article 23, or any rule, regulation, or order of the 12 13 department made pursuant hereto, within ten days after receipt of writ-14 15 ten request to do so by any person who is or will be adversely affected 16 by such violation, the person making such request may bring suit in his 17 to restrain such violation or threatened violation in any own behalf court in which the department might have brought suit. 18 The department shall be made a party in such suit in addition to the person violating 19 20 or threatening to violate a provision of article 23, or a rule, requ-21 lation, or order of the department, and the action shall proceed and 22 injunctive relief may be granted to the department without bond, or other undertaking in the same manner as if suit had been brought by the 23 24 department.]

This act shall take effect immediately; provided however, that no action authorized by section 71-4501 of the environmental conservation law, as added by section one of this act, may be commenced against any city, village, town or county prior to September 1, 2020 and nothing in this act shall affect any action commenced pursuant to section 71-1311 of the environmental conservation law prior to such effective date.
