- AN ACT to amend the labor law, in relation to the state policy against restraint of trade

THE PEOPLE OF THE STATE OF NEW YORK, REPRESENTED IN SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

POLICY AGAINST RESTRAINT OF TRADE

5 SECTION 950. POLICY.

951. PARTICULAR RESTRAINTS OF TRADE UNENFORCEABLE.

952. COVENANTS RELATING TO ATTORNEYS.

8 953. EXCEPTIONS.

9 S 950. POLICY. THE LEGISLATURE HEREBY REAFFIRMS THAT THE POLICY OF 10 THIS STATE IS TO DISFAVOR RESTRICTIVE COVENANTS IN EMPLOYMENT AS CONSTI-11 TUTING A RESTRAINT OF TRADE.

12 S 951. PARTICULAR RESTRAINTS OF TRADE UNENFORCEABLE. A COVENANT NOT TO COMPETE, OR NON-SOLICITATION AGREEMENT WITH RESPECT TO EITHER 13 EMPLOYEES ENFORCEABLE AGAINST A FORMER EMPLOYEE NO 14 CUSTOMERS, SHALL NOT BE OR 15 LONGER EMPLOYED BY A BUSINESS OR INDEPENDENT CONTRACTOR NO LONGER IN A 16 CONTRACTUAL RELATIONSHIP WITH THE BUSINESS, UNLESS (1) THE COVENANT IS 17 REASONABLE IN GEOGRAPHIC EXTENT OR IN TIME BASED ON THE CIRCUMSTANCES OF 18 THE CASE AND (2) ONE OF THE FOLLOWING IS TRUE:

1 (A) SUCH EMPLOYEE OR INDEPENDENT CONTRACTOR LEFT THE BUSINESS VOLUN-2 TARILY OR WAS INVOLUNTARILY TERMINATED OR DISCHARGED FOR MISCONDUCT; AND 3 SUCH EMPLOYEE OR INDEPENDENT CONTRACTOR IS UNIQUE AS A MATTER OF LAW. AN 4 EMPLOYEE OR INDEPENDENT CONTRACTOR IS CONSIDERED UNIQUE IF AND ONLY IF 5 HE OR SHE POSSESSES TRADE SECRETS OF THE BUSINESS OR CONFIDENTIAL MATE-6 RIAL THAT IS AKIN TO A TRADE SECRET.

7 (B) SUCH EMPLOYEE OR INDEPENDENT CONTRACTOR HAS PURCHASED OR SOLD ANY
8 PORTION OF THE BUSINESS. SUCH EMPLOYEES ARE DEEMED TO HAVE LEFT THE
9 BUSINESS VOLUNTARILY.

10 (C) SUCH EMPLOYEE OR INDEPENDENT CONTRACTOR IS A LEARNED PROFESSIONAL. 11 PROVIDED, HOWEVER, THAT COVENANTS INVOLVING LEARNED PROFESSIONALS ARE 12 NOT ENFORCEABLE IF SUCH LEARNED PROFESSIONAL WAS INVOLUNTARILY TERMI-13 NATED OR DISCHARGED FOR REASONS OTHER THAN MISCONDUCT.

14 S 952. COVENANTS RELATING TO ATTORNEYS. ANY SUCH COVENANTS REGARDING 15 ATTORNEYS, WHETHER AS EMPLOYEES OR INDEPENDENT CONTRACTORS, ARE UNEN-16 FORCEABLE IN LIGHT OF THE CLIENT'S RIGHT TO CHOOSE HIS OR HER OWN COUN-17 SEL.

953. EXCEPTIONS. SUCH RESTRICTIVE COVENANT MAY STILL BE ENFORCED IF 18 S 19 THE EMPLOYER DEMONSTRATES THAT (1) THE EMPLOYEE LEFT ITS BUSINESS VOLUN-TARILY OR WAS TERMINATED OR DISCHARGED FOR MISCONDUCT; AND (2) THERE ARE 20 21 UNUSUAL CIRCUMSTANCES UNIQUE TO THE BUSINESS AND TO THE EMPLOYEE INVOLVED SUCH THAT THE EMPLOYER HAS A COMPELLING INTEREST THAT OUTWEIGHS 22 23 EMPLOYEE OR INDEPENDENT CONTRACTOR'S INTEREST IN BEING ABLE TO THE 24 PURSUE HIS OR HER LIVELIHOOD AND THE PUBLIC INTEREST IN FREE AND OPEN COMPETITION; AND (3) SUCH RESTRICTIVE COVENANTS SHALL BE ENFORCED ONLY 25 TO THE EXTENT NECESSARY TO PROTECT THE EMPLOYER'S COMPELLING INTEREST. 26 27 S 2. This act shall take effect immediately.
