AN ACT to amend the public authorities law, in relation to method of collection of charges by the Suffolk county water authority

THE PEOPLE OF THE STATE OF NEW YORK, REPRESENTED IN SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

1 Section 1. The public authorities law is amended by adding a new 2 section 1078-f to read as follows:

3 S 1078-F. CHARGES BY AUTHORITY; METHOD OF COLLECTION. ALL RATES, OTHER CHARGES FOR THE USE OR AVAILABILITY OF THE FACILITIES OR 5 SERVICES OR COMMODITIES PROVIDED OR MADE AVAILABLE BY THE AUTHORITY BILLED DIRECTLY BY THE AUTHORITY TO THE USER OR SERVICE RECIPIENT PURSU-7 CLASSIFICATION OF PERSON ADOPTED BY THE AUTHORITY AS HEREIN ANT TO A 8 PROVIDED SHALL BE A LIEN UPON THE REAL PROPERTY UPON WHICH, WITH WHICH, SERVICES ARE PROVIDED OR ARE MADE AVAILABLE, AS 9 CONNECTION AND FROM THE FIRST DATE FIXED FOR A PAYMENT OF SUCH 10 RATES, FEES AND OTHER CHARGES. ANY SUCH LIEN SHALL TAKE PRECEDENCE OVER ALL OTHER LIENS, 11 ENCUMBRANCES, EXCEPT TAXES OR ASSESSMENTS. THE CHIEF FINANCIAL OFFI-12 CER OF THE AUTHORITY SHALL PREPARE AND TRANSMIT TO THE BOARD OF SUPERVI-13 14 SORS OF THE COUNTY, ON OR BEFORE THE FIRST DAY OF NOVEMBER IN EACH YEAR, 15 A LIST OF THOSE PROPERTIES USING SUCH FACILITIES OR FOR WHICH SERVICES OR COMMODITIES WERE PROVIDED OR MADE AVAILABLE AND 16 FACILITIES, 17 FROM WHICH THE PAYMENT OF RATES, FEES AND OTHER CHARGES ARE IN ARREARS FOR A PERIOD OF NINETY DAYS OR MORE AFTER THE LAST DAY FIXED FOR PAYMENT 18 19 SUCH RATES, FEES AND OTHER CHARGES WITHOUT PENALTY. THE LIST SHALL 20 CONTAIN A BRIEF DESCRIPTION OF SUCH PROPERTIES, THE NAMES OF THE PERSONS OR CORPORATIONS LIABLE TO PAY FOR THE SAME, AND THE AMOUNT CHARGEABLE TO 21 AND INTEREST, AS APPLICABLE, 22 EACH, INCLUDING PENALTIES COMPUTED 23 DECEMBER THIRTY-FIRST OF THAT YEAR. THE BOARD OF SUPERVISORS SHALL LEVY 24 SUCH SUMS AGAINST THE PROPERTIES LIABLE AND SHALL STATE THE AMOUNT THER-

- 11 S 2. This act shall take effect immediately.
