AN ACT to amend the highway law, in relation to the designation of the Rochester Craft Beverage Trail

THE PEOPLE OF THE STATE OF NEW YORK, REPRESENTED IN SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

1     Section 1. The highway law is amended by adding a new section 344-e to  
2     read as follows:

3     S 344-E. PORTION OF STATE HIGHWAY SYSTEM TO BE DESIGNATED AS THE  
4     "ROCHESTER CRAFT BEVERAGE TRAIL." ALL THAT PORTION OF THE STATE AND  
5     LOCAL HIGHWAY SYSTEM CONSTITUTING HIGHWAY 490 FROM THE INTERSECTION WITH  
6     HIGHWAY 390 EASTWARD TO THE INTERSECTION WITH INTERSTATE 90, HIGHWAY 390  
7     FROM THE INTERSECTION WITH HIGHWAY 104 SOUTHWARD TO THE INTERSECTION  
8     WITH INTERSTATE 90, HIGHWAY 590 FROM THE INTERSECTION WITH HIGHWAY 390  
9     NORTHWARD TO THE INTERSECTION WITH HIGHWAY 104, HIGHWAY 104 FROM THE  
10     INTERSECTION WITH HIGHWAY 390 EASTWARD TO THE INTERSECTION WITH HIGHWAY  
11     14, HIGHWAY 96 FROM THE INTERSECTION WITH HIGHWAY 332 EASTWARD TO THE  
12     INTERSECTION WITH EAST MAIN STREET IN ROCHESTER, HIGHWAY 20 FROM THE  
13     INTERSECTION WITH HIGHWAY 390 EASTWARD TO THE INTERSECTION WITH HIGHWAY  
14     14, HIGHWAY 21 FROM THE INTERSECTION WITH HIGHWAY 20 SOUTHWARD TO THE  
15     INTERSECTION WITH HIGHWAY 64, HIGHWAY 15-A FROM THE INTERSECTION WITH  
16     HIGHWAY 90 SOUTHWARD TO THE INTERSECTION WITH HIGHWAY 20, HIGHWAY 250  
17     FROM THE INTERSECTION WITH HIGHWAY 96 NORTHWARD TO THE INTERSECTION WITH  
18     HIGHWAY 31, HIGHWAY 15 FROM THE INTERSECTION WITH HIGHWAY 390 EASTWARD  
19     TO THE INTERSECTION WITH HIGHWAY 490, HIGHWAY 252 FROM THE INTERSECTION  
20     WITH HIGHWAY 15A EASTWARD TO THE INTERSECTION WITH HIGHWAY 15, AND HIGH-  
21     WAY 250 FROM THE INTERSECTION WITH HIGHWAY 31 SOUTHWARD TO THE INTER-  
22     SECTION WITH HIGHWAY 96 SHALL BE DESIGNATED AND KNOWN AS THE "ROCHESTER  
23     CRAFT BEVERAGE TRAIL."

24     S 2. The commissioner of transportation is authorized to permit the  
25     installation and maintenance of signs on the state highway system as  
26     designated pursuant to section 344-e of the highway law, as added by  
27     section one of this act. However, to avoid confusion and to limit any  
28     possible disruption of commerce, the designation called for pursuant to  
29     this act shall be one of a ceremonial nature and the official names of  
30     such highways shall not be changed as a result of this act.

31     S 3. This act shall take effect immediately.
