AN ACT to amend the education law, in relation to establishing a computer coding and basic programming course for secondary schools

THE PEOPLE OF THE STATE OF NEW YORK, REPRESENTED IN SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

1 Section 1. Section 1103 of the education law is amended to read as
2 follows:
3 S 1103. Courses of study and qualifications of teachers. 1. The
4 courses of instruction to accomplish the purposes of THIS part [one of
5 this article] are to be approved by the commissioner [of education].
6 Such courses when conducted in elementary or secondary schools are to be
7 approved by the superintendent in whose jurisdiction such instruction is
8 given. The qualifications of the teachers, directors, assistants and
9 supervisors employed by a vocational education and extension board must
10 conform to the regulations of the regents of the university and the
11 commissioner [of education].
12 2. ONE SUCH COURSE OF STUDY FOR SECONDARY SCHOOLS SHALL BE COMPUTER
13 CODING AND BASIC PROGRAMMING. THE BOARD OF SUPERVISORS SHALL ESTABLISH
14 THE CURRICULUM AND CERTIFICATION PROCESS FOR STUDENTS TO COMPLETE.
15 S 2. Section 1112 of the education law is amended to read as follows:
16 S 1112. Courses of study and qualifications of teachers. 1. The
17 courses of instruction to accomplish the purposes of THIS part [two of
18 this article] are to be approved by the commissioner [of education].
19 The qualifications of the teachers, directors, assistants and supervisors
20 employed by the county commission for special education must
21 conform to the regulations of the regents of the university and the
22 commissioner [of education].
23 2. ONE SUCH COURSE OF STUDY FOR SECONDARY SCHOOLS SHALL BE COMPUTER
24 CODING AND BASIC PROGRAMMING. THE BOARD OF SUPERVISORS SHALL ESTABLISH
25 THE CURRICULUM AND CERTIFICATION PROCESS FOR STUDENTS TO COMPLETE.
26 S 3. This act shall take effect the first of July next succeeding the
27 date on which it shall become a law; provided, however, that effective
28 immediately, the addition, amendment and/or repeal of any rule or regulation
29 necessary for the implementation of this act on its effective
30 date is authorized to be made and completed on or before such effective
31 date.
