- AN ACT to amend the executive law and the labor law, in relation to creating a veterans' jobs website

THE PEOPLE OF THE STATE OF NEW YORK, REPRESENTED IN SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

1 Section 1. Section 353 of the executive law is amended by adding a new 2 subdivision 23 to read as follows:

3 23. TO DEVELOP, JOINTLY WITH THE COMMISSIONER OF LABOR, A WEBSITE WITH JOB LISTINGS, JOB TRAINING MATERIALS, AND JOB SEARCH INFORMATION EXCLU-4 5 SIVELY FOR VETERANS, CARE GIVERS FOR DISABLED VETERANS, THE IMMEDIATE FAMILY MEMBERS OF DISABLED VETERANS AND IMMEDIATE FAMILY MEMBERS OF б 7 DUTY MILITARY STATIONED IN NEW YORK. THE WEBSITE SHALL CONTAIN ACTIVE 8 EMPLOYMENT OPPORTUNITIES THAT ARE ONLY AVAILABLE THROUGH THIS WEBSITE 9 AND NOT AVAILABLE ON ANY OTHER WEBSITE, JOB LISTING, BOARD, NEWSPAPER OR SHALL BE INTERACTIVE WHERE APPLICANTS CAN PROVIDE 10 FORUM. THE WEBSITE RESUMES OR COMPLETE JOB APPLICATIONS AND CHECK 11 THE STATUS OF THEIR 12 APPLICATIONS AND REPORT THE OUTCOMES OF THEIR JOB SEARCHES. THE COMMIS-13 SIONER AND THE COMMISSIONER OF LABOR SHALL DEVELOP A PROCESS FOR PROVID-14 ING EXCLUSIVE ACCESS TO THE WEBSITE TO VETERANS, CARE GIVERS FOR DISA-BLED VETERANS AND IMMEDIATE FAMILY MEMBERS OF ACTIVE DUTY 15 MILITARY STATIONED IN NEW YORK. 16

17 S 2. Section 21 of the labor law is amended by adding a new subdivi-18 sion 15 to read as follows:

19 15. SHALL WORK WITH THE COMMISSIONER OF VETERANS' AFFAIRS TO DEVELOP A 20 WEBSITE AS SET FORTH IN SECTION THREE HUNDRED FIFTY-THREE OF THE EXECU-

TIVE LAW. IN ADDITION, THE COMMISSIONER SHALL PREPARE A REPORT ANALYZING 1 THE CURRENT EMPLOYMENT OF VETERANS, THE CARE GIVERS OF DISABLED VETERANS 2 3 IMMEDIATE FAMILY MEMBERS OF ACTIVE DUTY MILITARY STATIONED IN NEW AND 4 YORK; SUCH STUDY SHALL INCLUDE RATES OF UNEMPLOYMENT, AN ANALYSIS OF THE 5 BARRIERS FACED IN BECOMING GAINFULLY EMPLOYED, ANALYSIS OF THE CONDI-TIONS THAT LEAD TO SUCCESSFUL EMPLOYMENT, AND PROVIDE RECOMMENDATIONS б 7 FOR REMOVING BARRIERS FACED IN FINDING GAINFUL EMPLOYMENT. SUCH REPORT SHALL BE PREPARED NO LATER THAN JANUARY FIRST, TWO THOUSAND SEVENTEEN 8 AND BE UPDATED EVERY FIVE YEARS THEREAFTER. THE REPORT SHALL BE PROVIDED 9 10 TO THE GOVERNOR AND LEGISLATURE AND PUBLISHED ON THE DEPARTMENT OF LABOR AND DIVISION OF VETERANS' AFFAIRS WEBSITES. 11

12 S 3. This act shall take effect immediately; provided, however, that 13 the addition, amendment and/or repeal of any rule or regulation neces-14 sary for the implementation of this act on its effective date is author-15 ized to be made and completed on or before such effective date.
