AN ACT to amend the social services law, in relation to establishing a single point of access to benefits and services for people with HIV in each local department of social services

THE PEOPLE OF THE STATE OF NEW YORK, REPRESENTED IN SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

1 Section 1. The social services law is amended by adding a new section 2 138 to read as follows:

3 S 138. SINGLE POINT OF ACCESS TO HIV SERVICES. 1. THE OFFICE OF TEMPO-RARY AND DISABILITY ASSISTANCE SHALL DIRECT EACH LOCAL DEPARTMENT OF 4 5 SOCIAL SERVICES (LDSS) TO ESTABLISH AND MAINTAIN A SINGLE POINT OF ACCESS TO BENEFITS AND SERVICES AS DEFINED IN SUBDIVISION THREE OF THIS б 7 SECTION TO EVERY PERSON WITH HIV INFECTION WHO REQUESTS ASSISTANCE, AND 8 SHALL ENSURE THE PROVISION OF BENEFITS AND SERVICES TO EACH ELIGIBLE 9 PERSON INFECTED WITH HIV.

10 2. THE COMMISSIONER OF THE OFFICE OF TEMPORARY AND DISABILITY ASSIST-11 ANCE SHALL DIRECT EACH LDSS TO PROVIDE TO PERSONS WITH HIV INFECTION WHO 12 SATISFY THE ELIGIBILITY REQUIREMENTS FOR MEDICAID AS SET FORTH IN U.S.C. 13 1396 ET SEQ.:

14 (A) INTENSIVE CASE MANAGEMENT WITH AN AVERAGE RATIO WHICH SHALL NOT
15 EXCEED ONE CASEWORKER OR SUPERVISOR TO TWENTY-FIVE FAMILY CASES, AND
16 WITH AN OVERALL AVERAGE RATIO FOR ALL CASES WHICH SHALL NOT EXCEED ONE
17 CASEWORKER OR SUPERVISOR TO THIRTY-FOUR CASES; AND

18 (B) TRANSPORTATION AND NUTRITION ALLOWANCES IN AN AMOUNT NOT LESS THAN 19 ONE HUNDRED NINETY-THREE DOLLARS PER MONTH.

20 3. (A) WHENEVER USED IN THIS SUBDIVISION, THE FOLLOWING TERMS SHALL 21 HAVE THE FOLLOWING MEANINGS:

22 (1) "ACCESS TO BENEFITS AND SERVICES" SHALL MEAN THE PROVISION OF 23 ASSISTANCE BY STAFF OF THE LDSS TO A PERSON WITH HIV INFECTION AT A 24 SINGLE LOCATION IN ORDER TO APPLY FOR PUBLICLY SUBSIDIZED BENEFITS AND

SERVICES, TO ESTABLISH ANY AND ALL ELEMENTS OF ELIGIBILITY INCLUDING,
 BUT NOT LIMITED TO, ASSISTANCE PROVIDED AT A FIELD OFFICE OF THE LDSS,
 AT THE HOME OF THE APPLICANT OR RECIPIENT, AT A HOSPITAL WHERE SUCH
 APPLICANT OR RECIPIENT IS A PATIENT OR AT ANOTHER LOCATION IN ASSEMBLING
 SUCH DOCUMENTATION AS MAY BE NECESSARY TO ESTABLISH ANY AND ALL ELEMENTS
 OF ELIGIBILITY AND TO MAINTAIN SUCH ELIGIBILITY;

7 (2) "ELIGIBLE PERSON" SHALL MEAN A PERSON WHO SATISFIES THE ELIGIBIL8 ITY REQUIREMENTS ESTABLISHED PURSUANT TO APPLICABLE LOCAL, STATE OR
9 FEDERAL STATUTE, LAW, RULE OR REGULATION FOR THE BENEFITS AND SERVICES
10 SET FORTH IN PARAGRAPH (B) OF THIS SUBDIVISION OR FOR ANY OTHER BENEFITS
11 AND SERVICES DEEMED APPROPRIATE BY THE COMMISSIONER;

(3) "MEDICALLY APPROPRIATE TRANSITIONAL AND PERMANENT HOUSING" SHALL
MEAN HOUSING WHICH IS SUITABLE FOR PERSONS WITH SEVERELY COMPROMISED
IMMUNE SYSTEMS, AND IF NECESSARY, ACCESSIBLE TO PERSONS WITH DISABILITIES. SUCH HOUSING SHALL INCLUDE, BUT NOT BE LIMITED TO, INDIVIDUAL
REFRIGERATED FOOD AND MEDICINE STORAGE AND ADEQUATE BATHROOM FACILITIES
WHICH SHALL, AT A MINIMUM, PROVIDE AN EFFECTIVE LOCKING MECHANISM AND
ANY OTHER SUCH MEASURES AS ARE NECESSARY TO ENSURE PRIVACY;

19 (4) "PERSONS WITH HIV INFECTION" SHALL MEAN A PERSON WHO HAS RECEIVED 20 A MEDICAL DETERMINATION THAT HE OR SHE IS INFECTED WITH HIV; AND

21 (5) "COMMISSIONER" SHALL MEAN THE COMMISSIONER OF THE OFFICE OF TEMPO-22 RARY AND DISABILITY ASSISTANCE.

(B) THE COMMISSIONER SHALL DIRECT EACH LDSS TO PROVIDE ACCESS TO BENE-23 FITS AND SERVICES TO EVERY ELIGIBLE PERSON WITH HIV INFECTION WHO 24 25 REQUESTS ASSISTANCE, AND SHALL ENSURE THE PROVISION OF BENEFITS AND SERVICES TO ELIGIBLE PERSONS WITH HIV INFECTION. ANY ELIGIBLE PERSON 26 27 SHALL RECEIVE ONLY THOSE BENEFITS AND SERVICES FOR WHICH SUCH PERSON 28 QUALIFIES IN ACCORDANCE WITH THE APPLICABLE ELIGIBILITY STANDARDS ESTAB-LISHED PURSUANT TO LOCAL, STATE OR FEDERAL STATUTE, LAW, RULE OR REGU-29 LATION. SUCH BENEFITS AND SERVICES SHALL INCLUDE, BUT NOT BE LIMITED TO: 30 MEDICALLY APPROPRIATE TRANSITIONAL AND PERMANENT HOUSING; MEDICAID, AS 31 32 FORTH IN 42 U.S.C. 1396 ET SEQ. AND OTHER HEALTH-RELATED SERVICES; SET LONG TERM CARE SERVICES PROVIDED BY A CERTIFIED HOME HEALTH AGENCY, LONG 33 34 TERM HOME HEALTH CARE PROGRAM OR AIDS HOME CARE PROGRAM AUTHORIZED PURSUANT TO ARTICLE THIRTY-SIX OF THE PUBLIC HEALTH LAW; PERSONAL CARE 35 SERVICES PURSUANT TO THIS ARTICLE; HOMEMAKER SERVICES AS DEFINED IN 36 SUBDIVISION SIX OF SECTION THIRTY-SIX HUNDRED TWO OF THE PUBLIC HEALTH 37 38 LAW; FOOD STAMPS IN ACCORDANCE WITH SECTION NINETY-FIVE OF THIS CHAPTER; 39 TRANSPORTATION AND NUTRITION ALLOWANCES AS REQUIRED BY SUBDIVISION TWO 40 THIS SECTION; PREVENTATIVE SERVICES, INCLUDING RENT SUBSIDIES, IN OF ACCORDANCE WITH SECTION FOUR HUNDRED NINE-A OF THIS CHAPTER; FINANCIAL 41 BENEFITS; AND INTENSIVE CASE MANAGEMENT AS REQUIRED BY SUBDIVISION TWO 42 OF THIS SECTION. THE COMMISSIONER SHALL HAVE THE AUTHORITY TO DIRECT 43 44 EACH LDSS TO PROVIDE ACCESS TO ADDITIONAL BENEFITS AND SERVICES AND 45 ENSURE THE PROVISION OF SUCH ADDITIONAL BENEFITS AND SERVICES WHENEVER DEEMED APPROPRIATE. THE REQUIREMENTS WITH RESPECT TO SUCH ACCESS TO AND 46 47 ELIGIBILITY FOR BENEFITS AND SERVICES SHALL NOT BE MORE RESTRICTIVE THAN 48 THOSE REQUIREMENTS MANDATED BY STATE OR FEDERAL STATUTE, LAW, RULE OR WITHIN THIRTY DAYS OF THE EFFECTIVE DATE OF THIS SECTION, 49 REGULATION. 50 THE COMMISSIONER SHALL ESTABLISH CRITERIA PURSUANT TO WHICH AN APPLICANT SHALL BE ENTITLED TO A HOME OR HOSPITAL VISIT FOR THE PURPOSE OF ESTAB-51 LISHING ELIGIBILITY AND APPLYING FOR BENEFITS AND SERVICES. 52

53 (C)(1) UPON WRITTEN OR ORAL APPLICATION TO AN LDSS OR SUBMISSION OF 54 DOCUMENTS REQUIRED TO ESTABLISH ELIGIBILITY FOR BENEFITS AND SERVICES BY 55 A PERSON WITH HIV INFECTION, SUCH PERSON SHALL IMMEDIATELY BE PROVIDED 56 WITH A RECEIPT WHICH SHALL INCLUDE, BUT NOT BE LIMITED TO, THE DATE, A 1 DESCRIPTION OF THE INFORMATION RECEIVED, AND A STATEMENT AS TO WHETHER 2 ANY APPLICATION FOR SUCH BENEFITS AND SERVICES IS COMPLETE OR INCOM-3 PLETE, AND IF INCOMPLETE, SUCH RECEIPT SHALL IDENTIFY ANY INFORMATION OR 4 DOCUMENTS NEEDED IN ORDER FOR THE APPLICATION TO BE DEEMED COMPLETE.

5 (2) WHERE NO STATUTE, LAW, RULE OR REGULATION PROVIDES A TIME PERIOD 6 WITHIN WHICH A BENEFIT OR SERVICE SHALL BE PROVIDED TO AN ELIGIBLE 7 PERSON WHO REQUESTS SUCH A BENEFIT OR SERVICE, SUCH BENEFIT OR SERVICE 8 SHALL BE PROVIDED NO LATER THAN TWENTY BUSINESS DAYS FOLLOWING 9 SUBMISSION OF ALL INFORMATION OR DOCUMENTATION REQUIRED TO DETERMINE 10 ELIGIBILITY.

(D) WHERE A PERSON WITH HIV INFECTION WHO APPLIES FOR 11 BENEFITS AND 12 SERVICES, OR ACCESS TO BENEFITS AND SERVICES, INDICATES THAT ONE OR MORE MINOR CHILDREN RESIDE WITH HIM OR HER OR ARE IN HIS OR HER CARE OR 13 14 CUSTODY, SUCH PERSON SHALL BE GIVEN INFORMATION AND PROGRAM REFERRALS ON 15 CHILD CARE OPTIONS AND CUSTODY PLANNING, INCLUDING THE AVAILABILITY OF STANDBY GUARDIANSHIP PURSUANT TO SECTION SEVENTEEN HUNDRED TWENTY-SIX OF 16 17 SURROGATE'S COURT PROCEDURE ACT AND REFERRAL TO LEGAL ASSISTANCE THE 18 PROGRAMS.

(E) RECERTIFICATION OF ELIGIBILITY, AS REQUIRED BY ANY STATE OR FEDER AL LAW, STATUTE, RULE OR REGULATION SHALL BE CONDUCTED NO MORE FREQUENT LY THAN MANDATED BY SUCH STATUTE, LAW, RULE OR REGULATION.

(F) ELIGIBILITY FOR BENEFITS AND SERVICES FOR PERSONS 22 WITH HIV INFECTION MAY NOT BE TERMINATED EXCEPT WHERE THE RECIPIENT IS DETERMINED 23 24 NO LONGER SATISFY ELIGIBILITY REQUIREMENTS, IS DECEASED, OR UPON TO 25 CERTIFICATION BY THE LDSS THAT THE RECIPIENT CANNOT BE LOCATED TO VERIFY 26 HIS OR HER CONTINUED ELIGIBILITY FOR BENEFITS AND SERVICES. IN THE 27 CIRCUMSTANCE, THE LDSS SHALL CONDUCT A REASONABLE GOOD FAITH LATTER 28 SEARCH FOR AT LEAST A NINETY DAY PERIOD TO LOCATE THE RECIPIENT, INCLUD-29 ING SENDING WRITTEN NOTICE BY CERTIFIED MAIL, RETURN RECEIPT REQUESTED, THE LAST KNOWN ADDRESS OF SUCH RECIPIENT, REQUIRING THE RECIPIENT TO 30 TO 31 CONTACT THE LDSS WITHIN TEN DAYS.

32 (G) NOT LATER THAN SIXTY DAYS FROM THE EFFECTIVE DATE OF THIS SECTION, 33 THE COMMISSIONER SHALL DIRECT EACH LDSS TO PREPARE A DRAFT POLICY AND 34 PROCEDURES MANUAL FOR LDSS STAFF. SUCH POLICY AND PROCEDURES MANUAL SHALL INCLUDE, BUT NOT BE LIMITED TO, STRICT GUIDELINES ON MAINTAINING 35 CONFIDENTIALITY OF THE IDENTITY OF AND INFORMATION RELATING TO ALL 36 THE 37 APPLICANTS AND RECIPIENTS, INSTRUCTIONAL MATERIALS RELATING TO THE 38 MEDICAL AND PSYCHOLOGICAL NEEDS OF PERSONS WITH HIV INFECTION, APPLICA-39 TION PROCEDURES, ELIGIBILITY STANDARDS, MANDATED TIME PERIODS FOR THE 40 PROVISION OF EACH BENEFIT AND SERVICE AVAILABLE TO APPLICANTS AND RECIP-IENTS AND ADVOCACY RESOURCES AVAILABLE TO PERSONS WITH HIV INFECTION. 41 SUCH LISTS OF ADVOCACY RESOURCES SHALL BE UPDATED SEMI-ANNUALLY. 42 WITHIN 43 THIRTY DAYS FOLLOWING THE PREPARATION OF SUCH DRAFT POLICY AND PROCE-44 DURES MANUAL AND PRIOR TO THE PREPARATION OF A FINAL POLICY AND PROCE-45 DURES MANUAL, THE LDSS SHALL DISTRIBUTE SUCH DRAFT POLICY AND PROCEDURES MANUAL TO ALL SOCIAL SERVICES AGENCIES AND ORGANIZATIONS THAT CONTRACT 46 47 WITH THE LDSS TO PROVIDE HIV-RELATED SERVICES AND TO ALL OTHERS WHOM THE 48 LDSS DEEMS APPROPRIATE, AND HOLD NO FEWER THAN ONE NOTICED PUBLIC HEAR-49 ING AT A SITE ACCESSIBLE TO THE DISABLED, AT WHICH ADVOCATES, SERVICES 50 PROVIDERS, PERSONS WITH HIV INFECTION, AND ANY OTHER MEMBER OF THE PUBLIC SHALL BE GIVEN AN OPPORTUNITY TO COMMENT ON SUCH DRAFT POLICY AND 51 PROCEDURES MANUAL. EACH LDSS SHALL PREPARE A FINAL POLICY AND PROCEDURES 52 MANUAL WITHIN THIRTY DAYS AFTER THE CONCLUSION OF SUCH HEARING AND SHALL 53 54 THEREAFTER REVIEW AND WHERE APPROPRIATE, REVISE SUCH POLICY AND PROCE-55 DURES MANUAL ON AN ANNUAL BASIS. EACH LDSS SHALL PROVIDE FOR SEMI-ANNUAL 1 TRAINING, USING SUCH POLICY AND PROCEDURES MANUAL, FOR ALL DIVISION 2 STAFF.

3 (H) NOT LATER THAN SIXTY DAYS FROM THE EFFECTIVE DATE OF THIS SECTION, 4 EACH LDSS SHALL PUBLISH A PROPOSED RULE ESTABLISHING A BILL OF RIGHTS 5 FOR PERSONS WITH HIV INFECTION. SUCH DRAFT BILL OF RIGHTS SHALL INCLUDE, 6 BUT NOT BE LIMITED TO, AN EXPLANATION OF THE BENEFITS AND SERVICES FOR 7 WHICH PERSONS WITH HIV INFECTION MAY BE ELIGIBLE; TIMETABLES WITHIN WHICH SUCH BENEFITS AND SERVICES SHALL BE PROVIDED TO ELIGIBLE PERSONS; 8 AN EXPLANATION OF AN APPLICANT'S AND RECIPIENT'S RIGHT TO EXAMINE HIS OR 9 10 HER FILE AND THE PROCEDURE FOR DISPUTING ANY INFORMATION CONTAINED THER-EIN; AN EXPLANATION OF AN APPLICANT'S AND RECIPIENT'S RIGHT TO A HOME OR 11 HOSPITAL VISIT FOR THE PURPOSE OF APPLYING FOR OR MAINTAINING BENEFITS 12 OR SERVICES; AN EXPLANATION OF THE PROCESS FOR REQUESTING AN LDSS 13 14 CONFERENCE OR FAIR HEARING IN ACCORDANCE WITH SECTION TWENTY-TWO OF THIS 15 CHAPTER; AND A SUMMARY OF THE RIGHTS AND REMEDIES FOR THE REDRESS OF 16 DISCRIMINATION. WITHIN SIXTY DAYS FOLLOWING THE PUBLICATION OF SUCH 17 PROPOSED RULE, AND PRIOR TO THE PUBLICATION OF A FINAL RULE, EACH LDSS SHALL HOLD NO FEWER THAN ONE NOTICED PUBLIC HEARING AT A SITE ACCESSIBLE 18 19 TO THE DISABLED AT WHICH ADVOCATES, SERVICE PROVIDERS, PERSONS WITH HIV 20 INFECTION, AND ANY OTHER MEMBER OF THE PUBLIC SHALL BE GIVEN AN OPPORTU-21 NITY TO COMMENT ON SUCH DRAFT BILL OF RIGHTS. EACH LDSS SHALL PUBLISH A FINAL RULE WITHIN THIRTY DAYS AFTER THE CONCLUSION OF SUCH HEARING AND 22 23 SHALL THEREAFTER REVIEW, AND WHERE APPROPRIATE, REVISE SUCH BILL OF 24 RIGHTS ON AN ANNUAL BASIS. SUCH BILL OF RIGHTS SHALL BE CONSPICUOUSLY 25 POSTED IN ALL LDSS OFFICES THAT ARE OPEN TO THE PUBLIC AND SHALL BE 26 AVAILABLE FOR DISTRIBUTION TO THE PUBLIC IN ENGLISH, SPANISH AND ANY 27 OTHER LANGUAGES THAT THE COMMISSIONER DEEMS APPROPRIATE.

28 NOT LATER THAN NINETY DAYS FROM THE EFFECTIVE DATE OF THIS (I) 29 SECTION, THE COMMISSIONER SHALL ESTABLISH A POLICY OR PROCEDURE FOR OVERSEEING AND MONITORING THE DELIVERY OF SERVICES REQUIRED PURSUANT TO 30 THIS SECTION TO PERSONS WITH HIV INFECTIONS WHICH SHALL INCLUDE, BUT NOT 31 BE LIMITED TO, QUALITY ASSURANCE MEASUREMENTS. THE COMMISSIONER 32 SHALL 33 SUBMIT SUCH POLICIES OR PROCEDURES TO THE GOVERNOR, SPEAKER OF THE ASSEMBLY AND THE TEMPORARY PRESIDENT OF THE SENATE IN WRITING WITHIN TEN 34 DAYS FROM THE DATE SUCH POLICIES OR PROCEDURES ARE ESTABLISHED. 35

(J) BEGINNING ON SEPTEMBER FIRST, TWO THOUSAND SIXTEEN, AND ON THE 36 37 FIRST DAY OF EACH CALENDAR QUARTER THEREAFTER, THE COMMISSIONER SHALL 38 SUBMIT A WRITTEN REPORT TO THE GOVERNOR, SPEAKER OF THE ASSEMBLY, MINOR-39 ITY LEADER OF THE ASSEMBLY, THE TEMPORARY PRESIDENT OF THE SENATE, AND 40 THE MINORITY LEADER OF THE SENATE, PROVIDING THE FOLLOWING INFORMATION DISAGGREGATED ON BOTH A QUARTERLY AND ANNUALIZED BASIS: THE NUMBER OF 41 PERSONS WITH HIV INFECTION WHO REQUESTED THE BENEFITS AND SERVICES SET 42 43 FORTH IN PARAGRAPH (B) OF THIS SUBDIVISION AND ANY OTHER BENEFITS PROVIDED BY LDSS, DISAGGREGATED BY LDSS AND BY THE TYPE OF BENEFIT OR 44 45 SERVICE REQUESTED, AND THE AVERAGE LENGTH OF TIME REQUIRED TO PROCESS SUCH REQUESTS, DISAGGREGATED BY LDSS, AND THE TYPE OF BENEFIT OR SERVICE 46 47 REQUESTED; THE NUMBER OF PERSONS WITH HIV INFECTION WHO REQUESTED BENE-48 FITS AND SERVICED AND WERE DETERMINED TO BE INELIGIBLE FOR SUCH BENEFITS AND SERVICES, DISAGGREGATED BY LDSS, BY THE TYPE OF BENEFIT OR SERVICE 49 50 REQUESTED, AND BY THE REASON FOR SUCH DETERMINATIONS; THE NUMBER OF LDSS 51 STAFF, BY JOB TITLE, WHOSE DUTIES INCLUDE PROVIDING BENEFITS AND SERVICES OR ACCESS TO BENEFITS AND SERVICES PURSUANT TO THIS 52 SECTION, THE NUMBER OF RECIPIENTS, THE NUMBER OF CASES AND THE NUMBER OF REQUESTS 53 54 FOR ASSISTANCE, DISAGGREGATED BY LDSS; THE AVERAGE LENGTH OF TIME FROM 55 THE INITIAL REQUEST FOR BENEFITS AND SERVICES TO SUBMISSION OF A COMPLETE APPLICATION FOR SUCH BENEFITS AND SERVICES, THE AVERAGE LENGTH 56

FOR THE PURPOSES OF THIS SUBDIVISION, "FIELD 26 OFFICE" SHALL MEAN ANY OFFICE OF THE DEPARTMENT AΤ WHICH PERSONS INFECTED WITH HIV, WITH CLINICAL/SYMPTOMATIC HIV ILLNESS OR WITH AIDS 27 28 MAY ACCESS BENEFITS AND SERVICES.

(K) THERE SHALL BE AN ADVISORY BOARD TO ADVISE THE COMMISSIONER ON THE 29 30 PROVISION OF BENEFITS AND SERVICES AND ACCESS TO BENEFITS AND SERVICES TO PERSONS WITH HIV INFECTION AS REQUIRED BY THIS SECTION. THIS ADVISORY 31 32 BOARD SHALL CONSIST OF ELEVEN MEMBERS TO BE APPOINTED FOR TWO YEAR TERMS 33 AS FOLLOWS: TWO MEMBERS SHALL BE APPOINTED BY THE SPEAKER OF THE ASSEM-BLY, TWO MEMBER SHALL BE APPOINTED BY THE TEMPORARY PRESIDENT OF 34 THE SENATE, ONE MEMBER SHALL BE APPOINTED BY THE MINORITY LEADER OF THE 35 ASSEMBLY, ONE MEMBER SHALL BE APPOINTED BY THE MINORITY LEADER OF 36 THE 37 SENATE AND THE REMAINING FIVE MEMBERS SHALL BE APPOINTED BY THE GOVER-38 NOR. AT LEAST ONE OF THE APPOINTMENTS MADE BY THE SPEAKER OF THE ASSEM-BLY AND THE TEMPORARY PRESIDENT OF THE SENATE, AND AT LEAST THREE OF THE 39 40 APPOINTMENTS MADE BY THE GOVERNOR SHALL BE ELIGIBLE FOR BENEFITS AND SERVICES PURSUANT TO THIS SECTION. THE ADVISORY BOARD SHALL MEET 41 AT LEAST QUARTERLY AND MEMBERS SHALL SERVE WITHOUT COMPENSATION. SUCH ADVI-42 43 SORY BOARD MAY FORMULATE AND RECOMMEND TO THE COMMISSIONER A POLICY OR 44 PROCEDURE FOR OVERSEEING AND MONITORING THE DELIVERY OF SERVICES TO 45 PERSONS WITH HIV INFECTION WHICH MAY INCLUDE QUALITY ASSURANCE MEASURE-MENTS. SUCH ADVISORY BOARD SHALL SUBMIT SUCH RECOMMENDED POLICY OR 46 47 PROCEDURE TO THE SPEAKER OF THE ASSEMBLY AND THE TEMPORARY PRESIDENT OF 48 THE SENATE UPON SUBMISSION TO THE COMMISSIONER.

49 S 2. Subdivision 14 of section 131-a of the social services law, as 50 added by section 1 of part H of chapter 58 of the laws of 2014, is 51 amended to read as follows:

52 14. In determining the need for aid provided pursuant to public 53 assistance programs, each person living with [clinical/symptomatic] HIV 54 [illness or AIDS in social services districts with a population over 55 five million who is receiving services through such district's adminis-56 trative unit providing HIV/AIDS services, public assistance and earned 1 and/or unearned income,] INFECTION shall not be required to pay more 2 than thirty percent of his or her monthly earned and/or unearned income 3 toward the cost of rent that such person has a direct obligation to pay; 4 this provision shall not apply to room and board arrangements.

S 3. The commissioner of the office of temporary and disability assistance shall amend 18 N.Y.C.R.R. S 352.3(k) as follows: (a) to 5 6 7 require local departments of social services to provide emergency shel-8 ter allowances, upon request, to households composed of an applicant or recipient of public assistance who has been medically diagnosed with HIV 9 10 infection and any family members residing with such person; (b) to set 11 the amount of the maximum emergency shelter allowance available at the amount, from time to time, of the fair market rent (FMR) set by the 12 United States department of housing and urban development for the size 13 14 the eligible household and FMR area where the household is located, with 15 the allowance in no event to be greater than the actual monthly rent 16 due; and (c) pursuant to subsection 14 of section 131-a of the social services law, as amended in this act, to calculate the amount of the 17 18 emergency shelter allowance available to a person with HIV infection who has earned and/or unearned income up to 200 percent of the federal poverty guidelines as a function of actual total monthly rent due less 19 20 21 30 percent of the monthly earned and/or unearned income of the person 22 with HIV infection.

23 4. Notwithstanding section 153 of the social services law or any S 24 other inconsistent provision of law (a) for local departments of social 25 services with a population over five million, New York state shall reim-26 burse 50 percent of safety net assistance expenditures for emergency 27 shelter, transportation, or nutrition payments which the district deter-28 mines are necessary to establish or maintain independent living arrange-29 ments among persons with HIV infection and who are homeless or facing homelessness and for whom no viable and less costly alternative to hous-30 ing is available; provided, however, that funds appropriated herein may 31 32 only be used for such purposes if the cost of such allowances are not 33 eligible for reimbursement under medical assistance or other programs; (b) for local departments of social services with a population under 34 five million, New York state shall reimburse 80 percent of safety net 35 assistance expenditures for emergency shelter, transportation, or nutri-36 37 tion payments which the district determines are necessary to establish 38 or maintain independent living arrangements among persons with HIV infection and who are homeless or facing homelessness and for whom no 39 40 less costly alternative to housing is available; provided, viable and however, that funds appropriated herein may only be used for such 41 purposes if the cost of such allowances are not eligible for reimburse-42 43 ment under medical assistance or other programs; and (c) local depart-44 ments of social services safety net assistance expenditures for emergency shelter, transportation, or nutrition payments may be made in kind through the use or transfer of property. 45 46

47 S 5. This act shall take effect immediately.
