AN ACT to amend the vehicle and traffic law, in relation to compliance
with the national driver register

THE PEOPLE OF THE STATE OF NEW YORK, REPRESENTED IN SENATE AND ASSEM-
BLY, DO ENACT AS FOLLOWS:

1 Section 1. The vehicle and traffic law is amended by adding a new
2 section 504-a to read as follows:
3 S 504-A. COMPLIANCE WITH THE PROVISIONS OF THE NATIONAL DRIVER REGIS-
4 TER. 1. THE COMMISSIONER SHALL ISSUE, NO LATER THAN DECEMBER
5 THIRTY-FIRST, TWO THOUSAND FIFTEEN, TO ALL PERSONS WHO HAVE BEEN ISSUED
6 A DRIVER'S LICENSE PURSUANT TO THIS ARTICLE, A NEW DRIVER'S LICENSE
7 WHICH IS FULLY COMPLIANT WITH THE STATUTORY PROVISIONS OF CHAPTER 303 OF
8 TITLE 49 OF THE UNITED STATES CODE. THE DRIVER'S LICENSES ISSUED PURSU-
9 ANT TO THIS SUBDIVISION SHALL BE ISSUED AT NO ADDITIONAL COST TO ALL
10 SUCH LICENSEES. THE COMMISSIONER MAY PROMULGATE RULES OR REGULATIONS
11 CONSISTENT WITH THIS SECTION AS MAY BE NECESSARY TO ACQUIRE THE DOCUMEN-
12 TATION NEEDED TO COMPLY WITH THE NATIONAL DRIVER REGISTRY.
13 2. THE COMMISSIONER SHALL ISSUE, ON AND AFTER DECEMBER THIRTY-FIRST,
14 TWO THOUSAND FIFTEEN, TO ALL PERSONS WHO ARE ELIGIBLE TO RECEIVE A NEW
15 LICENSE OR RENEWAL THEREOF PURSUANT TO THIS ARTICLE, A DRIVER'S LICENSE
16 WHICH IS FULLY COMPLIANT WITH THE STATUTORY PROVISIONS, AND ANY REGU-
17 LATIONS PROMULGATED PURSUANT TO SUCH STATUTORY PROVISIONS, OF CHAPTER
18 303 OF TITLE 49 OF THE UNITED STATES CODE. THE DRIVER'S LICENSES AND
19 RENEWALS THEREOF ISSUED PURSUANT TO THIS SUBDIVISION SHALL BE ISSUED AT
20 NO ADDITIONAL COST TO ALL SUCH LICENSEES, OTHER THAN THE ISSUANCE AND
21 RENEWAL FEE AUTHORIZED BY THIS CHAPTER.
22 3. THE COMMISSIONER SHALL FURTHER MAKE A REVIEW OF ALL APPLICABLE
23 FEDERAL LAWS AND REGULATIONS CONCERNING THE ISSUANCE OF DRIVER'S
24 LICENSES AND VEHICLE REGISTRATIONS, AND SHALL ISSUE A REPORT, ON OR
25 BEFORE THE FIFTEENTH OF DECEMBER OF EACH YEAR, TO THE GOVERNOR, THE
