AN ACT to amend part C of chapter 60 of the laws of 2014, amending the social services law and other laws relating to eliminating prescriber prevails for brand name drugs with generic equivalents, in relation to the establishment of a developmental disability clinician advisory group by the commissioner of health

THE PEOPLE OF THE STATE OF NEW YORK, REPRESENTED IN SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

1 Section 1. Section 18 of part C of chapter 60 of the laws of 2014,
2 amending the social services law relating to eliminating prescriber
3 prevails for brand name drugs with generic equivalents, is amended to
4 read as follows:
5 S 18. The commissioner of health is authorized to establish a DEVELOP-
6 MENTAL disability clinician advisory group of experienced clinicians and
7 clinic administrators who have an understanding of the comprehensive
8 needs of people with DEVELOPMENTAL disabilities. Such group shall
9 provide the commissioner and the department of health with information
10 and data on the effect of policies, including proposed regulations or
11 statutes, and of fiscal proposals, including rate setting and appropri-
12 ations, on the delivery of supports and services for individuals with
13 DEVELOPMENTAL disabilities including but not limited to the role of
14 specialty services. SUCH GROUP SHALL CONSIST OF THE FOLLOWING PERSONS OR
15 THEIR DESIGNEES: THE COMMISSIONER OF THE OFFICE OF PEOPLE WITH DEVELOP-
16 MENTAL DISABILITIES, THE COMMISSIONER OF THE DEPARTMENT OF HEALTH, THREE
17 INDIVIDUALS APPOINTED BY THE GOVERNOR, TWO INDIVIDUALS EACH BY THE
18 TEMPORARY PRESIDENT OF THE SENATE AND BY THE SPEAKER OF THE ASSEMBLY.
19 THE MEMBERS OF THE GROUP SHALL BE APPOINTED FOR A TERM OF TWO YEARS AND
20 SHALL MEET AT LEAST THREE TIMES IN EACH FULL CALENDAR YEAR DURING THE
21 FIRST TWO YEARS AND ADDITIONALLY UPON THE REQUEST OF THE COMMISSIONER OF
22 THE DEPARTMENT OF HEALTH. THE MEMBERS OF THE GROUP SHALL RECEIVE NO
23 COMPENSATION FOR THEIR SERVICES AS MEMBERS, BUT EACH SHALL BE ALLOWED
