AN ACT to amend the highway law, in relation to the designation of the Rochester-Finger Lakes Craft Beverage Trail

THE PEOPLE OF THE STATE OF NEW YORK, REPRESENTED IN SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

1 Section 1. The highway law is amended by adding a new section 344-e to 2 read as follows:

S 344-E. PORTION OF STATE HIGHWAY SYSTEM TO BE DESIGNATED AS "ROCHESTER-FINGER LAKES CRAFT BEVERAGE TRAIL." L 252 FROM THE INTERSECTION WITH HIGHWAY 15A EASTWARD TO THE INTERSECTION WITH HIGHWAY 15, AND HIGHWAY 250 FROM THE INTERSECTION WITH HIGHWAY 31 SOUTHWARD TO THE INTERSECTION WITH HIGHWAY 96 SHALL BE DESIGNATED AND KNOWN AS THE "ROCHESTER-FINGER LAKES CRAFT BEVERAGE TRAIL."

- S 2. The commissioner of transportation is authorized to permit the installation and maintenance of signs on the state highway system as designated pursuant to section 344-e of the highway law, as added by section one of this act. However, to avoid confusion and to limit any possible disruption of commerce, the designation called for pursuant to this act shall be one of a ceremonial nature and the official names of such highways shall not be changed as a result of this act.
