AN ACT to amend the navigation law, in relation to the authorized reimbursement rate paid to governmental entities for local navigation enforcement expenditures

THE PEOPLE OF THE STATE OF NEW YORK, REPRESENTED IN SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

1 Section 1. Subdivision 3 of section 79-b of the navigation law, as
2 amended by section 1 of part D of chapter 109 of the laws of 2010, is
3 amended to read as follows:
4 3. The amount of state aid to be allocated to eligible governmental
5 entities pursuant to this article shall be determined by the commissioner as hereinafter provided. The commissioner shall determine the
6 percentage proportion which the authorized expenditures of each individual entity, not exceeding four hundred thousand dollars for each county
7 including municipalities therein, shall bear to the total authorized
8 expenditures of all entities. Such percentage proportion shall then be
9 applied against an amount equal to one-half of the total of the amount
10 received by the state in each preceding program year in vessel registration fees as provided in section twenty-two hundred fifty-one of the
11 vehicle and traffic law, less no more than thirty percent, subject to
12 appropriation, which may be used by the commissioner and the commissioner of motor vehicles for administrative costs of the program, including
13 training and equipment, and by the department of environmental conservation, the division of state police and other state agencies, subject to
14 the approval of the commissioner, for the purposes of this article, plus
15 the entire amount received pursuant to subdivision nine of section
16 forty-four of this chapter. The amount thus determined shall constitute
17 the maximum amount of state aid to which each such entity shall be entitled; provided, however, that no entity shall receive state aid in an
18 amount in excess of [fifty] SEVENTY-FIVE percent of its authorized
19 expenditures as approved by the commissioner for such program year. The
20 commissioner shall certify to the comptroller the amount thus determined

1 for each eligible local governmental entity as the amount of state aid
2 to be apportioned to such eligible local governmental entity. The allo-
3 cation of state aid to any county, town or village within the Lake
4 George park shall not be reduced because of the allocation of state aid
5 to the Lake George park commission. Of the remaining funds received by
6 the state for the registration of vessels as provided in section twen-
7 ty-two hundred fifty-one of the vehicle and traffic law, no less than
8 six percent shall be made available to the commissioner for the expenses
9 of the office in providing navigation law enforcement training and
10 administering the provisions of this section.

11 S 2. This act shall take effect immediately and shall be deemed to
12 have been in full force and effect on and after April 1, 2016.
