AN ACT to amend the education law, in relation to continuing education requirements for interior designer certification

THE PEOPLE OF THE STATE OF NEW YORK, REPRESENTED IN SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

Section 1. The education law is amended by adding a new section 8305-a
to read as follows:

3 S 8305-A. MANDATORY CONTINUING EDUCATION FOR INTERIOR DESIGNERS. 1. EACH LICENSED INTERIOR DESIGNER REQUIRED UNDER THIS ARTICLE TO 4 (A) REGISTER TRIENNIALLY WITH THE DEPARTMENT TO PRACTICE IN THE STATE 5 SHALL 6 COMPLY WITH THE PROVISIONS OF THE MANDATORY CONTINUING EDUCATION 7 REQUIREMENTS PRESCRIBED IN SUBDIVISION TWO OF THIS SECTION EXCEPT AS SET 8 FORTH IN PARAGRAPHS (B) AND (C) OF THIS SUBDIVISION. INTERIOR DESIGNERS 9 WHO DO NOT SATISFY THE MANDATORY CONTINUING EDUCATION REQUIREMENTS SHALL NOT PRACTICE UNTIL THEY HAVE MET SUCH REQUIREMENTS, AND HAVE BEEN ISSUED 10 REGISTRATION CERTIFICATE, EXCEPT THAT AN INTERIOR DESIGNER MAY PRAC-11 Α TICE WITHOUT HAVING MET SUCH REQUIREMENTS IF HE OR SHE IS 12 ISSUED A CONDITIONAL REGISTRATION CERTIFICATE PURSUANT TO SUBDIVISION THREE OF 13 14 THIS SECTION.

15 (B) IN ACCORD WITH THE INTENT OF THIS SECTION, ADJUSTMENT TO THE 16 MANDATORY CONTINUING EDUCATION REOUIREMENT MAY BE GRANTED BY THE DEPART-MENT FOR REASONS OF HEALTH CERTIFIED BY AN APPROPRIATE HEALTH CARE 17 PROFESSIONAL, FOR EXTENDED ACTIVE DUTY WITH THE ARMED FORCES 18 OF THE 19 UNITED STATES, OR FOR OTHER GOOD CAUSE ACCEPTABLE TO THE DEPARTMENT 20 WHICH MAY PREVENT COMPLIANCE.

21 (C) A LICENSED INTERIOR DESIGNER NOT ENGAGED IN PRACTICE AS DETERMINED 22 BY THE DEPARTMENT, SHALL BE EXEMPT FROM THE MANDATORY CONTINUING EDUCA-TION REQUIREMENT UPON THE FILING OF A STATEMENT WITH THE DEPARTMENT 23 DECLARING SUCH STATUS. ANY LICENSEE WHO RETURNS TO THE PRACTICE OF INTE-24 25 RIOR DESIGN DURING THE TRIENNIAL REGISTRATION PERIOD SHALL NOTIFY THE DEPARTMENT PRIOR TO THE REENTERING THE PROFESSION AND SHALL MEET SUCH 26 27 MANDATORY EDUCATION REQUIREMENTS AS SHALL BE PRESCRIBED BY REGULATIONS 28 OF THE COMMISSIONER.

1 (D) LICENSED INTERIOR DESIGNERS SHALL BE EXEMPT FROM THE MANDATORY 2 CONTINUING EDUCATION REQUIRED BY THIS SECTION FOR THE TRIENNIAL REGIS-3 TRATION PERIOD DURING WHICH THEY ARE FIRST LICENSED.

4 2. DURING EACH TRIENNIAL REGISTRATION PERIOD AN APPLICANT FOR REGIS-5 TRATION SHALL COMPLETE A MINIMUM OF TWENTY HOURS OF ACCEPTABLE CONTINU-ING EDUCATION, AS SPECIFIED IN SUBDIVISION FOUR OF THIS SECTION, 6 PROVIDED, HOWEVER, THAT A MINIMUM OF SIXTEEN HOURS OF SUCH CONTINUING 7 8 EDUCATION SHALL CONSIST OF COURSES IN THE STATE BUILDING CODE AND FIRE SAFETY CODE AND RELATED SUBJECTS. ANY INTERIOR DESIGNER WHOSE FIRST 9 REGISTRATION DATE FOLLOWING THE EFFECTIVE DATE OF THIS SECTION OCCURS 10 LESS THAN THREE YEARS FROM SUCH EFFECTIVE DATE, BUT ON OR AFTER JANUARY 11 FIRST, TWO THOUSAND SEVENTEEN, SHALL COMPLETE CONTINUING EDUCATION HOURS 12 ON A PRORATED BASIS AT THE RATE OF ONE HOUR PER MONTH FOR THE PERIOD 13 14 BEGINNING JANUARY FIRST, TWO THOUSAND SIXTEEN UP TO THE FIRST REGISTRA-TION DATE THEREAFTER. A LICENSEE WHO HAS NOT SATISFIED THE MANDATORY 15 CONTINUING EDUCATION REQUIREMENTS SHALL NOT BE ISSUED A TRIENNIAL REGIS-16 TRATION CERTIFICATE BY THE DEPARTMENT AND SHALL NOT PRACTICE UNLESS AND 17 UNTIL A CONDITIONAL REGISTRATION CERTIFICATE IS ISSUED AS PROVIDED FOR 18 19 IN SUBDIVISION THREE OF THIS SECTION. WITH THE EXCEPTION OF CONTINUING 20 EDUCATION HOURS TAKEN DURING THE REGISTRATION PERIOD IMMEDIATELY PRECED-21 ING THE EFFECTIVE DATE OF THIS SECTION, CONTINUING EDUCATION HOURS TAKEN DURING ONE TRIENNIUM MAY NOT BE TRANSFERRED TO A SUBSEQUENT TRIENNIUM. 22

3. THE DEPARTMENT, IN ITS DISCRETION, MAY ISSUE A CONDITIONAL REGISTRATION TO A LICENSEE WHO FAILS TO MEET THE CONTINUING EDUCATION 23 24 25 REQUIREMENTS ESTABLISHED IN SUBDIVISION TWO OF THIS SECTION BUT WHO AGREES TO MAKE UP ANY DEFICIENCIES AND COMPLETE ANY ADDITIONAL EDUCATION 26 WHICH THE DEPARTMENT MAY REQUIRE. THE FEE FOR SUCH A CONDITIONAL REGISTRATION SHALL BE THE SAME AS, AND IN ADDITION TO, THE FEE FOR THE TRIEN-27 28 NIAL REGISTRATION. THE DURATION OF SUCH CONDITIONAL REGISTRATION SHALL 29 BE DETERMINED BY THE DEPARTMENT BUT SHALL NOT EXCEED ONE YEAR. ANY 30 LICENSEE WHO IS NOTIFIED OF THE DENIAL OF REGISTRATION FOR FAILURE TO 31 32 SUBMIT EVIDENCE, SATISFACTORY TO THE DEPARTMENT, OF REQUIRED CONTINUING EDUCATION AND WHO PRACTICES INTERIOR DESIGN WITHOUT SUCH REGISTRATION, 33 SHALL BE SUBJECT TO DISCIPLINARY PROCEEDINGS PURSUANT TO SECTION SIXTY-34 35 FIVE HUNDRED TEN OF THIS TITLE.

4. AS USED IN SUBDIVISION TWO OF THIS SECTION, "ACCEPTABLE CONTINUING 36 EDUCATION" SHALL MEAN COURSES OF LEARNING AND OTHER ACTIVITIES WHICH 37 CONTRIBUTE TO THE PROFESSION OR PRACTICE OF INTERIOR DESIGN AND WHICH MEET THE REGULATIONS OF THE COMMISSIONER. THE DEPARTMENT MAY, IN ITS 38 39 40 DISCRETION AND AS NEEDED TO CONTRIBUTE TO THE HEALTH AND WELFARE OF THE PUBLIC, REQUIRE THE COMPLETION OF CONTINUING EDUCATION COURSES 41 IN SPECIFIC SUBJECTS. SUCH COURSES OF LEARNING MUST BE TAKEN FROM A SPONSOR 42 43 APPROVED BY THE DEPARTMENT, PURSUANT TO REGULATIONS OF THE COMMISSIONER. INTERIOR DESIGNERS SHALL MAINTAIN ADEQUATE DOCUMENTATION OF 44 5. 45 COMPLETION OF ACCEPTABLE CONTINUING EDUCATION AND SHALL PROVIDE SUCH

46 DOCUMENTATION AT THE REQUEST OF THE DEPARTMENT.
47 6. THE MANDATORY CONTINUING EDUCATION FEE SHALL BE THIRTY DOLLARS AND
48 SHALL BE PAYABLE ON OR BEFORE THE FIRST DAY OF EACH TRIENNIAL REGISTRA49 TION PERIOD, AND SHALL BE PAID IN ADDITION TO THE TRIENNIAL REGISTRATION
50 FEE REQUIRED BY PARAGRAPH (H) OF SUBDIVISION ONE OF SECTION EIGHTY-THREE
51 HUNDRED FIVE OF THIS ARTICLE.

52 S 2. This act shall take effect on the first of January next succeed-53 ing the date on which it shall have become a law.
