AN ACT to amend the penal law, in relation to assaults upon station cleaners and terminal cleaners

THE PEOPLE OF THE STATE OF NEW YORK, REPRESENTED IN SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

1 Section 1. Subdivision 11 of section 120.05 of the penal law, as
2 amended by chapter 487 of the laws of 2015, is amended to read as
3 follows:
4 11. With intent to cause physical injury to a train operator, ticket
5 inspector, conductor, signalperson, bus operator [or], station agent,
6 STATION CLEANER OR TERMINAL CLEANER employed by any transit agency,
7 authority or company, public or private, whose operation is authorized
8 by New York state or any of its political subdivisions, a city marshal,
9 a school crossing guard appointed pursuant to section two hundred
10 eight-a of the general municipal law, a traffic enforcement officer,
11 traffic enforcement agent, subdivision thirty-one of section 1.20 of the
12 criminal procedure law, sanitation enforcement agent, New York city
13 sanitation worker, registered nurse, licensed practical nurse, emergency
14 medical service paramedic, or emergency medical service technician, he
15 or she causes physical injury to such train operator, ticket inspector,
16 conductor, signalperson, bus operator [or], station agent, STATION
17 CLEANER OR TERMINAL CLEANER, city marshal, school crossing guard
18 appointed pursuant to section two hundred eight-a of the general municipi-
19 pal law, traffic enforcement officer, traffic enforcement agent, prose-
20 cutor as defined in subdivision thirty-one of section 1.20 of the crimi-
21 nal procedure law, registered nurse, licensed practical nurse,
22 sanitation enforcement agent, New York city sanitation worker, emergency
23 medical service paramedic, or emergency medical service technician,
24 while such employee is performing an assigned duty on, or directly
25 related to, the operation of a train or bus, INCLUDING THE CLEANING OF A
26 TRAIN OR BUS STATION OR TERMINAL, or such city marshal, school crossing
27 guard, traffic enforcement officer, traffic enforcement agent, prosecu-
28 tor as defined in subdivision thirty-one of section 1.20 of the criminal

38 paramedic, or emergency medical service technician is performing an
39 assigned duty.

40 S 3. This act shall take effect on the first of November next succeed-
41 ing the date upon which it shall have become a law; provided, however,
42 if chapter 472 of the laws of 2015 shall not have taken effect on or
43 before such date then section two of this act shall take effect on the
44 same date and in the same manner as such chapter of the laws of 2015,
45 takes effect.
