- AN ACT to amend the administrative code of the city of New York, in relation to enacting the traffic safety compliance act relative to requests for and study of implementation of traffic control devices in the city

PEOPLE OF THE STATE OF NEW YORK, REPRESENTED IN SENATE AND ASSEM-THE BLY, DO ENACT AS FOLLOWS:

Section 1. This act shall be known and may be cited as the "traffic safety compliance act".

3 S 2. Chapter 1 of title 19 of the administrative code of the city of 4 New York is amended by adding a new subchapter 4 to read as follows: SUBCHAPTER 4

TRAFFIC SAFETY COMPLIANCE ACT

7 TRAFFIC CONTROL DEVICE STUDY AND REPORT. S 19-192 1. WITHIN THREE MONTHS OF RECEIVING A REQUEST TO IMPLEMENT A TRAFFIC CONTROL DEVICE, THE 8 9 PERFORM AN ENGINEERING STUDY OR INTERSECTION CONTROL DEPARTMENT SHALL 10 STUDY PURSUANT TO THE REOUIREMENTS OF THE NATIONAL MANUAL ON UNIFORM 11 TRAFFIC CONTROL DEVICES (HEREINAFTER REFERRED TO IN THIS SECTION AS "MUTCD"), PROMULGATED BY THE FEDERAL HIGHWAY ADMINISTRATION PURSUANT 12 ΤO SUBPART F OF PART 655 OF TITLE 23 OF THE CODE OF FEDERAL REGULATIONS. 13

2. UPON COMPLETION OF SUCH STUDY, THE DEPARTMENT SHALL PREPARE A WRIT-14 15 TENREPORT DETAILING THE ANALYSES DONE DURING THE STUDY, INCLUDING AN EXPLANATION OF THE ANALYSIS OF CRITERIA OR WARRANTS CONSIDERED 16 PURSUANT TO THE MUTCD. IF A SPECIFIC TRAFFIC CONTROL DEVICE LOCATION IS DEEMED TO 17 OF THE CRITERIA OR WARRANTS CONSIDERED, THE HAVE FAILED TO MEET 18 ANY 19 WRITTEN REPORT SHALL PROVIDE A DETAILED EXPLANATION OF THE REASONS 20 THEREFORE.

1 3. A COPY OF THE DEPARTMENT'S REPORT SHALL BE PROVIDED TO THE PARTY OR 2 PARTIES THAT REQUESTED IMPLEMENTATION OF THE TRAFFIC CONTROL DEVICE AND 3 SHALL BE AVAILABLE TO THE PUBLIC WITHOUT COST AT THE OFFICE OF THE 4 DEPARTMENT.

5 4. IF IN RESPONSE TO A REQUEST AND AFTER COMPLETION OF THE STUDY AND 6 REPORT REQUIRED BY THIS SECTION, THE DEPARTMENT DETERMINES THAT NO TRAF-FIC CONTROL DEVICE IS WARRANTED, THE PARTY OR PARTIES THAT REQUESTED 7 8 IMPLEMENTATION OF THE TRAFFIC CONTROL DEVICE SHALL BE ENTITLED TO APPLY TO THE COMMISSIONER FOR A REVIEW OF THE FINDINGS WITHIN SIXTY 9 DAYS OF 10 DATE OF NOTIFICATION. THE APPEALING PARTY OR PARTIES SHALL BE ENTI-THE TLED TO SUBMIT NEW DATA WITH THE APPEAL, WHICH NEW DATA MUST BE CONSID-11 ERED BY THE DEPARTMENT AND ADDRESSED IN A SUPPLEMENTARY REPORT. IF AFTER 12 CONSIDERATION OF ANY NEW DATA, THE DEPARTMENT STILL DETERMINES THAT NO 13 14 TRAFFIC CONTROL DEVICE IS WARRANTED, THE COMMISSIONER SHALL REFER THE 15 MATTER TO AN INDEPENDENT ADVISORY BOARD TO REVIEW THE DEPARTMENT'S FIND-INGS. A COPY OF THE ADVISORY BOARD'S RECOMMENDATIONS SHALL BE PROMPTLY 16 17 FORWARDED TO THE PARTY OR PARTIES AND TO THE COMMISSIONER. IF THE ADVI-SORY BOARD'S RECOMMENDATION IS REJECTED BY THE COMMISSIONER, WHOLLY OR 18 IN PART, THE COMMISSIONER SHALL STATE HIS OR HER REASONS FOR SUCH 19 20 REJECTION IN WRITING.

21 5. THE ADVISORY BOARD SHALL CONSIST OF FIVE MEMBERS. THE MEMBERSHIP OF 22 THE BOARD SHALL CONSIST OF THE DEPUTY MAYOR FOR PUBLIC SAFETY OR HIS OR HER ASSIGNEE, THE POLICE COMMISSIONER OR HIS OR HER ASSIGNEE, ONE PERSON 23 24 APPOINTED BY THE COMMISSIONER AND TWO RESIDENTS OF THE CITY APPOINTED BY 25 THE NEW YORK CITY COUNCIL. EACH OF THE MEMBERS OF THE ADVISORY BOARD 26 SHALL SERVE DURING THE TERM OF THEIR RESPECTIVE OFFICES OR, IN THE CASE OF AN ASSIGNEE OF SUCH AN OFFICER AND THE MEMBER APPOINTED BY THE 27 28 COMMISSIONER, AT THE PLEASURE OF SUCH OFFICER AND THE COMMISSIONER OR, 29 IN THE CASE OF AN ASSIGNEE OF THE NEW YORK CITY COUNCIL, FOR A PERIOD OF FOUR YEARS, RESPECTIVELY. NO MEMBER OF THE ADVISORY BOARD SHALL BE 30 DISQUALIFIED FROM HOLDING ANY OTHER PUBLIC OFFICE, NOR SHALL EMPLOYMENT 31 32 BE FORFEITED BY REASON OF THE MEMBER'S APPOINTMENT HEREUNDER, NOTWITH-33 STANDING THE PROVISIONS OF ANY GENERAL, SPECIAL OR LOCAL LAW, ORDINANCE, COUNTY OR CITY CHARTER. ALL MEMBERS OF THE ADVISORY BOARD SHALL RECEIVE 34 35 ACTUAL AND NECESSARY EXPENSES INCURRED IN THE PERFORMANCE OF THEIR 36 DUTIES.

6. AFTER COMPLETING A STUDY PURSUANT TO THIS SECTION, THE DEPARTMENT SHALL NOT BE REQUIRED TO COMPLETE ANOTHER STUDY AT THE SAME LOCATION FOR TWELVE MONTHS FOLLOWING SUCH STUDY, UNLESS IT IS DETERMINED BY THE DEPARTMENT THAT TRAFFIC CONDITIONS AT THE LOCATION HAVE CHANGED SIGNIF-ICANTLY SINCE THE COMPLETION OF SUCH STUDY.

S 19-193 COLLECTION OF ACCIDENT DATA. IN PERFORMING A STUDY REQUIRED 42 43 SECTION 19-192 OF THIS SUBCHAPTER, THE DEPARTMENT SHALL COLLECT AND ΒY 44 CONSIDER ACCIDENT DATA. IN ADDITION TO INFORMATION RETRIEVED FROM THE 45 STATE POLICE DEPARTMENT ACCIDENT INDEX SYSTEM AND INDIVIDUAL ACCIDENT REPORTS, SUCH ACCIDENT DATA SHALL INCLUDE, BUT SHALL NOT BE LIMITED TO: 46 47 1. REPORTS OF ACCIDENTS CONTAINED IN AFFIDAVITS SIGNED BY MEMBERS OF 48 THE PUBLIC. A PERSON MAKING A FALSE STATEMENT OR PROVIDING FALSE INFOR-49 MATION OF FALSE TESTIMONY IN A REPORT UNDER THIS SECTION SHALL BE 50 SUBJECT TO CRIMINAL PROSECUTION PURSUANT TO ARTICLE ONE HUNDRED SEVEN-51 TY-FIVE OR ARTICLE TWO HUNDRED TEN OF THE PENAL LAW.

52 2. TRAFFIC ACCIDENT DATA COLLECTED BY THE STATE DEPARTMENT OF FINAN-53 CIAL SERVICES AS A RESULT OF AUTOMOBILE INSURANCE CLAIMS RELATING TO 54 TRAFFIC ACCIDENTS. SUCH DATA, WHICH RELATES TO TRAFFIC ACCIDENTS OCCUR-55 RING WITHIN THE CITY, SHALL BE PROVIDED BY THE STATE DEPARTMENT OF 1 FINANCIAL SERVICES, WITH SPECIFIC INFORMATION IDENTIFYING THE LOCATION 2 OF REPORTED ACCIDENTS.

3 S 3. This act shall take effect on the one hundred eightieth day after 4 it shall have become a law.
