AN ACT to amend the environmental conservation law and the state finance
law, in relation to the regional land banks for projects on state land
in the forest preserve

The People of the State of New York, represented in Senate and Assem-
bly, do enact as follows:

1 Section 1. The environmental conservation law is amended by adding a
2 new section 9-0309 to read as follows:

3 § 9-0309. Use of certain state lands in forest preserve counties for
4 public utilities and regional land banks for projects on
5 state lands.

6 1. Definitions. For purposes of this section:

7 a. "Environmental infrastructure" means fire hydrants, fire
8 suppression lines and stormwater management structures.

9 b. "Highway" means a town highway, as defined in paragraph five of
10 section three of the highway law, in existence on January first, two
11 thousand fifteen and which is listed on the local highway inventory
12 maintained by the department of transportation, or a state highway, as
13 defined in subdivisions one, two and three of section three of the high-
14 way law, or a county road, as defined in subdivision four of section
15 three of the highway law.

16 c. "Project sponsor" means a town, a county, a public utility company,
17 a public water supplier or, for purposes of a bicycle path, the depart-
18 ment of transportation.

19 d. "Public utility company" shall have the same meaning as such term
20 is defined in section two of the public service law, and for purposes of
21 public utility line projects, as defined in subparagraph four of para-
22 graph e of this subdivision, shall include a public water supplier, a
23 town or a county.

24 e. "Public utility line" means:

1 (1) a line that conveys, transports or distributes steam or electric-
2 ity for light, heat or power;

3 (2) a communication line, including a telephone or telegraph line;

4 (3) broadband, including coaxial cable, optical cable, optical fiber
5 and twisted pair; or

6 (4) a water line, sewer line and water system for domestic, commercial
7 or public uses.

8 Public utility line shall include all appurtenant facilities, includ-
9 ing poles and conduits, necessary to support such line.

10 f. "Public water supplier" means a county or town improvement district
11 established to provide public water supply or any public benefit corpo-
12 ration or public authority established pursuant to state law or any
13 agency of the state or the city of New York which is empowered to
14 construct and operate a municipal water management facility, as defined
15 in section twelve hundred eighty-one of the public authorities law.

16 g. "State lands" means lands owned by the state in forest preserve
17 counties that are under the jurisdiction of the department.

18 h. "Stormwater management structure" means devices which are engi-
19 neered and constructed to provide storage and treatment of stormwater
20 runoff, including ponds, wetlands, open channels, infiltration practices
21 and filtering practices.

22 i. "Water supply projects" means drinking water wells and necessary
23 appurtenances thereto.

24 j. "Width of a highway" means the entire driving surface of the high-
25 way, plus the width of the cleared, regularly maintained area adjacent
26 to the driving surface, or thirty feet from the center line of a two
27 lane highway or thirty feet from the middle of the passing lane nearest
28 the shoulder of a four lane highway, whichever is less, except for on
29 the state highway system where determined otherwise by the department of
30 transportation.

31 2. A public utility line may be buried or co-located by a municipality
32 or a public utility company within the width of a highway where the
33 highway traverses state lands, subject to the approval by the department
34 in the form of a consent to occupy and any required authorization from
35 the department of transportation to ensure compliance with state and
36 federal law, rules and regulations. Essential above grade infrastructure
37 directly related to and necessary for such buried or co-located public
38 utility lines may be located within the width of such highways.

39 a. Prior to department review and approval, a proposal to bury or
40 co-locate a new utility line pursuant to this section must receive
41 approval by resolution of the town board or boards of the town or towns
42 in which the utility line is proposed.

43 b. If the proposed utility line will utilize a town or county highway,
44 the applicant shall provide the department with a certification from the
45 town or county respectively that the area where the utility line will be
46 placed is beneath the driving surface or in the cleared, regularly main-
47 tained area adjacent to the driving surface.

48 c. No compensation shall be required to be provided to the state for
49 approval to bury or co-locate a utility line in the width of a highway,
50 except as may be required by the highway law, the transportation corpo-
51 rations law, or any other state or federal law, rule or regulation.

52 d. The utility line owner shall submit an application for a consent to
53 occupy and survey map delineating the land to be used for the public
54 utility purposes, prepared to standards of the department.

55 3. A bicycle path may be constructed and maintained by a project spon-
56 sor within the width of a highway that traverses state lands, subject to

1 approval by the department in the form of a consent to occupy and any
2 required authorization from the department of transportation to ensure
3 compliance with state and federal law, rules and regulations. The
4 project proponent shall submit a survey map, prepared to standards of
5 the department, of the lands where the bicycle path will be constructed.

6 4. a. There is hereby created an Adirondack regional land bank and a
7 Catskill regional land bank. The Adirondack regional land bank shall be
8 five hundred acres of state lands which shall be available in the coun-
9 ties of Clinton, Essex, Franklin, Fulton, Hamilton, Herkimer, Lewis,
10 Oneida, Saratoga, Saint Lawrence, Warren and Washington. The Catskill
11 regional land bank shall be two hundred fifty acres of state lands which
12 shall be available in the counties of Delaware, Greene, Sullivan and
13 Ulster.

14 b. Subject to review and approval by the department and any required
15 authorization from the department of transportation to ensure compliance
16 with state and federal law, rules and regulations, a project sponsor may
17 apply to use available acreage from a regional land bank for the follow-
18 ing:

19 (1) environmental infrastructure located within one hundred feet of a
20 highway;

21 (2) to relocate, reconstruct and maintain existing town and county
22 highways for the purpose of eliminating the hazards of dangerous curves
23 and grades and to address drainage problems on such highways provided
24 that no single relocated portion of a highway may be longer than one-
25 half mile in length on state lands without prior approval by the legis-
26 lature and provided further that no single relocated portion of a high-
27 way may be longer than one mile in length;

28 (3) construction, reconstruction, relocation or improvement of a
29 bridge, or bridge infrastructure;

30 (4) the construction and maintenance of a bicycle path;

31 (5) installation of any public utility lines and associated infras-
32 tructure located within one hundred feet of a highway; and

33 (6) water supply projects located within five hundred feet of a high-
34 way, if it is necessary to comply with a specific directive to address
35 public health or environmental impacts.

36 c. An application for a proposal shall include a survey map, prepared
37 to the standards of the department, a narrative about the project, a
38 justification, and estimates of needed acreage. The department shall
39 hold a non-adjudicatory public hearing on the project, at which the
40 public shall be given an opportunity to be heard. Notice of any such
41 hearing and public comment shall be provided thirty calendar days in
42 advance and shall be published in the state register, the environmental
43 notice bulletin and in a newspaper having general circulation in the
44 county where the forest preserve lands in question are located.

45 d. Acreage from a regional land bank may be utilized for a project
46 authorized by this subdivision only when the department has determined:
47 there is no feasible alternative on land not owned by the state; the
48 project will minimize environmental impacts to the maximum extent prac-
49 ticable; and the proposal will not adversely impact lands with recog-
50 nized critical environmental or recreational value, as determined by the
51 department based on a resource inventory and assessment.

52 Proposals for use of land from a land bank shall be subject to public
53 review and comment.

54 e. No individual project shall be permitted to utilize more than five
55 acres from a land bank. No more than ten acres from a land bank may be
56 utilized by any individual town without prior approval from the legisla-

1 ture. No more than fifteen acres from a land bank may be utilized by any
2 individual county without prior approval from the legislature.

3 f. The department shall conduct appraisals, consistent with standards
4 developed by the department and paid for by the project sponsor, to
5 determine the fair market value of the state land which is proposed to
6 be used.

7 g. No land from a land bank shall be allocated to an eligible project
8 unless the state receives a payment from the project proponent equal to
9 the value of the state land to be utilized, or, for public utility
10 projects, in accordance with methods determined by the department. Any
11 funds received shall be deposited in the forest preserve expansion fund,
12 established pursuant to section ninety-seven-e of the state finance law,
13 and only be used to acquire lands as an addition to the forest preserve.
14 Funds received for the use of a regional land bank shall be used to
15 acquire lands within the same region.

16 h. After a hearing and opportunity to be heard, if the commissioner
17 determines that a project sponsor is utilizing land for a purpose other
18 than as authorized by the department, the commissioner may require
19 removal of any improvements to the land and restoration of the land to a
20 natural, vegetative state.

21 6. The department shall provide an opportunity for public review and
22 comment on all applications for projects pursuant to subdivisions two,
23 three, four and five of this section.

24 7. State lands used for projects authorized by paragraph b of subdivi-
25 sion five of this section shall be conveyed, or an easement granted for
26 public utility projects, to the project sponsor with a deed restriction
27 specifying that the land shall only be used for the purpose authorized
28 by the department and shall not be transferred to any entity for a
29 different private or commercial purpose. Such lands shall revert to the
30 state when they shall cease to be used for the purposes authorized by
31 this section.

32 8. Prior to allowing any project sponsor to use land from a land bank
33 for an eligible project, as authorized by subdivision five of this
34 section, the state shall acquire no less than seven hundred fifty acres,
35 which shall include at least five hundred acres in the Adirondack park
36 and at least two hundred fifty acres in the Catskill park, which shall
37 be added to the forest preserve and shall be classified as wilderness.

38 9. The provisions of subdivisions one and five of section 9-0303 of
39 this title shall not apply to activities authorized pursuant to this
40 section.

41 10. Nothing in this section shall affect the application of state
42 environmental quality review pursuant to article eight of this chapter
43 or the jurisdiction of the Adirondack park agency in accordance with
44 article twenty-seven of the executive law, provided that no such project
45 shall be subject to the Adirondack park state land master plan developed
46 pursuant to section eight hundred sixteen of the executive law or the
47 Catskill park state land master plan; provided, however, that applicable
48 provisions of a state land master plan shall apply to the real property
49 interests retained by the state in any land subject to an easement for a
50 utility line pursuant to this section.

51 11. The department is authorized to promulgate such rules and regu-
52 lations as may be necessary to implement and administer the provisions
53 of this section.

54 12. The department shall maintain an inventory of all fee and consent
55 to occupy parcel acreages and survey maps subject to this section.

1 13. The provisions of this section shall be severable and if any
2 portion thereof or the applicability thereof to any person or circum-
3 stances shall be held invalid, the remainder of this title and the
4 application thereof shall not be affected thereby.

5 § 2. Section 97-e of the state finance law, as amended by chapter 637
6 of the laws of 1960, is amended to read as follows:

7 § 97-e. Forest preserve expansion fund. 1. There is hereby established
8 in the state treasury a special fund, to be known as the forest preserve
9 expansion fund, which shall consist of and into which shall be paid all
10 moneys derived from the sale of certain forest preserve lands specified
11 in section twenty-four of the public lands law, moneys received for a
12 regional land bank transaction pursuant to section 9-0309 of the envi-
13 ronmental conservation law and such other moneys as may be paid into
14 said fund pursuant to law. The moneys in such fund shall be expended
15 only for the acquisition of additional lands for the practice of forest
16 or wildlife conservation in forest preserve counties pursuant to section
17 9-0309 of the environmental conservation law for the forest preserve
18 within either the Adirondack or Catskill park as now fixed by law. Upon
19 appropriation by the legislature, the [~~conservation~~] department of envi-
20 ronmental conservation may use such moneys or any portion thereof for
21 the acquisition of such additional lands subject to the approval of
22 title thereto by the attorney general. All payments from such fund shall
23 be made by the department of taxation and finance after audit by and
24 upon warrant of the comptroller, on vouchers approved by the [~~conserva-~~
25 ~~tion~~] commissioner of environmental conservation.

26 2. The [~~conservation~~] commissioner of environmental conservation is
27 authorized to accept, in the name of the people of the state of New
28 York, any gift or bequest of moneys to be paid into such forest preserve
29 expansion fund and to be expended and disbursed as provided in subdivi-
30 sion one of this section.

31 § 3. This act shall take effect on the same date and in the same
32 manner as a "CONCURRENT RESOLUTION OF THE SENATE AND ASSEMBLY proposing
33 an amendment to article 14 of the constitution, in relation to allowing
34 public utility lines and bicycle paths on certain state lands in the
35 forest preserve and establishing a forest preserve land bank for public
36 projects" takes effect, in accordance with section 1 of article 19 of
37 the constitution.
