**WHEREAS**, In 1986, Nadine Whitted was promoted to the esteemed role of Community Board 4 District Manager, a position from which she officially retired in 2016; and

**WHEREAS**, Throughout her career, Nadine Whitted served the residents of Community Board 4 with intelligence and caring dedication, continuously striving to effectively fulfill the duties of her position; and
