AN ACT to amend the alcoholic beverage control law, in relation to licensing restrictions for manufacturers and wholesalers of alcoholic beverages on licensees who sell at retail for on-premises consumption; and to repeal certain provisions of such law relating thereto; and providing for the repeal of certain provisions upon the expiration thereof

The People of the State of New York, represented in Senate and Assembly, do enact as follows:

Section 1. Subparagraph (ii) of paragraph (a) of subdivision 1 of section 101 of the alcoholic beverage control law is REPEALED and a new subparagraph (ii) is added to read as follows:

(ii) (A) all that tract or parcel of land situate in the City of Canandaigua, County of Ontario, State of New York, all as shown on a map entitled "Meridian Automotive Systems Subdivision Plan", prepared by Costich Engineering, P.C., having drawn number 3203-01, last dated 8/4/2003, and is to be filed in the Ontario County Clerk's Office and being more particularly bounded and described as follows:

15 distance of fourteen and four-tenths feet to a point; thence south
16 fifteen degrees thirty-eight minutes and forty seconds east a distance
17 of four hundred forty-six and eighty-seven hundredths feet to a point;
18 thence south twenty-eight degrees thirty-seven minutes and fifty seconds
19 east a distance of one hundred thirteen and eighty-four hundredths feet
20 to a point; thence south eighty-five degrees and forty-seven minutes
21 east a distance of forty-seven and sixty-one hundredths feet to an iron
22 pin; thence on the same course a distance of three hundred and sixty-
23 five feet to an iron pin; thence north seventeen degrees twenty-one
24 minutes and ten seconds east a distance of four hundred fifty-seven and
25 thirty-two hundredths feet to an iron pin; thence north nineteen degrees
26 and thirty minutes west a distance of two hundred and forty-eight feet
27 to a point; thence north sixty-nine degrees and fifty-four minutes east
28 a distance of two hundred eighty-four and twenty-six hundredths feet to
29 a point; thence north nineteen degrees and thirty minutes west a
30 distance of sixty feet to the point and place of beginning, provided
31 that such facility maintains not less than seventy-five rooms and suites
32 for overnight lodging.

33 § 5. This act shall take effect immediately; provided, however, that
34 upon the sale or transfer of the parcels detailed in clause (C) of
35 subparagraph (ii) of paragraph (a) of subdivision 1 of section 101 of
36 the alcoholic beverage control law, such clause shall expire and be
37 deemed repealed unless the licensee immediately obtains a leasehold upon
38 such sale or transfer of such parcel as part of the sale or transfer. If
39 the licensee obtains such a leasehold, the clause pertaining to such
40 parcel shall expire and be deemed repealed upon the end or termination
41 of such lease. The state liquor authority shall notify the legislative
42 bill drafting commission upon notification by the licensee of the sale,
43 transfer or termination of the leasehold, or non-renewal of the lease-
44 hold of the parcel detailed in clause (C) of subparagraph (ii) of para-
45 graph (a) of subdivision 1 of section 101 of the alcoholic beverage law
46 in order that the commission may maintain an accurate and timely effec-
47 tive data base of the official text of the laws of the state of New York
48 in furtherance of effectuating the provisions of section 44 of the
49 legislative law and section 70-b of the public officers law.
