**WHEREAS,** Upon his return home, Roy Tschudy joined the NYPD in 1974 as a Police Officer and served in that capacity until 1997; while there, he attended the New York City Police Academy, becoming a certified NYPD field training officer in 1993, and two years later becoming certified by New York State; and

**WHEREAS,** In this esteemed position, Roy Tschudy has received numerous high honors including two Meritorious Medal awards, one Distinguished Duty Medal Award, and New York City P.B.A Cop of the Month Award; he is also a multiple time recipient of the New York City Public Service Award for Valor; and

**WHEREAS,** Furthermore, Roy Tschudy has worked in conjunction with Vietnam Veterans of America, Chapter 333, Rockland County, which provides services for Veterans in the area; and

**WHEREAS,** Having exhibited unparalleled patriotism both at home and abroad, Roy Tschudy has demonstrated his love for this country and merits forevermore, the highest respect of his State and Nation; and

**WHEREAS,** Our Nation's veterans deserve to be recognized, commended
