AN ACT to amend the alcoholic beverage control law, in relation to notification requirements for a seven day license to sell liquor at retail for consumption off the premises

## The People of the State of New York, represented in Senate and Assembly, do enact as follows:

- Section 1. Subdivision 1 of section 110-a of the alcoholic beverage 2 control law, as added by chapter 77 of the laws of 1999, is amended to 3 read as follows:
- 4 1. Every person applying for a license to sell alcoholic beverages 5 pursuant to subdivision four of section fifty-one, or section fifty-6 five, sixty-three, sixty-four, sixty-four-a, sixty-four-c, eighty-one or eighty-one-a of this chapter shall publish notice thereof pursuant to subdivision two of this section. 8
- 9 § 2. Paragraphs (a), (b), (c) and (d) of subdivision 1 of section 10 110-b of the alcoholic beverage control law, paragraphs (a) and (b) as amended and paragraphs (c) and (d) as added by chapter 560 of the laws 11 of 2011, are amended to read as follows: 12
- 13 (a) for a license issued pursuant to section fifty-five, fifty-five-a, 14 <u>sixty-three</u>, sixty-four, sixty-four-a, sixty-four-b, sixty-four-c, sixty-four-d, eighty-one or eighty-one-a of this chapter;
- 16 (b) for a renewal under section one hundred nine of this [chapter] 17 <u>article</u> of a license issued pursuant to section fifty-five, 18 fifty-five-a, <u>sixty-three</u>, sixty-four, sixty-four-a, sixty-four-c,
- 19 sixty-four-d, eighty-one or eighty-one-a of this chapter if the premises
- 20 is located within the city of New York;

(c) for approval of an alteration under section ninety-nine-d of this 2 chapter if the premises is located within the city of New York and licensed pursuant to section fifty-five, fifty-five-a, sixty-three, sixty-four, sixty-four-a, sixty-four-c, sixty-four-d, eighty-one or eighty-one-a of this chapter; or

- (d) for approval of a substantial corporate change under section ninety-nine-d of this chapter if the premises is located within the city of New York and licensed pursuant to section fifty-five, fifty-five-a, sixty-three, sixty-four, sixty-four-a, sixty-four-d, 10 eighty-one or eighty-one-a of this chapter.
- § 3. This act shall take effect immediately.
