read once and referred to the Committee on Cities

AN ACT to authorize the city of New York to discontinue the use as parkland a portion of real property in the borough of Brooklyn and to transfer such lands to the metropolitan transportation authority, to enable the New York city transit authority to construct in such areas new permanent at-grade station improvements and pedestrian bridges

The People of the State of New York, represented in Senate and Assembly, do enact as follows:

1 Section 1. Subject to the provisions of this act, but notwithstanding  
2 any provision of law to the contrary, the city of New York is hereby  
3 authorized, upon such terms and conditions the city shall determine, to:  
4 (a) discontinue permanently the use as parklands the lands described in  
5 section three of this act, and transfer such lands to the metropolitan  
6 transportation authority, to enable the New York city transit authority  
7 to construct in such areas new permanent at-grade station improvements;  
8 (b) discontinue permanently the air rights over the parklands described  
9 in section four of this act, and transfer such air rights to the metro-  
10 politan transportation authority for pedestrian bridges between and  
11 among the L, J, Z, A and C subway lines; and (c) discontinue temporarily  
12 the use as parklands the areas described in section five of this act for  
13 construction staging areas.

14 § 2. The authorization provided in section one of this act shall be  
15 effective only upon the condition that at the time of the transfer of  
16 the lands and air rights described in sections three and four of this  
17 act, the city of New York dedicates as parkland the lands described in  
18 section six of this act provided that the city of New York has never  
19 used such lands for public open space or park purposes. In the event  
20 that such land to be dedicated is not equal to or greater than the fair  
21 market value of the park land to be discontinued, the city of New York  
22 shall dedicate the difference between the fair market value of the park  
23 land to be discontinued and the fair market value of the land to be  
24 dedicated towards the acquisition of new parklands or capital improve-

1 ments to existing parklands and recreational facilities within the  
2 borough of Brooklyn.

3 § 3. The lands hereby authorized by section one of this act to be  
4 discontinued permanently as parkland and transferred to the metropolitan  
5 transportation authority are located in the county of Kings, city and  
6 state of New York in a park known as the Callahan-Kelly Park, and are  
7 bounded and described as follows:

8 Area A: acquisition of property rights on Tax Lot 1 in Block 1546,  
9 Borough of Brooklyn:

10 Beginning at the Point of Commencement, (N=186378.8532,  
11 E=1009899.0749) (NAD83 / NAVD88) at the corner formed by the inter-  
12 section of the northerly line of Fulton Street, an eighty feet width  
13 right of way, and the easterly line of Eastern Parkway, a one-hundred-  
14 and ten-feet width right of way, running thence,

15 Easterly along the said northerly sideline of Fulton Street 883.90',  
16 along the same northerly sideline of Fulton Street to a point, thence,

17 On a line in a general northerly direction having an interior angle of  
18  $84^{\circ}14'59''$  with the previous course 72.29' to a point known as the Point  
19 of Beginning, thence,

20 1) On a line in a general westerly direction having an interior angle  
21 of  $89^{\circ}57'01''$  with the previous course 55.94' to a point, thence,

22 2) On a line in a general Northerly direction having an interior angle  
23 of  $79^{\circ}17'17''$  with the previous course 65.85' to a point, thence,

24 3) On a line in a general easterly direction having an interior angle  
25 of  $100^{\circ}47'48''$  with the previous course 23.82' to a point, thence,

26 4) On a line in a general northerly direction having an interior angle  
27 of  $270^{\circ}17'30''$  with the previous course 18.55' to a point, thence,

28 5) On a line in a general easterly direction having an interior angle  
29 of  $89^{\circ}14'48''$  with the previous course 112.13' to a point, thence,

30 6) On a line in a general southerly direction having an interior angle  
31 of  $70^{\circ}59'29''$  with the previous course 18.01' to a point, thence,

32 7) On a line in a general westerly direction having an interior angle  
33 of  $109^{\circ}20'10''$  with the previous course 45.81' to a point, thence,

34 8) On a line in a general southerly direction having an interior angle  
35 of  $270^{\circ}00'00''$  with the previous course 17.40' to a point, thence,

36 9) On a line in a general westerly direction having an interior angle  
37 of  $90^{\circ}00'00''$  with the previous course 40.29' to a point, thence,

38 10) On a line in a general southerly direction having an interior  
39 angle of  $270^{\circ}00'00''$  with the previous course 48.23' to the Point of  
40 Beginning.

41 Said parcel described above contains 5,836 square feet (0.13 acres) of  
42 land more or less.

43 Area B: acquisition of property rights on Tax Lot 1 in Block 1546,  
44 Borough of Brooklyn:

45 Beginning at the Point of Commencement, (N=186378.8532,  
46 E=1009899.0749) (NAD83 / NAVD88) at the corner formed by the inter-  
47 section of the northerly line of Fulton Street, an eighty feet width  
48 right of way, and the north-easterly line of Eastern Parkway, a one-hun-  
49 dred-and ten-feet width right of way, running thence,

50 Easterly along the said northerly line of Fulton Street 1011.31', to a  
51 point of curvature on the same northerly sideline of Fulton Street,  
52 thence,

53 Along the arc, having a curve to the left, a radius of 70 feet, delta  
54 of  $102^{\circ}54'18''$ , and an arc distance of 125.72 feet to the point of  
55 tangency along the westerly line of Van Sinderen Avenue, a one-hundred  
56 width right of way, thence,

1 Along the same westerly sideline of Van Sinderen Avenue in a general  
2 northerly direction, from the point of tangency 53.99' along the same  
3 westerly line of Van Sinderen Avenue, to a point, thence,

4 On a line in a general westerly direction having an interior angle of  
5  $97^{\circ}09'24''$  with the previous course 45.92' to the Point of Beginning,  
6 thence,

7 1) On a line in a general westerly direction having an interior angle  
8 of  $180^{\circ}00'00''$  with the previous course 38.50' to a point, thence,

9 2) On a line in a general northerly direction having an interior angle  
10 of  $90^{\circ}00'00''$  with the previous course 18.75' to a point, thence,

11 3) On a line in a general easterly direction having an interior angle  
12 of  $90^{\circ}00'00''$  with the previous course 0.90' to a point, thence,

13 4) On a line in a general northerly direction having an interior angle  
14 of  $250^{\circ}39'50''$  with the previous course 51.96' to a point, thence,

15 5) On a line in a general easterly direction having an interior angle  
16 of  $89^{\circ}54'43''$  with the previous course 13.21' to a point, thence,

17 6) On a line in a general northerly direction having an interior angle  
18 of  $270^{\circ}09'15''$  with the previous course 1.50' to a point, thence,

19 7) On a line in a general easterly direction having an interior angle  
20 of  $89^{\circ}42'05''$  with the previous course 19.98' to a point, thence,

21 8) On a line in a general southerly direction having an interior angle  
22 of  $116^{\circ}54'23''$  with the previous course 9.83' to a point, thence,

23 9) On a line in a general southerly direction having an interior angle  
24 of  $153^{\circ}20'13''$  with the previous course 10.30' to a point, thence,

25 10) On a line in a general easterly direction having an interior angle  
26 of  $285^{\circ}10'47''$  with the previous course 1.53' to a point, thence,

27 11) On a line in a general southerly direction having an interior  
28 angle of  $74^{\circ}53'38''$  with the previous course 40.81' to the Point of  
29 Beginning.

30 Said parcel described above contains 2,485 square feet (0.06 acres) of  
31 land more or less.

32 § 4. The area above certain limiting planes set forth below authorized  
33 to be discontinued permanently as parkland by section one of this act,  
34 and granted as easements to the metropolitan transportation authority is  
35 bounded and described as follows:

36 Area C: Acquisition of air rights on Tax Lot 1 in Block 1546, Borough  
37 of Brooklyn:

38 Beginning at the Point of Commencement, (N=186378.8532,  
39 E=1009899.0749) (NAD83 / NAVD 88) at the corner formed by the inter-  
40 section of the northerly sideline of Fulton Street, an eighty feet width  
41 right of way, and the easterly sideline of Eastern Parkway, a one-hun-  
42 dred- and ten-feet width right of way, running thence,

43 Along the easterly sideline of Eastern Parkway, a one-hundred- and  
44 ten-feet width right of way, in a general northeasterly direction 70.74'  
45 to a point in the same easterly sideline of Eastern Parkway and the  
46 southerly sideline of Truxton Street, a 70 feet width right of way,  
47 thence,

48 Along the southerly sideline of Truxton Street in a general easterly  
49 direction having an interior angle of  $142^{\circ}03'22''$  with the previous  
50 course 945.72' to the point to curvature along the same said southerly  
51 sideline of Truxton Street, thence,

52 Along the arc, having a curve to the right, a radius of 70 feet, delta  
53 of  $36^{\circ}53'27''$ , and an arc distance of 45.07', also described as having an  
54 interior angle of  $161^{\circ}33'16''$  with the previous course 44.30' chord  
55 length to the Point of Beginning in the same southerly sideline of Trux-  
56 ton Street, thence,

- 1) On a line in a general southerly direction having an interior angle of  $82^{\circ}10'13''$  with the previous course 60.33' to a point, thence,
- 2) On a line in a general easterly direction having an interior angle of  $90^{\circ}05'13''$  with the previous course 13.21' to a point, thence,
- 3) On a line in a general northerly direction having an interior angle of  $89^{\circ}50'45''$  with the previous course 56.52 to a point along a curve, thence,
- 4) Along an arc on the southerly sideline of Truxton Street having a curve to the left, a radius of 70 feet, a delta angle of  $11^{\circ}22'02''$  and an arc distance of 13.71', also described as having an interior angle of  $106^{\circ}17'35''$  with the previous course 13.69' chord length to the Point of Beginning.

The property rights described above begin at an elevation (NAVD 88) of 121.5 ± feet with no upper limit. The park ground is at an elevation of 86.5± feet.

Said parcel containing 773 square feet more or less.

Area D: acquisition of air rights on Tax Lot 1 in Block 1546, Borough of Brooklyn:

Beginning at the Point of Commencement, (N=186378.8532, E=1009899.0749) (NAD83 / NAVD 88) at the corner formed by the intersection of the northerly sideline of Fulton Street, an eighty feet width right of way, and the easterly sideline of Eastern Parkway, a one-hundred- and ten-feet width right of way, running thence,

Easterly along the said northerly line of Fulton Street 1011.31', to a point of curvature on the same northerly sideline of Fulton Street, thence,

Along the arc, having a curve to the left, a radius of 70 feet, delta of  $102^{\circ}54'18''$ , and an arc distance of 125.72 feet to the point of tangency along the westerly sideline of Van Sinderen, a one-hundred width right of way, thence,

On a line in a general northerly direction, from the point of tangency 111.19' along the same westerly sideline of Van Sinderen, to the Point of Beginning,

1) On a line in a general westerly direction having an interior angle of  $101^{\circ}43'05''$  with the previous course 24.87' to a point, thence,

2) On a line in a general southerly direction having an interior angle of  $78^{\circ}06'04''$  with the previous course 10.46' to a point, thence,

3) On a line in a general southerly direction having an interior angle of  $206^{\circ}39'47''$  with the previous course 10.30' to a point, thence,

4) On a line in a general easterly direction having an interior angle of  $74^{\circ}45'47''$  with the previous course 29.48' to a point along the westerly sideline on Van Sinderen Avenue, a one-hundred feet width right of way, thence,

5) On a line in general northerly direction having an interior angle of  $78^{\circ}45'18''$  with the previous course 20.38' to the Point of Beginning.

The property rights as described above begin at an elevation (NAVD 88) of 96.5± feet with no upper limit. The park ground is at an elevation of 86.5± feet.

Said parcel containing 522 square feet more or less.

§ 5. The lands hereby authorized to be discontinued temporarily as parklands by section one of this act and granted as temporary easements to serve as construction staging areas for the duration of construction are bounded and described as follows:

Area E: Temporary Construction Easement on Tax Lot 1 in Block 1546, Borough of Brooklyn:

1 Beginning at the Point of Commencement, (N=186378.8532,  
2 E=1009899.0749) (NAD83) at the corner formed by the intersection of the  
3 northerly sideline of Fulton Street, an eighty feet width right of way,  
4 and the easterly sideline of Eastern Parkway, a one-hundred- and ten-  
5 feet width right of way, running thence,

6 Easterly along the said northerly sideline of Fulton Street 883.90',  
7 to the Point of Beginning along the same northerly sideline of Fulton  
8 Street, thence,

9 1) On a line in a general northerly direction having an interior angle  
10 of 84°15'59" with the previous course 72.29' to a point, thence,

11 2) On a line in a general westerly direction having an interior angle  
12 of 89°57'02" with the previous course 55.94' to a point, thence,

13 3) On a line in a general northerly direction having an interior angle  
14 of 280°42'43" with the previous course 65.85' to a point, thence,

15 4) On a line in a general easterly direction having an interior angle  
16 of 259°12'12" with the previous course 23.82' to a point, thence,

17 5) On a line in a general northerly direction having an interior angle  
18 of 89°42'30" with the previous course 18.55' to a point, thence,

19 6) On a line in a general westerly direction having an interior angle  
20 of 90°45'12" with the previous course 42.04' to a point, thence,

21 7) On a line in a general southerly direction having an interior angle  
22 of 89°48'43" with the previous course 97.30' to a point, thence,

23 8) On a line in a general easterly direction having an interior angle  
24 of 90°00'11" with the previous course 7.38' to a point, thence,

25 9) On a line in a general southerly direction having an interior angle  
26 of 280°27'29" with the previous course 39.17' to a point, thence,

27 10) On a line in a general southerly direction having an interior  
28 angle of 169°22'25" with the previous course 13.72' to a point, thence,

29 11) On a line in a general easterly direction having an interior angle  
30 of 95°46'34" with the previous course 62.48' along the northerly line of  
31 Fulton Street to the Point of Beginning.

32 Said parcel containing 5,752 square feet (0.13 acres) of land more or  
33 less.

34 Area F: temporary construction easement on Tax Lot 1 in Block 1546,  
35 Borough of Brooklyn:

36 Beginning at the Point of Commencement, (N=186378.8532,  
37 E=1009899.0749) (NAD83) at the corner formed by the intersection of the  
38 northerly sideline of Fulton Street, an eighty feet width right of way,  
39 and the easterly sideline of Eastern Parkway, a one-hundred- and ten-  
40 feet width right of way, running thence,

41 North-easterly along the said easterly sideline of Eastern Parkway, a  
42 one-hundred- and ten-feet width right of way, 70.74' to a point in the  
43 same easterly sideline of Eastern Parkway and the Southerly sideline of  
44 Truxton Street, a 70 feet width right of way, thence,

45 Along the southerly line of Truxton Street in a general easterly  
46 direction having an interior angle of 142°03'22" with the previous  
47 course 932.30' along the same said southerly line of Truxton Street to  
48 the Point of Beginning, thence,

49 1) On a line in a general southerly direction having an interior angle  
50 of 63°43'34" with the previous course 101.74' to a point, thence,

51 2) On a line in a general easterly direction having an interior angle  
52 of 70°59'29" with the previous course 29.61' to a point, thence,

53 3) On a line in a general northerly direction having an interior angle  
54 of 109°00'31" with the previous course 53.82' to a point, thence,

55 4) On a line in a general easterly direction having an interior angle  
56 of 270°00'00" with the previous course 27.92' to a point, thence,

1 5) On a line in a general southerly direction having an interior angle  
2 of 270°00'00" with the previous course 10.07, to a point, thence,  
3 6) On a line in a general easterly direction having an interior angle  
4 of 90°05'17" with the previous course 13.21' to a point, thence,  
5 7) On a line in a general northerly direction having an interior angle  
6 of 89°50'45" with the previous course 1.50' to a point, thence,  
7 8) On a line in a general easterly direction having an interior angle

19 westerly sideline of Van Sinderen Avenue, a one-hundred feet width right  
20 of way, thence,  
21 14) Along the westerly sideline of Van Sinderen Avenue in a general  
22 northerly direction having an interior angle of 82°50'36" with the  
23 previous course 73.34' to the point of curvature along the same westerly  
24 sideline of Van Sinderen, now opened at one-hundred feet wide, thence,  
25 15) Along the arc, having a curve to the left, a radius of 70 feet,  
26 delta of 89°46'03", arc distance of 109.69' feet to the point of tangen-  
27 cy along the southerly sideline of Truxton Street, a seventy feet width  
28 right of way, thence,  
29 16) Along the southerly sideline of Truxton Street from the point of  
30 tangency in a general easterly direction 13.42' to the Point of Begin-  
31 ning.  
32 Said parcel containing 8,564 square feet (0.20 acres) of land more or  
33 less.  
34 § 6. The lands hereby authorized to be dedicated as parklands by the  
35 city of New York on the terms set forth in section two of this act are  
36 located in the county of Kings, city and state of New York and bounded  
37 and described as follows:  
38 Portion of Sackman Street abutting Tax Lot 1 in Block 1546, Borough of  
39 Brooklyn:  
40 Beginning at the Point of Commencement, (N=186378.8532,  
41 E=1009899.0749) (NAD83) at the corner formed by the intersection of the  
42 northerly line of Fulton Street, an eighty feet width right of way, and  
43 the north-easterly line of Eastern Parkway, a one-hundred- and ten-feet  
44 width right of way, running thence,  
45 Easterly along the said northerly sideline of Fulton Street 466.90' to  
46 the Point of Beginning on the same northerly sideline of Fulton Street,  
47 and the easterly sideline of Sackman Street, thence,  
48 1) Along the easterly sideline of Sackman Street in a general norther-  
49 ly direction having an interior angle of 74°27'51" with the previous  
50 course 124.23' to a point along the southerly sideline of Truxton Street  
51 a 70' width right of way, thence,  
52 2) Along the southerly sideline of Truxton Street in a general wester-  
53 ly direction having an interior angle of 92°50'53" with the previous  
54 course 80.10' to a point on the same southerly sideline of Truxton  
55 Street and the westerly sideline of Sackman street, thence,

1 3) Along the westerly sideline of Sackman Street in a general souther-  
2 ly direction having an interior angle of  $87^{\circ}09'07''$  with the previous  
3 course 127.97' to a point along the westerly sideline of Sackman Street  
4 and the northerly sideline of Fulton Street, thence,

5 4) Along the northerly sideline of Fulton Street in a general easterly  
6 direction having an interior angle of  $105^{\circ}32'08''$  with the previous  
7 course 83.03' to the Point of Beginning.

8 Said parcel containing 10,968 square feet (0.25 acres) of land more or  
9 less.

10 § 7. In the event that the city of New York received any fund-  
11 ing, support or assistance from the federal government for the  
12 purchase, maintenance or improvement of the park lands set forth in  
13 sections three, four and five of this act, the discontinuance and  
14 alienation of such parkland authorized by the provisions of this act  
15 shall not occur until the city of New York has complied with any federal  
16 requirements pertaining to the alienation or conversion of such park  
17 lands, including satisfying the secretary of the interior that the  
18 alienation or conversion complies with all conditions which the secre-  
19 tary of the interior deems necessary to assure the substitution of other  
20 lands shall be equivalent in fair market value and usefulness to the  
21 lands being alienated or converted.

22 § 8. Upon the completion of construction, the metropolitan transporta-  
23 tion authority shall, in agreement with the city of New York and in  
24 consultation with the local community board, restore the surface of the  
25 lands described in section five of this act and the lands shall other-  
26 wise continue to be used for park purposes.

27 § 9. This act shall take effect immediately.
