AN ACT to amend the vehicle and traffic law, in relation to imposing restrictions on the purchase, sale and possession of catalytic converters by vehicle dismantlers, salvage pools, mobile car crushers, itinerant vehicle collectors and scrap processors

The People of the State of New York, represented in Senate and Assembly, do enact as follows:

1	Section 1. Subdivision 15 of section 415-a of the vehicle and traffic
2	law is renumbered subdivision 16 and a new subdivision 15 is added to
3	read as follows:
4	15. Restrictions regarding catalytic converters. (a) No vehicle
5	dismantler, salvage pool, mobile car crusher, itinerant vehicle collec-
б	tor or scrap processor shall purchase, sell, take possession of or recy-
7	cle a used catalytic converter except as provided in this subdivision.
8	(b) As used in this subdivision:
9	(i) "catalytic converter" means a catalytic converter or other equip-
10	ment or feature constituting an operational element of a motor vehicle's
11	air pollution control system or mechanism required by federal or state
12	law or by any rules or regulations promulgated pursuant thereto, as
13	amended; and
14	(ii) "used catalytic converter" means a catalytic converter that was
15	previously installed in a vehicle and which has been removed from such
16	<u>vehicle in whole or in part.</u>
17	(c) No vehicle dismantler, salvage pool, mobile car crusher, itinerant
18	vehicle collector or scrap processor shall purchase or take possession
19	of, including for purposes of recycling or rebuilding, a used catalytic
20	converter from any person or entity other than a dealer registered
21	pursuant to section four hundred fifteen of this article, an insurance
22	company, a governmental agency, a person in whose name a certificate of

1	title or other ownership document has been issued for the vehicle from
2	which the catalytic converter was removed, a repair shop or a person
3	registered or certified or issued an identification number pursuant to
4	this section.
5	(d) No vehicle dismantler, salvage pool, mobile car crusher, itinerant
	vehicle collector or scrap processor shall sell a used catalytic
6	
7	converter that was acquired from any person or entity under circum-
8 9	stances other than as described in paragraph (c) of this subdivision.
	(e) (i) Each vehicle dismantler, salvage pool, mobile car crusher,
10	itinerant vehicle collector or scrap processor who purchases or takes
11	possession of, including for purposes of recycling or rebuilding, a used
12	catalytic converter shall record the purchase of the catalytic converter
13	indicating the date of purchase, the name of seller, the seller's
14	address or, in the case that the seller is an individual, the seller's
15	residence address by street, number, city, village or town, the seller's
16	driver's license number or information from a government issued photo-
17	graphic identification card, if any, or by such description as will
18	reasonably locate the seller, or, if the seller was a repair shop, the
19	repair shop's license number. Such record shall be preserved by the
20	vehicle dismantler, salvage pool, mobile car crusher, itinerant vehicle
21	collector or scrap processor for a period of three years. Such records
22	shall be available for inspection by the police department of the state
23	or of the municipality in which the vehicle dismantler, salvage pool,
24	mobile car crusher, itinerant vehicle collector or scrap processor is
25	located.
26	(ii) Each vehicle dismantler, salvage pool, mobile car crusher, itin-
27	erant vehicle collector or scrap processor shall cause the record
28	described in subparagraph (i) of this paragraph to be signed by the
29	seller or his agent. It shall be unlawful for any seller or agent to
30	refuse to furnish such information or to furnish incorrect or incomplete
31	information. The vehicle dismantler, salvage pool, mobile car crusher,
32	itinerant vehicle collector or scrap processor shall make and retain a
33	copy of the government issued photographic identification card used to
34	verify the identity of the person from whom the catalytic converter was
35	purchased or obtained and shall retain this copy in a separate book,
36	register or electronic archive for two years from the date of purchase.
37	Such records shall be available for inspection by the police department
38	of the state or of the municipality in which the vehicle dismantler,
39	salvage pool, mobile car crusher, itinerant vehicle collector or scrap
40	processor is located.
41	(f) Any vehicle dismantler, salvage pool, mobile car crusher, itiner-
42	ant vehicle collector or scrap processor that violates this subdivision
43	shall be subject to a civil penalty not to exceed two thousand dollars
44	per violation.
45	(g) Any vehicle dismantler, salvage pool, mobile car crusher, itiner-
46	ant vehicle collector or scrap processor that violates this subdivision
47	more than five times within a thirty-six-month period shall be subject
48	to having its license revoked.
49	§ 2. This act shall take effect on the one hundred eightieth day after
50	it shall have become a law. Effective immediately, the addition, amend-
51	ment and/or repeal of any rule or regulation necessary for the implemen-
52	tation of this act on its effective date are authorized and directed to
53	be made and completed on or before such effective date.
