AN ACT to amend the environmental conservation law, in relation to prohibiting the use of chemical flame retardants

The People of the State of New York, represented in Senate and Assembly, do enact as follows:

Section 1. Article 37 of the environmental conservation law is amended by adding a new title 11 to read as follows:

CHEMICAL FLAME RETARDANTS

37-1103. Prohibition on the use of chemical flame retardants.

§ 37-1101. Definitions. As used in this title:

- 8 <u>1. "Chemical flame retardants" shall mean any halogenated chemical</u>
 9 <u>flame retardant, including but not limited to TDCPP Tris (1, 3 Dicholo-ro-2-propyl) phosphate, and any Phosphorus-Bromine flame retardants.</u>

 11 2. "Residential upholstered furniture" shall mean a sofa, loveseat,

 12 chair, ottoman, footstool, or other item of furniture, intended for

1 provide a specific characteristic, appearance or quality, to perform a specific function, or for any other purpose.

- 2. The provisions of this section shall not apply to the sale or 4 distribution of residential upholstered furniture resold or offered for resale, or distributed by consumers for consumer use.
- § 2. This act shall take effect on the thirtieth day after it shall have become a law. Effective immediately, the commissioner of environ-7 mental conservation is authorized to promulgate any rules and regulations necessary to implement the provisions of this act on or before 10 such effective date.
