- AN ACT to amend the vehicle and traffic law, in relation to authorizing the town of Hempstead in the county of Nassau to establish residential parking systems in the neighborhoods of Bellerose Terrace and Elmont

The People of the State of New York, represented in Senate and Assembly, do enact as follows:

1 Section 1. Legislative findings and intent. The legislature finds that 2 a lack of parking for residents of certain areas of the town of Hemp-3 stead, Nassau county, has resulted in traffic hazards, congestion and 4 air and noise pollution. In addition, such lack of parking poses a 5 hazard to residents and other pedestrians in such areas.

6 The legislature further finds that a residential parking system within 7 such areas would be in the public interest. The legislature further 8 finds that a residential parking system within such areas will reduce 9 such hazards and will reduce pollution levels as well. The legislature, 10 therefore, hereby declares the necessity of this act to authorize the 11 town of Hempstead to adopt a residential parking permit system in 12 accordance with the provisions of this act.
