AN ACT to amend the racing, pari-mutuel wagering and breeding law, in relation to requiring all advertisements for gambling and sports betting to include warnings about potential harmful and addictive effects of gambling and to requiring the state gaming commission to cooperate with the commissioner of addiction services and supports to ensure that all advertisements for gaming activity state a problem gambling hotline number

The People of the State of New York, represented in Senate and Assembly, do enact as follows:

1 Section 1. Paragraph (a) of subdivision 1 of section 1363 of the 2 racing, pari-mutuel wagering and breeding law, as added by chapter 174 3 of the laws of 2013, is amended to read as follows:

- 4 (a) "advertisement" shall mean any notice or communication to the 5 public or any information concerning the gaming-related business of a 6 gaming facility licensee or applicant or a mobile sports wagering licen7 see as defined in section thirteen hundred sixty-seven of this article 8 through broadcasting, publication or any other means of dissemination, 9 including electronic dissemination. Promotional activities are considered advertisements for purposes of this section.
- 11 § 2. Subdivision 1 of section 111 of the racing, pari-mutuel wagering 12 and breeding law, as added by section 1 of part A of chapter 60 of the 13 laws of 2012, is amended to read as follows:
- 14 1. (a) The commission shall cooperate with the commissioner of [alco15 holism and substance abuse services] addiction services and supports to
 16 ensure the posting of signs and listing of information on the internet
 17 designed to assist compulsive gamblers pursuant to the provisions of
 18 subdivision (h) of section 19.09 of the mental hygiene law.

(b) The commission shall cooperate with the commissioner of addiction 2 services and supports to ensure that all advertisements for gaming activity clearly and conspicuously state a problem gambling hotline 4 <u>number.</u>

- (c) The commission shall make available on its website information and 6 technical support which includes, but is not limited to, guidelines for any association, corporations licensed or enfranchised pursuant to this chapter on advertising restrictions.
- 9 § 3. This act shall take effect on the sixtieth day after it shall 10 have become a law. Effective immediately, the addition, amendment and/or 11 repeal of any rule or regulation necessary for the implementation of 12 this act on its effective date are authorized to be made and completed 13 on or before such effective date.
