AN ACT to establish senior citizen alcoholism treatment and training demonstration programs

The People of the State of New York, represented in Senate and Assembly, do enact as follows:

1 Section 1. Legislative intent. The latest New York State census identifies twelve and three-tenths percent of the state's residents as age  
2 sixty-five or older. The New York state office of alcoholism and  
3 substance abuse services has identified chemical abuse and dependence  
4 among the elder population as a serious and growing problem. This can  
5 result from isolation, depression or the interaction of prescribed  
6 drugs. Too many professionals: doctors, nurses, pharmacists and social  
7 workers are unfamiliar with the science of gerontology and the special  
8 physiological and psychological needs of the elderly. In addition, many  
9 community-based programs and facilities, nursing homes and senior citizen  
10 centers are not aware of the incidence of chemical abuse and dependence  
11 among the elderly and do not have the expertise to recognize their  
12 clients' problems, resulting in a barrier to prevention, detection and  
13 treatment.

15 It is, therefore, the intention of the legislature to eliminate barriers to effective chemical abuse and dependence services through this act  
16 by establishing chemical abuse prevention, education and treatment  
17 demonstration programs for senior citizens in the office of addiction  
18 services and supports.

20 § 2. The commissioner of addiction services and supports in consultation with the director of the office for the aging shall develop comprehensive chemical abuse prevention, education and treatment demonstration  
21 programs to address the unique needs of the elderly.

1     § 3. Subject to appropriation, funds for support of demonstration  
2 projects for the purposes stated in section two of this act shall be  
3 allocated to eligible local governments and not-for-profit providers  
4 through a request for proposal process to be designed by the office of  
5 alcoholism and substance abuse services in consultation with the office  
6 for the aging.

7     § 4. In reviewing applications for funding, the commissioner of  
8 addiction services and supports shall consider such factors as program  
9 cost-effectiveness; the ability of such proposals to offer programmat-  
10 ically appropriate, long-term, stable services; and the ability of such  
11 proposals to enable elderly persons to receive chemical abuse and  
12 dependence services; and geographic need. While incidence and prevalence  
13 shall be significant factors in the distribution of funds, demonstration  
14 projects approved pursuant to this act shall be established in regions  
15 across the state.

16     § 5. No expenditure shall be made until the commissioner of addiction  
17 services and supports has approved a program and fiscal plan for chemi-  
18 cal abuse and dependence prevention, education and treatment demon-  
19 stration projects. Such plan shall include, but not be limited to, the  
20 following:

21     i. Specific criteria to be applied in evaluating the requests for  
22 proposal;

23     ii. Uniform program and cost standards;

24     iii. Criteria to be used to evaluate the outcome of the demonstration  
25 projects, including specific requirements to be met by providers of  
26 service.

27     § 6. This act shall take effect on the first of April next succeeding  
28 the date on which it shall have become a law.
